BOARD OF ESTIMATE AND APPORTIONMENT, CITY OF NEW YORK, MAYOR'S OFFICE, CITY HALL, THURSDAY, June 24, 1875, 11 o'clock A. M.

The Board met pursuant to the following call:

In pursuance of the authority contained in the 112th section of chapter 335, being an act entitled "An act to reorganize the local government of the City of New York," passed April 30, 1873; and section 1 of chapter 779, being an act entitled "An act in relation to raising money by taxation in the County of New York, for county purposes," passed June 14, 1873; and chapter 304, being an act entitled "An act to consolidate the government of the City passed June 14, 1873; and chapter 304, being an act entitled "An act in relation to regulate the same," passed April 30, 1874; and chapter 303, being an act entitled "An act in relation to the estimates and apportionment for the support of the government of the County of New York," passed April 30, 1874; and chapter 308, being an act entitled "An act in relation to the estimates and apportionment for the support of the government of the City of New York," passed May 1, 1874—a meeting is hereby called of the Mayor, Comptroller, President of the Board of Aldermen, and the President of the Department of Taxes and Assessments, constituting a Board of Estimate and Apportionment, to be held at the office of the Mayor, on Thursday, June 24, 1875; for the purposes specified in requisition of the Comptroller of June 21, 1875.

The minutes of the meeting held June 19, 1875, were read and approved.

The President of the Department of Taxes and Assessments presented a communication from the Health Department, as follows:

HEALTH DEPARTMENT, No. 301 MOTT STREET, NEW YORK, June 23, 1875.

SIR—At a meeting of the Board of Health, held on the 22d inst., the following preamble and resolution were adopted:

Whereas, The efforts of this Board to reduce the amount of small-pox, by sending a large force of Vaccinators into the districts in which the disease prevails, has been successful in preventing such a marked increase of the disease as was dreaded, but has not as yet controlled the epidemic force of the disease;

Resolved, That this Board hereby respectfully requests the Board of Estimate and Apportionment for \$2,500, in order to continue the same number of Vaccinators for another month as an absolute necessity for the preservation of the public health.

To the Honorable WM. H. WICKHAM, Mayor, and

ANDREW H. GREEN, Comptroller of the City of New York : GENTLEMEN—I have the honor to transmit to you a copy of a resolution adopted by this Board on the ninth instant, in pursuance of the powers conferred by the act of the Legislature organizing this Board.

As the greater portion of the sum called for will be necessary to repay moneys borrowed on the resumption of the work on the bridge this spring, and to meet the certificates of indebtedness given to private stockholders on the retirement of their stock, the whole amount is desirable at once, and a considerable portion is absolutely required at least by the first of July next.

Whereas, Section 112 of chapter 335 of the Laws of 1873, as amended by section 20, chapter 757, Laws of said year, provides as follows:

"The Mayor, Comptroller, President of the Board of Aldermen, and the President of the Department of Taxes and Assessments, shall constitute a Board of Estimate and Apportionment, who shall, annually, between the first day of August and the first day of November, meet, and by the affirmative vote of all the members, make a provisional estimate of the amounts required to pay the expenses of conducting the public business of the City and County, in each Department and branch thereof, and the Board of Education, for the next ensuing financial year

For the purpose of making said provisional estimate, the heads of Departments and the Board of Education shall, at least thirty days before the said provisional estimate is required to be made as herein provided, send to the Board of Apportionment an Estimate in writing, herein called a Departmental Estimate, of the amount of expenditure, specifying in detail the objects thereof, required in their respective Departments, including a statement of each of the salaries of the officers, clerks, employees, and subordinates. The same statement as to salaries and expenditure shall be made by all other officers, persons and boards having power to fix or authorize them. A duplicate of these Departmental Estimates and statements shall be made at the same time to the Board of Aldermen;" therefore

Resolved, That the Comptroller be requested to notify the heads of all the city Departments, and the officers of the City and County of New York, to prepare their "Departmental Estimates" for the year 1876, in conformity with the foregoing provisions of law, and send the same to the Board of Estimate and Apportionment prior to the 1st day of September, 1875;

Resolved, That the salary of the Commissioner, who shall from time to time be appointed President of the said Commissioners of the Court-house of the Third Judicial District, be and hereby is fixed at the sum of twenty-five hundred dollars per annum, and that the salaries of the other two of said Commissioners be and hereby are fixed at the sum of two thousand dollars each per annum, to take effect from April 22, 1875: to take effect from April 22, 1875;

Resolved, That the sum of \$4,477.77 is transferred from the appropriation "Public Instruction," 1874, the same being in excess of the amount required for the purposes and objects thereof, to an appropriation for "Salaries, Third District Court-house Commissioners," 1875, for which it is required.

Whereas, It is provided by a law, passed during the last session of the Legislature, that—

"§ 3. The various scows employed by the Cities of New York and Brooklyn, or by the contractors for removing the ashes, garbage, and refuse of said cities, while moored at the various dumping-boards of said cities, are hereby designated and required to receive directly any and all ashes and garbage or rubbish from any steam-tug or steam-vessel in the Harbor of New York; and in addition to the foregoing provisions, two or more scows shall be located at one or more of the said dumping-boards, on the East and North rivers, respectively, or at such other points as the Commissioners of Pilots may direct, for the special use of boats and vessels wishing to discharge ashes, garbage, or rubbish; and the ashes, garbage, or rubbish received by all of the said scows shall be disposed of as part of the refuse of and at the expense of said cities;" and

Whereas, Requisition has been made on the Police Department by the Commissioners of Pilots to place two scows in the Harbor of New York, one at the Sand-spit Shoal, off Governor's Island, on the East river, the other in the North river, on the Communipaw Flats, each scow to be provided with night signals, and lanterns, and a watchman; and

Whereas, The Police Department has no funds appropriated which can be lawfully expended to defray the expense of keeping and maintaining scows, in conformity to the above requisition; therefore

Which was referred to the Comptroller.

Resolved, That in view of the said requisition made on the Police Department by the Commissioners of Pilots, the Board of Estimate and Apportionment be and they are hereby respectfully requested to appropriate and set apart from the unexpended balance of the appropriation for "Cleaning the Streets" for the year 1874, the sum of ten thousand dollars (\$10,000), to be used and expended for the purpose set forth in section 3 of chapter 148 of the Laws of 1875.

#### CHAPTER 484.

An Act authorizing and empowering the Commissioners of the Sinking Fund of the City of New York to assign to the Board of Education certain property to be used for school purposes.

(Passed June 5, 1875; three-fifths being present.) The People of the State of New York, represented in Senate and Assembly, do enact as follows:

SECTION 1. The Commissioners of the Sinking Fund of the City of New York, are hereby authorized and empowered to assign to the Board of Education of the City of New York, such property belonging to said city, and situate between Sixty-seventh and Sixty-eighth streets, and Lexington and Third avenues, or as much thereof as they may deem suitable for the erection of an edifice for a grammar or primary school, and on such conditions as they shall deem proper, and for the use of said Board.

Sec. 2. This act shall take effect immediately.

Whereas, It is manifest that the present system of payments through the Comptellar is of more

Whereas, It is manifest that the present system of payments through the Comptroller is of no pecuniary or other advantage to the city, but the contrary, inasmuch as a large additional expenditure is caused by the employment by the Comptroller of a clerical force for revising the expenditures of this Board, after the careful revision they receive from its proper committees, and the officers necessarily employed for this purpose; and

Whereas, Such system of payment is opposed to the decision of the Supreme Court herein quoted;

therefore. Resolved, That the Committee on By-laws, etc., be and they hereby are instructed to report to this Board, at its next stated meeting, what measures are necessary to be taken to enforce the right of this Board to the corporate control and disbursement of the funds apportioned for the purposes of public instruction, and which control and direct disbursement are important obligations of the Board, imposed upon it by the Laws of the State, as decided by the late decree of the Supreme Court.

The Committee on By-laws, etc., respectfully report:

That at the request and by the advisement of said Committee, the Chairman, Commissioner R. W. Townsend, addressed a letter to the Comptroller of the city, requesting him to place the moneys raised for the use of the Board of Education, to its credit with the Chamberlain, as was the practice before he adopted a different method, viz., the payment by himself of all the salaries and bills, and requesting an answer before the meeting of the Board.

Sir.—In answer to yours of the 28th instant, requesting to be informed before the meeting of your Committee on Wednesday next, whether this Department will comply with the requisitions which the Board of Education may make from time to time, to place the school moneys to its credit with the Chamberlain, it is obviously proper that the payments from the City Treasury should be made upon one uniform system. The existing method of auditing and paying the claims of the Board of Education was fixed upon in order to make the payments conform to the mode adopted in relation to all Departments and officers of the City Government.

I should, of course, object to changing the method now established in relation to such payments, except upon a complete investigation of the whole subject, and an authorized declaration of the law.

In respect to all payments required to be made from the City Treasury, whatever system I may prefer must, of course, yield to the law, and should your Board deem it necessary to take proceedings in the courts to change the method of paying the schools, I should wish to appear and present the full question, in order that the matter may be intelligently passed upon by the courts.
