

Banding Peregrine Falcons



EP research scientist **Christopher Nadareski** and NYS DEC biologist **Barbara Saunders** partnered last month to band 10 new peregrine falcon chicks at three Metropolitan Transportation Authority (MTA) bridges. MTA provides a nesting box for the falcons on each span—the Verrazano-Narrows, Marine Parkway-Gil Hodges Memorial, and Throgs Neck Bridges. The identifying bands help wildlife experts keep track of the number of peregrines in the city, and identify them in case they become sick or injured. The Importance of Regular Safety Communication

As we near the middle of National Safety Month (NSM) it is important to remember the National Safety Council's theme of "Staying Safe for Life." Regular safety communication is beneficial to the workplace for many reasons. Safety communications aid in avoiding complacency in the workplace, preventing workplace fatalities, and protecting new workers.

In the current issue of Safety & Health Magazine, the article "New Workers, Higher Risk" focuses on the importance of communicating to new workers their safety rights and responsibilities, and that they should not fear speaking up about a hazard they witness. Employees who are new, both in the office and the field, may be unfamiliar with their workplace's safety protocols, which is why orientation and training is crucial to keeping new workers safe. Good communication is important, especially if employees work in different locations; understanding the safety protocols of each location can help to protect them.

At DEP, striving for safety excellence should always be on the minds of employees, and this effort shows in the form of various policies, procedures and guidelines, and communications and trainings—such as the EHS Orientations and <u>Hazard</u> <u>Communication/Right-to-Know</u> <u>Program</u>. Over the next decade, more than half of the DEP work force will be eligible for retirement. in the Pump Maintenance event, and 3rd in the Process Control event. The Jamaica Sludge Hustlers took 2nd place in the state, as well as 1st in the Safety event, 1st in the Pump Maintenance event, 3rd in the Collections event, and 2nd in the Process Control event. The teams are overjoyed and very proud to bring home the state trophy to NYC.
