**IN THE MATTER OF** an application submitted by the New York City Department of Correction pursuant to Sections 197-c and 199 of the New York City Charter, and Section 5-430 *et seq.* of the New York City Administrative Code for an amendment to the City Map involving:

- the elimination, discontinuance and closing of 82<sup>nd</sup> Avenue between 126<sup>th</sup> Street and 132<sup>nd</sup>
  Street:
- the elimination of two Public Places within the area bounded by Union Turnpike, 132<sup>nd</sup> Street, Hoover Avenue, Queens Boulevard, 82<sup>nd</sup> Avenue and 126<sup>th</sup> Street;
- the adjustment of grades and block dimensions necessitated thereby;

including authorization for any acquisition or disposition of real property related thereto, in Community District 9, Borough of Queens, in accordance with Map No. C.P.C. 190117 MMQ dated March 25, 2019 and signed by the Director of the Department of City Planning.

This application for an amendment to the City Map was filed by the New York City (NYC) NYC Department of Correction on October 24, 2018. The proposed action, along with the related actions, would facilitate the development of four detention facilities that comprise the NYC borough-based jail system in Bronx Community District 1, Brooklyn Community District 2, Manhattan Community District 1 and Queens Community District 9.

#### RELATED ACTIONS

#### **BACKGROUND**

A full background discussion and description of this application appear in the report for the related site selection action (C 190333 PSY).

#### **ENVIRONMENTAL REVIEW**

The subject application (C 190117 MMQ), in conjunction with the applications for related actions (C 190333 PSY, N 190334 ZRY, C 190335 ZSX, C 190336 ZMX, N 190337 ZRX, C 190338 HAX, C 190339 ZSK, C 190116 MMK, C 190340 ZSM, C 190341 PQM, C 190252 MMM and C 190342 ZSQ) was reviewed pursuant to the New York State Environmental Quality Review Act (SEQRA) and the SEQRA regulations set forth in Volume 6 of the New York Code of Rules and Regulations, Section 617.00 et seq. and the City Environmental Quality Review (CEQR) Rules of Procedure of 1991 and Executive Order No. 91 of 1977. The designated CEQR number is 18DOC001Y. The lead agency is the Department of Correction.

A summary of the environmental review appears in the report on the related application for a site selection (C 190333 PSY).

### UNIFORM LAND USE REVIEW

On March 25, 2019 this application (C 190117 MMQ), in conjunction with the related applications (C 190333 PSY, N 190334 ZRY and C 190342 ZSQ) was certified as complete by the Department of City Planning and was duly referred to Queens Community Board 9 in accordance with Title 62 of the Rules of the City of New York, Section 2-02(b) and in accordance with the procedures for non-ULURP matters.

## **Community Board Public Hearing**

Community Board 9 held a public hearing on this application (C 190117 MMQ), in conjunction with the related actions, on April 24, 2019 and on May 14, 2019, by a vote of 28 in favor, zero

opposed and one abstaining, adopted a resolution recommending disapproval of the application.

Queens Community Board 8 requested to formally review the application and held a public hearing on this application (C 190333 PSY), in conjunction with the related actions, on May 6, 2019, and on May 8, 2019, by a vote of 39 in favor, zero opposed and one abstaining, adopted a resolution recommending disapproval of the proposed action.

The Community Boards' recommendation appears in the report for the related site selection action (C 190333 PSY).

# **Borough President Recommendation**

This application (C 190117 MMQ), in conjunction with the related actions, was considered by the Queens Borough President, who held a public hearing on this application on June 13, 2019 and issued a recommendation on June 18, 2019 to disapprove the application.

A summary of the Borough President's recommendation appears in the report for the related site selection action (C 190333 PSY).

### **City Planning Commission Public Hearing**

On June 19, 2019 (Calendar No. 13), the City Planning Commission scheduled July 10, 2019 for a public hearing on this application (C 190117 MMQ). The hearing was duly held on July 10, 2019 (Calendar No. 20) in conjunction with the public hearing on the applications for the related actions (C 190333 PSY, N 190334 ZRY, C 190335 ZSX, C 190336 ZMX, N 190337 ZRX, C 190338 HAX, C 190339 ZSK, C 190116 MMK, C 190340 ZSM, C 190341 PQM, C 190252 MMM and C 190342 ZSQ).

There were a number of speakers, as described in the report for the related site selection action (C 190333 PSY), and the hearing was closed.

#### CONSIDERATION

The Commission believes that this application for a City Map amendment (C 190117 MMQ), in conjunction with the related applications, is appropriate.

A full description of the Commission's consideration appears in the report for the related site selection action (C 190333 PSY).

### RESOLUTION

Therefore, the City Planning Commission, deeming the proposed amendment to the City Map and any related acquisition or disposition of real property related thereto to be appropriate, adopts the following resolution:

**RESOLVED,** that having considered the Final Environmental Impact Statement (FEIS), for which a Notice of Completion was issued on August 23, 2019, with respect to this application (CEQR No. 18DOC001Y) the City Planning Commission finds that the requirements of the New York State Environmental Quality Review Act and Regulations have been met and that:

- 1. Consistent with social, economic and other essential considerations from among the reasonable alternatives available, the action is one which avoids or minimizes adverse environmental impacts to the maximum extent practicable; and
- 2. The adverse environmental impacts identified in the FEIS will be minimized or avoided to the maximum extent practicable by incorporating, as conditions to the approval, those project components related to the environmental and mitigation measures that were identified as practicable.

The report of the City Planning Commission, together with the FEIS constitute the written statement of facts, and of social, economic and other factors and standards, that form the basis of

the decision, pursuant to Section 617.11(d) of the SEQRA regulations; and be it further

**RESOLVED,** by the City Planning Commission, pursuant to Section 197-c and 199 of the New York City Charter, ad Section 5-430 et seq. of the New York City Administrative Code that base on the environmental determination and the consideration described in this report, the application (C 190117 MMQ), for an amendment to the City Map involving:

- the elimination, discontinuance and closing of 82<sup>nd</sup> Avenue between 126<sup>th</sup> Street and 132<sup>nd</sup> Street;
- the elimination of two Public Places within the area bounded by Union Turnpike, 132<sup>nd</sup> Street, Hoover Avenue, Queens Boulevard, 82<sup>nd</sup> Avenue and 126<sup>th</sup> Street;
- the adjustment of grades and block dimensions necessitated thereby;

including authorization for any acquisition or disposition of real property related thereto, in accordance with Map No. C.P.C. 190117 MMQ dated March 25, 2019 and signed by the Director of the Department of City Planning is approved; and be it further

**RESOLVED**, that pursuant to Section 5-432 of the New York City Administrative Code, the City Planning Commission determines that "such closing or discontinuance will further the health, safety, pedestrian or vehicular circulation, housing, economic development or general welfare of the City"; and be it further

**RESOLVED**, that, pursuant to Section 5-433 of the New York Administrative Code, the City Planning Commission adopts the legally required number of counterparts of Map No. C 190117 MMQ dated March 25, 2019 providing for the discontinuance and closing of 82<sup>nd</sup> Avenue between 126th Street and 132nd Street being more particularly described as follows:

DISCONTINUING AND CLOSING OF 82<sup>nd</sup> AVENUE BETWEEN 126<sup>TH</sup> STREET AND 132<sup>ND</sup> STREET, BOROUGH OF QUEENS, AS SHOWN ON THE CITY OF NEW YORK DEPARTMENT OF CITY PLANNING MAP C.P.C. NO. 190117 MMQ, DATED MARCH 25, 2019.

Starting at the point of intersection of the northerly line of Queens Boulevard and easterly line of 82<sup>nd</sup> Avenue, thence running 314.50 feet northeasterly, along the easterly line of 82<sup>nd</sup> Avenue, to the point or place of beginning;

- 1) Thence, running 351.93 feet, in an easterly direction to a point, which makes an external angle to the right of the previous course of 123 degrees 19 minutes and 37.4 seconds;
- 2) Thence, running 84.37 feet, in a northwesterly direction to a point, which makes an internal angle with the previous course of 72 degrees 28 minutes and 50.4 seconds;
- 3) Thence, running 273.78 feet, in a westerly direction to a point, which makes an internal angle with the previous course of 108 degrees 31 minutes and 9.6 seconds;
- 4) Thence, running 95.07 feet, in a southwesterly direction, which makes an interior angle with the previous course of 123 degrees, 41 minutes and 53.3 seconds, to the point or place of beginning;

Said  $82^{nd}$  Avenue to be discontinued and closed between  $126^{th}$  Street and  $132^{nd}$  Street contains an area of 25,028.5 square feet, more or less.

**RESOLVED**, that, pursuant to subdivision 1a of Section 5-433 of the New York City Administrative Code, public utility facilities within the subsurface of the streets cites herein

which are to be discontinued and closed by this action, may be maintained in place or relocated within such subsurface by the public utility, so that such maintenance in place or relocation of such facilities is consistent with the propose use of the closed portion or portions of such subsurface and the requirements of other facilities located therein;

All such approvals being subject to the following conditions:

- a. The subject amendment to the City Map shall take effect on the day following the day on which certified counterparts of Map No. C 190117 MMQ dated March 25, 2019, are filed with the appropriate agencies in accordance with Section 198 subsection c of the New York City Charter and Section 5-435 of the New York City Administrative Code; and
- b. The subject streets to be discontinued and closed shall be discontinued and closed on the day following the day on which such maps adopted by this resolution shall be filed in the offices specified by law.

The above resolution (C 190117 MMQ), duly adopted by the City Planning Commission on September 3, 2019 (Calendar No. 13), is filed with the Office of the Speaker, City Council, and the Borough President in accordance with the requirements of Section 197-d of the New York City Charter.
