# DEPARTMENT OF PUBLIC PARKS.

Report for the Quarter ending March 31, 1889.

CITY OF NEW YORK—DEPARTMENT OF PUBLIC PARKS, Nos. 49 and 51 Chambers Street, April 1, 1889.

Hon. HUGH J. GRANT, Mayor :

SIR—In compliance with the provisions of section 49 of chapter 410 of the Laws of 1882, the Department of Public Parks hereby submits the following statement of its transactions during the three months ending March 31, 1889:

In pursuance of the provisions of chapter 721 of the Laws of 1887, an act authorizing the Department of Public Parks to alter the lines, grades and class of certain streets in the Twenty-third and Twenty-fourth Wards of the city, maps showing the following changes, which have been made after being duly advertised and hearings given as required by law, have been filed in the offices of the Secretary of State, the Register of the City and County, and in the office of this Department:

The Board of Estimate and Apportionment was requested to transfer the sum of \$445.48 from

the appropriation for "Sewers and Drains," 1888, for which it will not be required, to the appropriation for "Maintenance, Twenty-third and Twenty-fourth Wards," for the same year, which was found to be insufficient.

The Board of Estimate and Apportionment was also requested to authorize and direct the Comptroller to issue bonds to the amount of \$3,500 for the purpose of paving the walk adjoining the sea-wall in East River Park, under authority of chapter 575 of the Laws of 1887.

The Comptroller of the City was requested to provide, pursuant to the provision of chapter 575 of the Laws of 1887 and in the manner described in said act, an additional sum of \$50,000 to be applied to the improvement of Morningside Park and on account of the amount authorized to be raised for that purpose by said act.

The Gas Commission was requested to make provision for lighting with electric light Central Park, West, from Fifty-ninth to One Hundred and Tenth streets; and, also, the four transverse roads crossing the Central Park.

Permission was given the Ph. & William Ebling Brewing Company to regulate and grade, at their own expense, Eagle avenue, between East One Hundred and Fifty-sixth street and Cedar place, the work to be done under the supervision and direction of the Department.

Permission was given the Manhattan Railway Company to crect stairways at the northwest and southeast corners of Seventy-second street and Ninth avenue.

A license for conducting the boat service at the Central Park Lake was granted to J. Clarence Dick for one year from January 1, 1889, upon his agreeing to pay the sum of \$1,000 for the privilege.

A license for conducting the grant carriage service in Central Park Lake was granted to J. Clarence

A license for conducting the boat service at the central rark Lake was grained to J. Assertable Dick for one year from January 1, 1889, upon his agreeing to pay the sum of \$1,000 for the privilege.

A license for conducting the goat-carriage service in Central Park, was granted to Isidor Isaac for one year from May 1, 1889, upon his agreeing to pay a sum equal to five per cent. of his gross receipts for the privilege.

A site for a statue of Nathan Hale, which is proposed to be erected on the parks by the Sons of the Revolution, has been designated on the northwest corner of City Hall Park.

On the 24th of January last E. E. Stearns of the Torrey Botanucal Garden was heard by the Board of Parks, in relation to the establishment of a batanical garden in one of the new parks if a sufficient sum of money is provided by any responsible individual or association.

The following resolution was adopted:

Resolved, That it is the opinion of this Board that adequate space should be provided in one of the city parks for a botanical garden, if at any time during the years 1889 or 1890 any individual or association shall provide sufficient means for the establishment of such a garden.

To meet the terms of the appropriation made by the Board of Estimate and Apportionment of \$10,000 each for the Metropolitan Museum of Art and the American Museum of Natural History, in addition to the usual appropriation for the maintenance of those museums, which terms require that the museum buildings shall be open on Sunday afternoons, or in lieu thereof two evenings of each week, the Metropolitan Museum of Art on Tuesday and Saurday evenings, and the American Museum of Natural History Wednesday and Saurday evenings, designated, between the hours of Natural History Wednesday and Saurday evenings designated, between the hours of Natural History Wednesday and Saurday evenings designated, between the hours of Natural History Wednesday and Saurday evenings to help the Museum of Art, in order

The latter museum is now open to the public on the evenings designated, between the hours of 8 and 10 o'clock P. M., and arrangements are being made for lighting the Museum of Art, in order that that also may be thrown open to the public as soon as practicable.

The Sinking Fund Commission having provided, pursuant to the provisions of chapter 407 of the Laws of 1888, the sum of 512,000 for the purposes of constructing railways in Transverse Road No. 3, through Central Park, plans and specifications are being prepared for carrying out the work

for the Laws of 1505, the suit of States of the part of the Road No. 3, through Central Park, plans and specifications are being prepared for carrying out the work.

The subject of the proposed depression of the tracks and changing the grades of the Port Morris branch of the New York and Harlem Railroad, from East One Hundred and Fifty sixth to East One Hundred and Sixty-fifth street, has been considered and several public hearings have been given in relation thereto. A plan of the proposed depression as modified and agreed upon has been adopted and filed according to law, and the Counsel to the Corporation has been requested to prepare a form of agreement to be executed by the Department and the New York and Harlem Railroad Company for depressing their tracks, as shown on the said plan.

The West Side and Yonkers Railway Company have been requested to provide approaches to the footways of the bridge over the Harlem river at Eighth avenue, in order that the same may be used by the public.

The Board of Aldermen has been requested to pass an ordinance permitting this Department to contract for telephone service for the period from January 1 to December 31, 1889, at a price not exceeding four thousand dollars, without public letting.

The Department having been advised by the Counsel to the Corporation in relation to the collection of rent from the occupants or tenants of houses and tenements in the new parks beyond the Harlem river, a notice has been prepared and served upon all of said occupants, informing them that by the confirmation by the Supreme Court-on December 12, 1888, of the report of the Commissioners for acquiring title to the lands, etc., included within the new parks and parkways, under the provisions of chapter 522, Laws of 1884, the City has become the owner of all lands, houses and tenements in the new parks, and the relation of landlord and tenant heretofore existing between lesses and owners thereupon terminated.

# CENTRAL, CITY AND NEW PARKS.

During the past quarter a number of Gardeners have been engaged in cutting out dead, diseased, deformed and overcrowded trees, chiefly in the Ramble, in the First and Third Divisions, near One Hundredth and One Hundred and Fifth streets and Eighth avenue and along the cross-drive leading to Mount Saint Vincent. In all 2,356 trees were removed.

Another force of Gardeners has been engaged in pruning the shrubs between Fifty-ninth and Eighth streets.

The force at the greenhouses has been engaged in the care and propagation of plants and shrubs.

The force at the greenhouses has been solved a large amount of extra labor in caring for a much larger stock of plants than has ever been handled before.

The work on the Park, as performed by the laboring force, has been of the usual routine work of cleaning walks, roads and drives; caring for cottages and urinals; cleaning basins on an average of once a month; and watering drives, roads and Fifth avenue.

The manure spread upon the lawns last fall has been raked off and the refuse carted to the

At the Sheepfold 34r cart loads of manure were received, as follows:

The small park at junction of Ninth avenue and the Boulevard, opposite Sixty-third street, Manhaitan Square, Fourth Avenue Parks and East River Park, have been attended to.

On the small lake, near Fifty-ninth street and Fifth avenue, there were three days' skating, on the large lake, two days' and on Harlem lake, three days.

The skate building on large lake is being removed as rapidly as the other work will permit.

The work at the Stables has consisted in caring for and cleaning at

Eighty-fifth street Stables.

56 horses

Sheepfold Stables

Also cleaning and caring for harness and making necessary repairs to same.

The work at Mount Morris Park has consisted of the ordinary maintenance work of the park.

At Riverside Park and Drive the ordinary routine work of maintenance has been carried on, also repairing property road in the neighborhood of Ninety-first to Ninety-sixth street, and One Hundred and Twenty-fourth street and Manhattan avenue.

Four hundred and twenty cubic yards of mould were delivered free of charge, on the Park, south of Seventy-ninth street.

The work at Morningside Park has been of a construction character. At the lower end of the park, 1,250 square feet of a 20-foot walk have been graded and paved; 200 feet of sewer has been cleaned, and 51 pieces of rock-work set in position.

The gang working in about the centre of the park, neighborhood of One Hundred and Sixteenth street, has accomplished the following work:

Paved 700 square feet of 20-foot walk and 165 square feet of 15-foot walk, also broke stone over the surface of 1,235 square feet of 20-foot walk, and 165 square feet of 15-foot walk.

3304 Blasted and quarried 140 cubic yards of broken stone, removed 375 cubic yards of earth from cut for walk, shaped lawns around steps and bay at One Hundred and Sixteenth street, also placed 53 pieces of rock in position.

The force employed at the upper end of the park has accomplished the following work:
Broke stone (macadam size) over the surface of 1,800 square feet of 20-foot walk, also broke 300 cubic yards of stone for walks.

Turned 700 cubic yards of manure, cleaned 100 feet of sewer of 18 inches of mud.
The work on the small city parks south of Fifty-minth street has been of a general maintenance character. After snowstorms the walks were cleaned as rapidly as possible.
On the new parks, north of the Harlem river, the following work has been performed:
Parade Ground, Van Cortlandt Park—Removed and carted away for future use, 1,300 square feet of stone wall, also 20 trees.
The trees along the line of the Spuyten Duyvil Parkway were cared for.
At Bronx River Park, 27 dead trees were removed.
At Croton Park, 12 dead trees were removed.
A general supervision has been maintained over the walks and roads of Pelham Park.
The mechanical force of the Department has been employed as follows: Carpenters. Put up new Elephant-house, Camel-house and fences around Zoological collection at Central Park.

Made necessary repairs to Arsenal building, Dairy, 7 cottages, Police Stables, at Sheepfold, roof of Boat-house on large lake, and 6 cottages in the city parks.

Took down skate building and gentlemen's closet on large lake, Central Park.
Laid 1,600 square feet of new board walk connecting Fifth avenue and Seventy-ninth street with Museum of Art.

Repaired entire fence at Mount Morris Park.
Made 58 new signs and repaired 112 old ones.
Made 50 new settees and repaired 212 old ones.
Repaired 55 pieces of rolling stock, also wooden parts of other tools.
Made necessary repairs to woodwork of approaches, draws and roundhouse of bridges over the Harlem river. Harlem river Fitted up police station at Van Cortlandt Park with desk, lockers, etc. Painters' Work. Painted all repairs of woodwork of cottages and buildings on the Central and City Parks; also Harlem river bridges and police station at Van Cortland: Park; also attended to the necessary glazing at different points throughout the Department. Masons' Work Masens' Work.

The principal items of mason work were as follows:
Building 1,080 cubic feet of stone foundation wall, laying 3,348 cubic feet of dry stone foundation. Items of mason work were as follows:
Building 1,080 cubic feet of stone foundation wall, laying 3,348 cubic feet of dry stone foundation for laying 15,500 brick, building one receiving-basin, laying 86 feet of 8-inch drain, pipe, laying 900 square feet of concrete floor and cutting and setting blue-stone flagging at Elephant-house.

Repaired slate roof and pointed brickwork of chunney and foundations of ladies' cottages at Bryant Park and Washington Square.

At Morningside Park cut 240 feet of granite, 671 feet of rough rock, built 1,344 cubic feet of dry foundation and set 256 feet of rock work at steps.

At Jeannette Park excavated 470 cubic feet of earth, laid 185 cubic feet of concrete, laid 3,500 brick, cut and set 70 square feet of granite flagging, removed street pavenent and excavated trench, put in drains, manifole, stop-cock, etc., in connection with the erection of a urinal at this point.

The Masons performed a number of other items of work, such as pointing up brickwork, building and repairing receiving-basins.

Plambers' Work. Plumbers' Work. The plumbing force have been engaged in repairing bursts in water-pipes, general repairing of closers in the cottages throughout the Department and in putting up stoves.

The balance of the mechanical force, such as, Engineers, etc., were employed in the operation of the bridges over the Harlem river, in shoeing horses, repairing harness, repairing rolling-stock, IMPROVEMENT AND CONSTRUCTION OF CENTRAL PARK, UNDER AUTHORITY OF CHAPTER 575, LAWS OF 1887. Erection of Resaining Walls in Transverse Read No. 2.

This work was placed under contract, August 30, 1888, and was completed April 6, 1889.

The work done since December 31, 1888, was 41 37-100 cubic yards masonry. The total quantity of work done is 426 62-100 cubic yards masonry. Approaches to and the Reconstruction of the Grounds around the Metropolitan Museum of Art' The work is being done under contract and commenced in October last. It is still in progress.

The work done during the quarter is:
4,439 cubic yards earth excavation.

The works being prosecuted under contract are, viz.;

3. The erection of blue-stone steps and foundation masonry for same.

Under these contracts no work has been done during the quarter by reason of the weather. EAST RIVER PARK Furnishing and Selting Granile Coping and Flors and the Erection of an Iron Railing on the Seasonall, etc. This work was placed under contract September 25, 1888, and fully completed February 13, The work done since December 31, 1888, is viz. : 471.51 lineal feet granite coping set. 3 piers built. 456.70 lineal feet from railing furnished and set up. RIVERSIDE FARK, IMPROVEMENT UNDER AUTHORITY, CHAPTER 575, LAWS OF 1887.

Construction of Reseiving Wall and Appartenances, Walk and Drainage, from Seventy second to Seventy-ninth Streets. The contract for the above-named work was executed December 29, 1888, but as the masonry could not be proceeded with during the winter months, the contractor was not notified to begin work until April 1, 1889.

Work was actually commenced on April 8, 1889, on drainage and the delivery of stone for small. wall Setting Curb stones, Repairing and Resurfacing Roadway and Improving Seventy-second Street, between Eighta and Ninth Avenues.

This work was completed on January 2, 1889, and an amount was retained for repairs, curb, etc. The total quantities of work done since commencement are:

1,839.67 cubic yards mould furnished.

2,019.84 cubic yards mould furnished and set.

4 receiving-basins rebuilt.

9,585 square yards pavement repaired and resurfaced.

Sir.—At a meeting of the Board of Street Opening and Improvement:

sir.—At a meeting of the Board of Street Opening and Improvement, held on January 18, 1850, a communication from the Commissioner of Public Works, requesting that the necessary action be taken to acquire title to a strip of land from the easterly terminus of One Hundred and sixty-seventh street to the Harlem river, needed for a sewer outlet, was read and referred to the Counsel to the Corporation for his opinion and advice in the premises.

On April 5, 1850, this office advised that your Board should adopt, as nearly as possible, the same procedure for taking land for sewerage and drainage purposes as is followed in street opening cases. Reference was therein made to the Consolidation Act (see section 327 et seq.), and to chapter 423 of the Laws of 1858.

The Consolidation Act (section 327) empowers the Commissioner of Public Works to plan a system of sewerage for the whole of the city, except the Twenty-third and Twenty-fourth Wards, and to district the city and prepare maps and plans in accordance therewith. The last clause of section 327 provides, "The said Commissioner shall appoint and employ such engineers, surveyors, inspectors and other persons, and take and acquire, in accordance with existing laws, such lands as may be necessary for the prosecution of the work authorized by this section."

As existing laws furnished no method by which private property could be taken for sewerage or drainage purposes by the Commissioner of Public Works, chapter 423 of the Laws of 1888 was enacted, amending section 327 of the Consolidation Act by substituting for "in accordance with existing laws," the following: "In the manner hereinafter by this act provided for the acquisition of land by the Mayor, Aldermen and Commonalty of the City of New York, for the purpose of opening sircets, avenues, squares and public places."

This amendment clearly supplies the defect in exist

Works.

In order that the validity of the assessment for the building of the outlet sewer, as well as the regularity of the proceedings for the acquisition of the land itself, may not be successfully attacked, I am of opinion that all proceedings should be begun de novo by the Commissioner of Public Works without the intervention of the Board of Street Opening and Improvement.

I would advise, therefore, as preliminary to this course, that the resolutions adopted by your Board at the meetings held on May 17 and June 21 of the current year, be rescinded, and the proceedings so taken be discontinued, and that there should be taken from file such maps as have been certified to in accordance therewith. Copies of the resolutions of recision and discontinuance, forms of which are herewith inclosed, should also be transmitted to the Board of Aldermen.

On the back of this communication appears the following indorsement in the hand writing of a former clerk in this office: "Wrote Bd. of S. O. & I. advising the discontinuance of Brook avenue, 174 & 175 sts. Mch. 1889, & Apl. 2, '89."

As the records of this office and of your Board fail to show that such an answer was ever sent or received in the matter of Brook avenue, I beg leave to say, that in the notice of motion for the appointment of Commissioners of Estimate and Assessment, the land sought to be acquired was reroneously stated to consist of two parcels, A and B. The resolution of the Board of Street Opening and Improvement requested the Counsel to the Corporation to take proceedings to acquire the top parcel A only. This is an irregularity in a statutory proceeding that might result in the vacating of the assessment.

NUMEROUS APPLICATIONS HAVE BEEN made to this Department by citizens claiming reductions or rebates on bills for water supplied through meters, on the alleged ground of leakage caused by defective plumbing and worn-out service pipes, or by willing waster of water by tenants allowing the faucets to be turned on in full force in water-closests, sinks, etc., which out the knowledge or consent of the owners of the premises.

The main object of the use of water-meters is to enable this Department to detect and check the useless and unwarrantable waste of an element so valuable and essential to the health and comfort of all the citizens, and this object can only be accomplished by enforcing payment for the water wasted.

Under the law all charges for water supplied through meters are a lien against the respective premises, and the law therefore holds the owner of the premises responsible for the amount of water used or wasted.

Notice is therefore type to all householders that in all urther applications for reduction of water rest or plumbing, or wasteful use of water by tenants or occurring through leaks, from defective service pipes or plumbing, or wasteful use of water by tenants or occurred without the knowledge or consent of the owners of the buildings.

House-owners are further notified that whenever their premises become vacant, and are likely to remna vacant, they must notify this beparant water rents will be allowed for any portion of one year.
