

Work Performed by the Sanitary Bureau for the Week ending January 5, 1895.

There were 12,250 inspections made by the Sanitary Inspectors and the Sanitary Police. There were 407 complaints returned by the Sanitary Inspectors and the Sanitary Police. There were 220 complaints received from citizens and referred to the Sanitary Inspectors and Sanitary Police for investigation and report. There were issued to the consignees of vessels, to discharge cargoes, on vouchers from the Health Officer of the Port, 18 permits. There were issued to consignees, to discharge rags (in bulk, under bonds), 2 permits. There were issued to scavengers to empty, clean and disinfect privy sinks, 3 permits.

The 775 deaths represent a death-rate of 20.29, against 17.55 for the previous week, and 23.79 for the corresponding week of 1894. The increase of 105 deaths was mainly due to an increase of 5 in the deaths from diphtheria, of 6 from measles, of 6 from phthisis, of 24 from diseases of the nervous system, of 32 from bron-chitis, of 30 from pneumonia, and of 11 from Bright's disease, partially offset by a decrease of 8 in the deaths from distribution were most numerous in the Twelfth Ward from measles in the

The deaths from diphtheria were most numerous in the Twelfth Ward, from measles in the Eleventh, Seventeenth and Nineteenth Wards, and from scarlet fever in the Eleventh and Twelfth Wards.

Resolved, That the Honorable the Commissioners of the Sinking Fund, be and are hereby informed that during the twenty-eight years this Board occupied the much frequented building Nos. 300 Mulberry street and 301 Mott street, Police Headquarters (during most of which period the Division of Contagious Diseases was in the same building), no case of contagious disease occured which was or could be attributed to the presence of the Health Department in said building.


