Dear Speaker Adams,

Local Laws 126, 127, and 128 of 2016 require the Mayor's Office of Operations (Operations) to conduct an annual review of all forms issued by the Department of Social Services (DSS), Administration for Children's Services (ACS), the Department of Homeless Services (DHS), the Department of Health and Mental Hygiene (DOHMH), the Department for the Aging (DFTA), the Department for Youth and Community Development (DYCD), and the Department of Education (DOE), that meet criteria set forth in these laws, and to submit a report to the City Council within 60 days of such review that includes: a list of all forms reviewed, which includes both eligible and ineligible forms submitted by the agency, and a list of all forms that are eligible for updating to include the demographic information specified in the laws (ancestry and languages spoken; multiracial ancestry or ethnic origin; and sexual orientation and gender identity, respectively). The local laws only mandate a review of forms that collect the relevant demographic information, are completed by persons seeking services, and are within the relevant agency's authority to edit or amend. Therefore, this report shall no longer list forms that do not meet all these criteria in the body of the report. Forms that the Mayor's Office of Operations received that do not meet all criteria will be listed in an appendix, accompanied by the reason why each form is not eligible for review.

The criteria for reviewing the forms, as indicated in the local laws, include:

- Forms that are voluntarily completed by persons seeking social services from designated agencies and the agencies' contracted providers of social services. "Social services" (a subset of "human services" as defined in Admin. Code § 6-129), includes but is not limited to: day care, home care, homeless assistance, housing and shelter assistance, preventive services, youth services, and senior centers, and exclusive of other types of human services, such as health or medical services, including those provided by health maintenance organizations; legal services; employment assistance services, vocational and educational programs; and recreation programs.
- Forms that collect the enumerated types of demographic information (specified in each local law):
  - Local Law 126 of 2016 (ancestry groups and languages spoken)
  - Local Law 127 of 2016 (multiracial ancestry or ethnic origin)
  - Local Law 128 of 2016, as amended by Local Law 76 of 2018 (sexual orientation, gender identity and the gender pronoun(s) that an individual identifies with and that others should use when talking to or about that individual)
- Whether the agency has the authority to amend or edit (i.e. update) such forms.

In determining whether a named agency has the authority to amend or edit (i.e. update) a form, Operations asked the respective agencies to cite any law, regulation, oversight agency, or contractual restriction that would prevent the agency from editing or amending the form. Operations also separately offered agencies an opportunity to comment if they had any practicability concerns with updating such forms to include expanded demographic data questions and response options to reflect those which are in the local laws. The named agencies have evaluated all relevant forms against these criteria and provided them to Operations for review. The results of each agency's findings are included in this report. Operations has been in discussions with the agencies about all 18 forms that have been deemed eligible for updating, excluding forms that have been previously identified as eligible and successfully updated to compliance.

In accordance with these local laws, the Mayor's Office of Operations will, prospectively, conduct this annual review as new forms are created and evaluated, as it looks forward to continuing to best serve residents of all backgrounds and identities.

#### 2023 Demographics Report Overview

The Mayor's Office of Operations determined that 18 forms were eligible for updating and 9 were updated since the 2022 Annual Demographics Report.

Below is a guide for reading each agency section.

•

- For each demographic data question type in the tables below, the following classification system is used:
  - **"Compliant"** = question is present in the form and compliant with the local law requirements
  - "Yes" = question is present in the form and eligible for update
  - "NA" = question is absent from the form
- Where a form asks the service seeker's name and gender but does not explicitly have a gender-pronoun question, this report automatically lists a positive eligibility under "LL-128 Gender Pronouns" since gender pronouns are typically used when interacting with or referring to that service seeker and might otherwise be assumed.
- If the form is not eligible for updating, the reason is included in appendix. Reasons some might not be eligible for updating include:
  - **Does not contain any Demo Data questions**: The form does not contain questions related to the demographic categories associated with Local Laws 126, 127, and 128 of 2016 and therefore updating the form is not applicable.
  - Not within agency's authority to edit or amend: The form is issued by the City agency; however, Demographic Data questions are at least in part subject to oversight from some other authority (i.e.: state or federal government).
  - **Not a City-issued form:** Although the form in question is used by a City agency, the form is issued by another entity, and as such the agency is dependent on the issuer and unable to alter the form contents.

## Agency Reportable Forms Summary

#### Administration for Children's Services (ACS)

Notes:

- ACS does not have any forms deemed eligible for updating. All three forms reviewed required New York State Office of Children and Family Services (OCFS) approval to amend. OCFS has not granted permission to amend the forms because the forms must be consistent with OCFS's federal data reporting requirements.
- Mandated ACS services (e.g. foster care) are excluded from this form review report as they are not services that are voluntarily sought.
- In Summer 2022, OCFS updated their statewide Child Care Application to include gender identity for each member of the household. ACS adopted those changes into the CFWB-012 and resubmitted the application to OCFS for their approval. Approval is currently pending with OCFS. Until the update is granted, this form is considered ineligible as it is not within ACS's authority to amend, and updates must come from OCFS.

## Department for the Aging (DFTA)

Forms that qualify for review: 5 Forms deemed eligible for updating: 0 Eligible forms updated since last year: 0 Forms newly compliant this year: 4

Notes:

- DFTA does not have any forms eligible for updating. All five forms reviewed were already in compliance or not within
  the agency's authority to amend. The following four forms were previously reported as eligible for updating and were
  updated in 2022, becoming fully compliant with all demographic laws this year: Caregiver Assessment, FV Client
  Assessment, NORC Assessment, Client Profile Demographic and Social History. They will no longer be reported here.
  The remaining form reviewed was a Compass form, DFTA's case management assessment, which is not a city-issued
  form and not within the agency's authority to amend, thus not eligible for updating under the laws.

Notes:

- DOE has five forms eligible for updating, all which are in relation to student enrollment. All other 19 forms reviewed, which include forms for public schools and programs, the ReStart Academy, and the Young Adult Borough Center, either do not contain any demographic data questions or are not within the agency's authority to amend or edit because they require state and/or federal approval, as they must comply with New York State Education Department (NYSED) Commissioner's Regulation Part 154, the Family Education Rights and Privacy Act of 1974 (FERPA), and/or related federal guidance.
- Individual schools may maintain their own contracts. Such contractor forms are not included below.
