AN ORDINANCE to provide the necessary means for the support of the Government of the City of New York, the Board of Education and for the payment of the quota of the State Tax in the year eighteen hundred and eighty-two.

year eighteen hundred and eighty-two. The Board of Aldermen of the City of New York do ordain, as follows: Section 1. There shall be and hereby is imposed upon the estates, real and personal, subject to taxation according to law, for the support of the City Government and the Board of Education, and for the purpose of paying the quota of the State Tax imposed upon the City and County of New York, for the year eighteen hundred and eighty-two, the sum of twenty-seven million four hundred and twelve thousand eight hundred and thirty-one dollars and fifty-six cents (\$27,412,831.56), which is the amount certified by the Comptroller of the City of New York, to the Board of Aldermen, in pursuance of the provisions of law contained in section 112 of chapter 335 of the Laws of 1873, as the sum to be raised and collected in the year eighteen hundred and eighty-two, by tax upon the estates, real and personal, subject to taxation, of and within the City and County of New York, which will more fully appear by the communication from the Comptroller, transmitting his certificate of the aggregate amount of the Final Estimate made by the Board of Estimate and Apportionment for the year eighteen hundred and eighty-two, of which said communication, certificate and Final Estimate, the following are copies : Estimate, the following are copies :

Whereas, The Board of Estimate and Apportionment have considered the objections to, and rectifications of, the Provisional Estimate made by said Board on the 31st day of October, 1881, of the amounts required to pay the expenses of conducting the public business of the City and County of New York, in each Department and branch thereof, and the Board of Education, for the next ensuing financial year, to wit, for the year eighteen hundred and eighty-two (1882), in which estimate is mcluded such sum as is necessary for the payment of the interest on the bonds of the said city and county, which become due and payable within said year, and also such sum as is necessary to be raised by tax to pay the principal of any bonds and stocks which become due and payable during the said year; also the amount to be raised by tax annually, which will be sufficient, with the accumulations of interest thereon, to pay the bonds and stocks, payable from taxation, issued after June 3, 1878, pursuant to chapter 383, Laws of 1878; and also so much as may be necessary to pay the proportion of the State tax required to be paid by the City and County of New York, in said year, which objections to, and rectifications of, said Provisional Estimate made by the Board of Aldermen, were transmitted by the Clerk of said Board, under date of November 25, 1881, and pre-sented to the Board of Estimate and Apportionment on November 28, 1881; therefore Resolved, That after such consideration of the said objections to, and rectifications of, said Provisional Estimate, the Board of Estimate and Apportionment does hereby make this a

#### FINAL ESTIMATE

of the amount required to pay the expenses of conducting the public business of the City and County of New York, in each Department and branch thereof, and the Board of Education, for the next ensuing financial year, to wit, the year eighteen hundred and eighty-two (1882), in which is included such sum as is necessary for the payment of the interest on the bonds of the said city and county, which become due and payable within said year, and also such sum as is necessary to be raised by tax to pay the principal of any bonds and stocks which become due and payable during the said year; also the amount to be raised by tax annually, which will be sufficient, with the accu-mulations of interest thereon, to pay the bonds and stocks, payable from taxation, issued after June 3, 1878, pursuant to chapter 383, Laws of 1878; and also so much as may be necessary to pay the pro-portion of the State tax required to be paid by the City and County of New York, in said year, as follows :



At a special meeting of the Board of Docks, held September 29, 1882. Present—The full Board. The Board proceeded to investigate the charges made by the Pilot Commissioners in their com-

The Board proceeded to investigate the charges made by the Pilot Commissioners in their com-munication of the 23d instant, that the scows in tow of the tug "Cyclops" had dumped the material therein contained in the waters of the Bay, unlawfully, on the 16th day of September instant. Captain Joseph Conway, who appeared on the part of the Pilot Commissioners in response to the notice sent to them, in support of the charges made, stated, that on September 15th instant, he personally saw the "Cyclops" proceeding down the Bay with two scows in tow, one of which was taken from the North river by said tug, and the other from the East river, having been towed to the Battery by the tug "Brandon," was there taken in tow by the "Cyclops"; that he went down on the Iron Steamboat Line to the Coney Island pier, and from there he saw the scows dumped outside of Buoy No. 3, at 2.57 P. M.; that the day was clear and he could plainly see the Romer Beacon ; that on the same day the "Tebo," with a tow, followed the "Cyclops," about three miles behind her. 7,400 00 her.

her. Captam Owen F. Hennessey, of the tug "Cyclops," was examined, and stated that he was never made aware that a white spar buoy was placed to mark the dumping-ground; that the scows taken down by him were dumped outside, and north-east of Buoy No. 3, in 5½ fathoms of water; that it was the same place he was accustomed to dump, and, as a rule, he always went outside of all other boats dumping material in the Bay. Sebastian Ellis, the mate of the tug, was examined, and stated he was on board of the tug on the day in question; that the scows were dumped about a mile and a half north-east of Buoy No. 3, in 5½ fathoms of water, at the same place as they usually dumped; that he never seen any boats going as far out as their boat went to dump the material carried in the scows; that no notice or copy of the new law was ever given to him, and he never knew that any white spar or other buoy was placed to mark the dumping-ground. 1,100 00

the new law was ever given to him, and he never knew that any write spar of other bady was placed to mark the dumping-ground. The Board, after due consideration of the matter, and upon the statements made by the parties, decided that the dumping of the material on the day in question was not lawfully made, it appearing to have been made within the Bay, and not outside of the bar, as provided by law; but that it also appears that the act was not done wilfully, or with any intention of violating the law, on the part of the Captain or officers of the tug, and they would therefore recommend that action be taken by the proper authorities to place and maintain buoys to properly designate and mark the place where material may be lawfully dumped outside of the bar, at the entrance to the harbor of New Vork York.

Messrs. J. H. Hazard and Nathaniel L. Griswold appeared before the Board and were heard in reference to the use by the Screw Dock Co. of the bulkhead and water-front between Piers 39 and 40, East river. Action was deferred in the matter until the necessary papers can be prepared to send the matter to the Counsel to the Corporation.

#### NEW YORK AND BROOKLYN BRIDGE.

The Trustees of the New York and BROOKLYN BRIDGE, Office, No. 21 Water Street, BROOKLYN, October 3, 1882.

GENTLEMEN—I have the honor to inform you that the following work has been done on the superstructure of the bridge during the past week, viz.: 310 posts have been erected and 122 got ready for erection, 164 intermediate chords, got ready for erection, 164 intermediate chords, 125 supporting channels, 50 promenade floor beams and 18 promenade diagonals have been erected, 135 top chords have been placed ready for erection, 12 over-floor stays have been made and one end attached to the top of the towers, and 6 under-floor stays have been put in place. The floor beams to panel 30 have been ad-justed to the proper grade, to enable the trusses to be promptly finished when the diagonals to that point, which we understand are finished, shall arrive from Edgemoor. The painting of the three roadway bridges, on the Brooklyn approach, will be finished to-night, and the paving of the roadway, on the same approach, is connected with the pavement at Sands street.

Sands street.

The work of putting down the foundations for the elevated terminus of the railway in Brooklyn

is progressing satisfactorily. The paving is being pushed vigorously on the New York approach, and preparations are being made for the elevated terminus there.

The Franklin Square bridge is virtually finished, except the elevated promenade and the railing thereon, and is now receiving its first coat of paint by the contractors.
