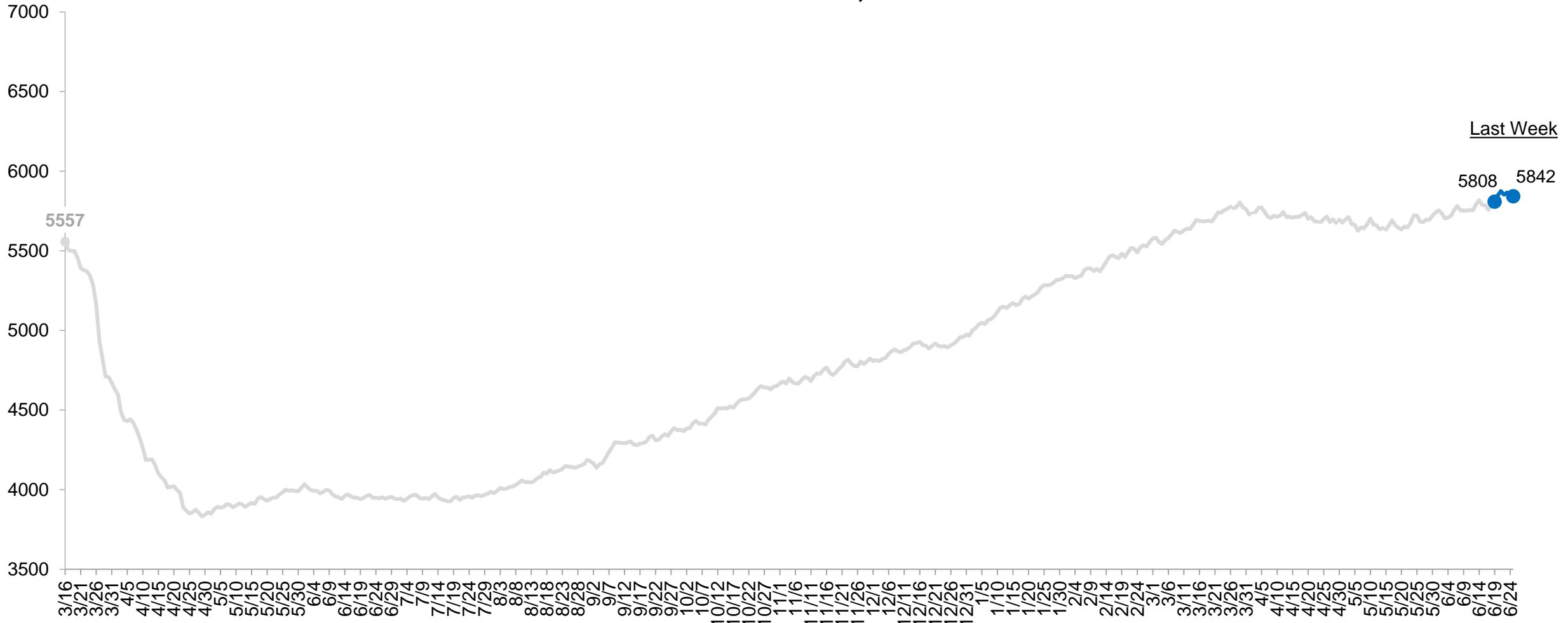

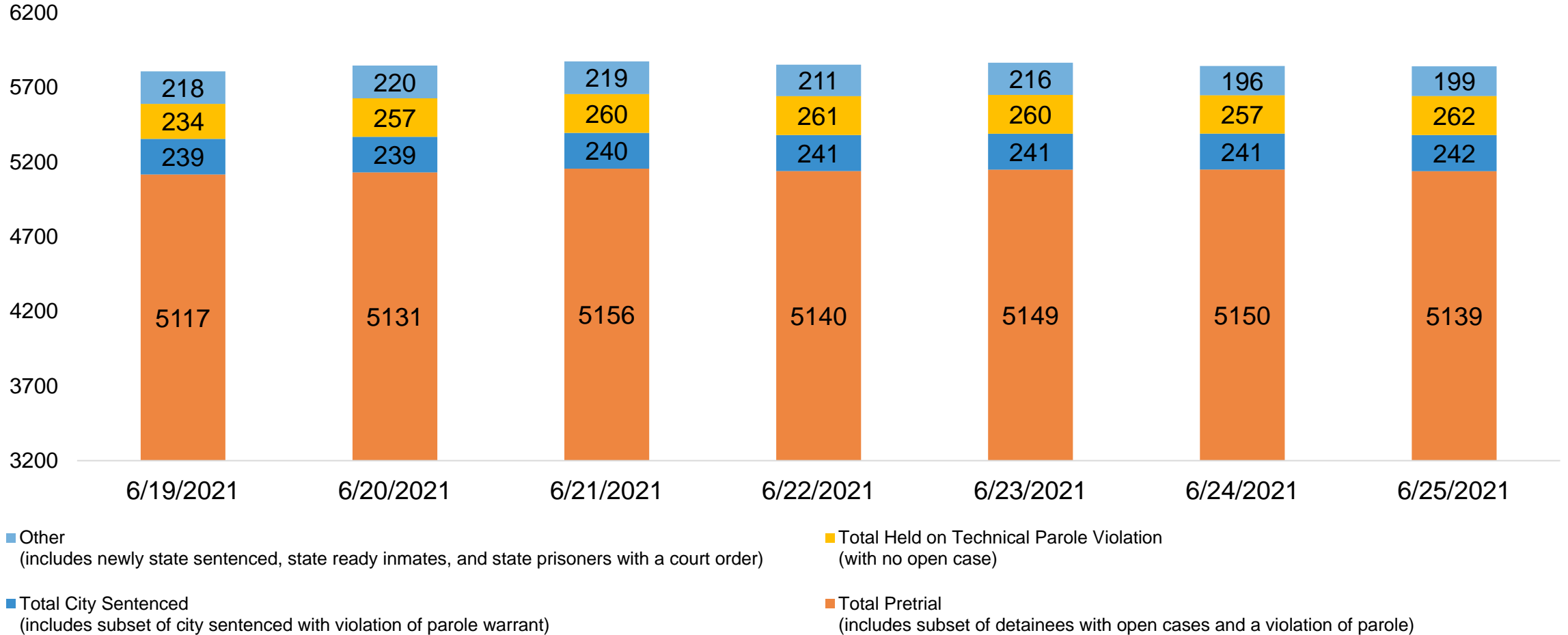
## Total Population in DOC Custody March 16 - June 25, 2021

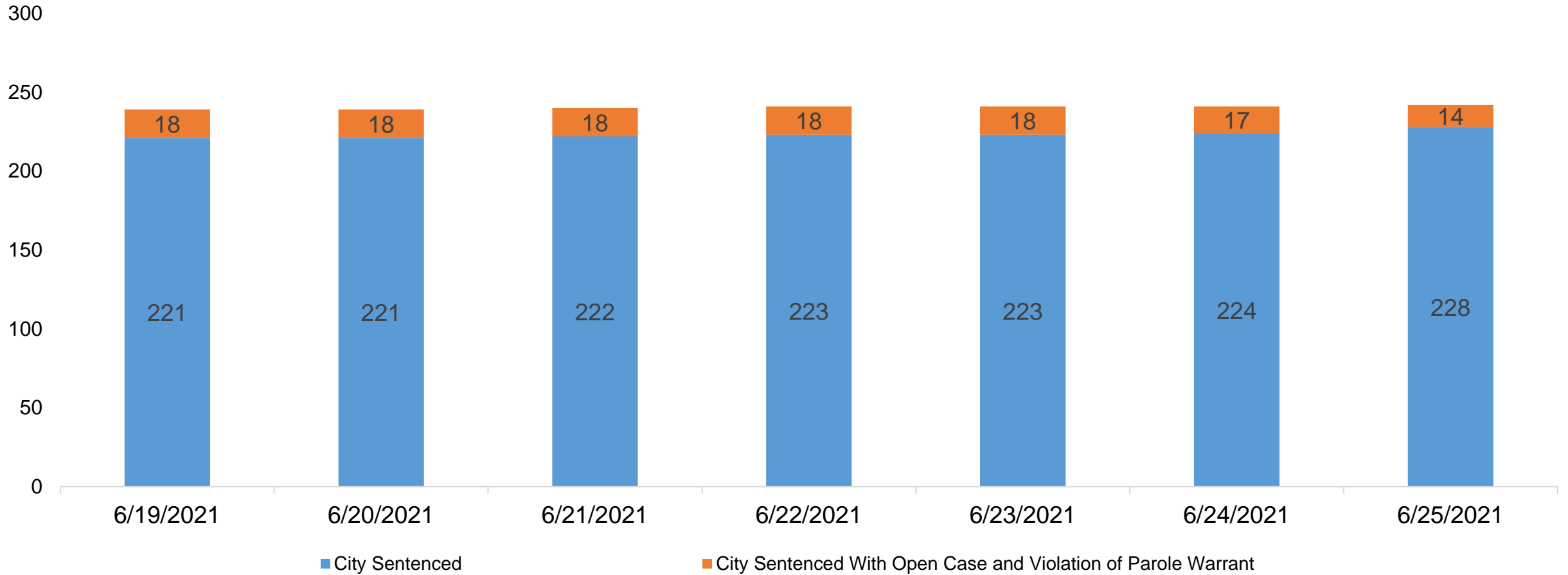

## Total DOC Population by Custody Status, 6/19/2021 - 6/25/2021



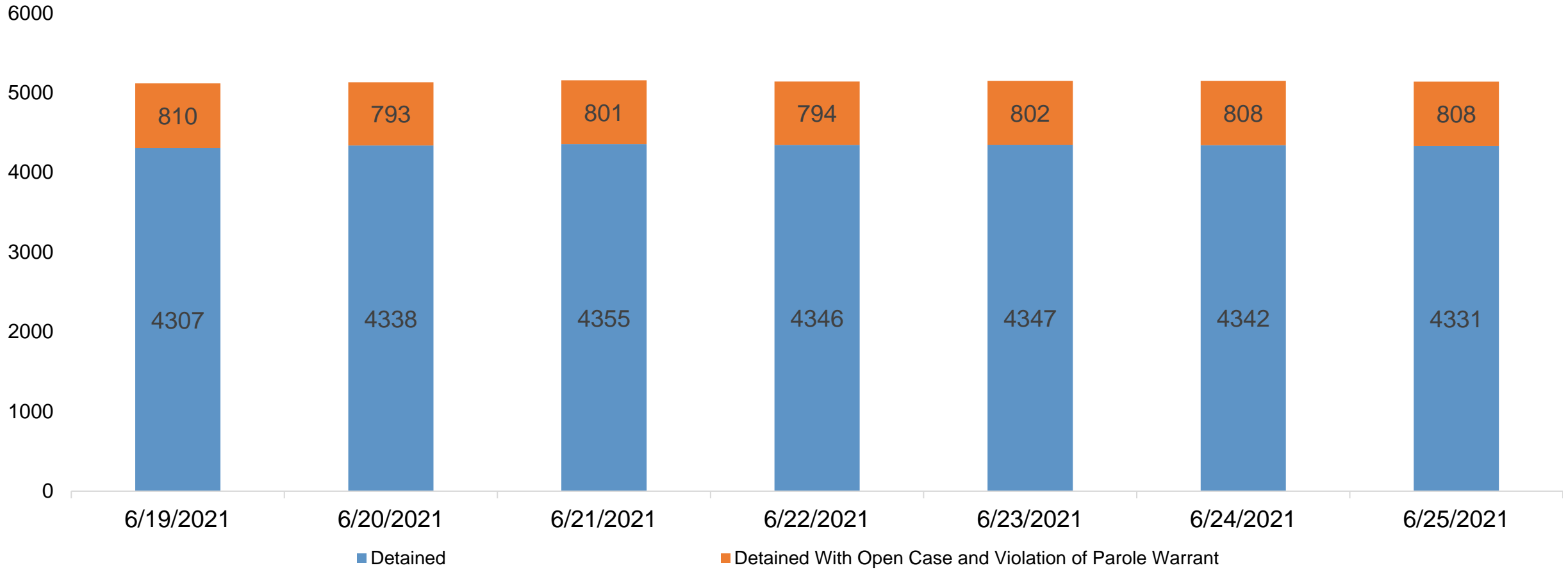

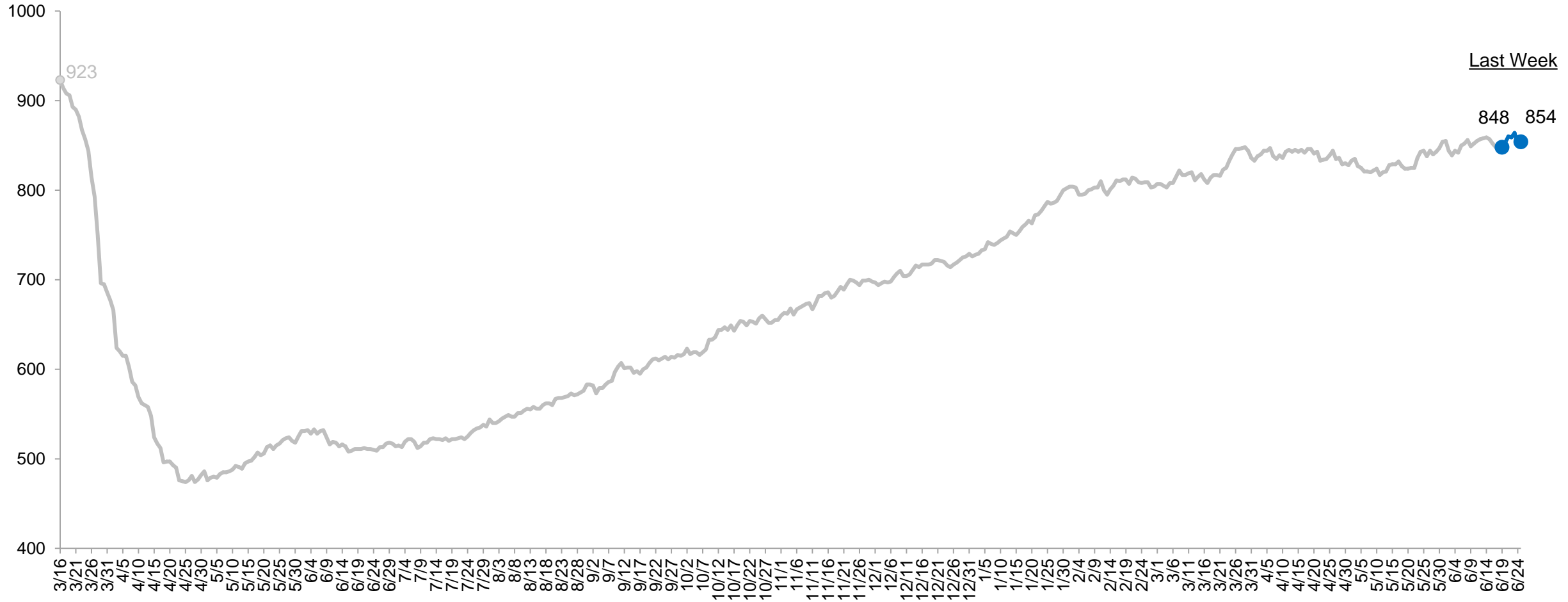

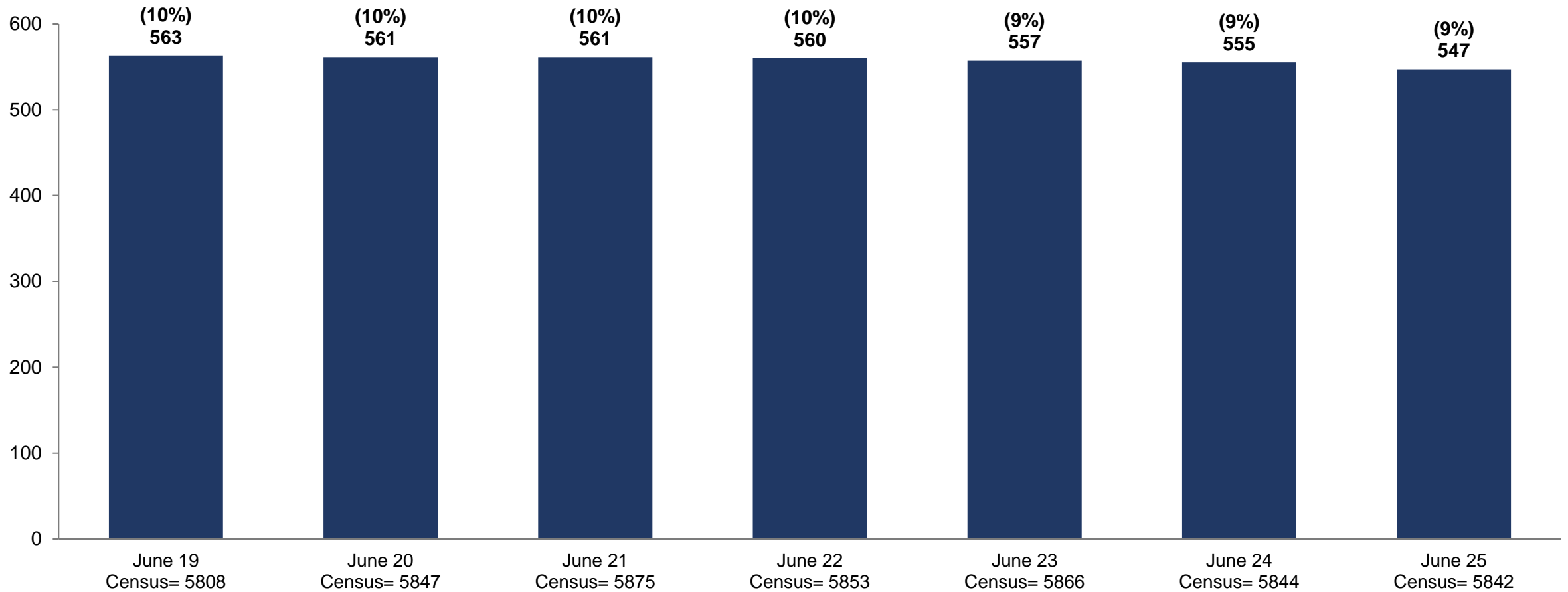

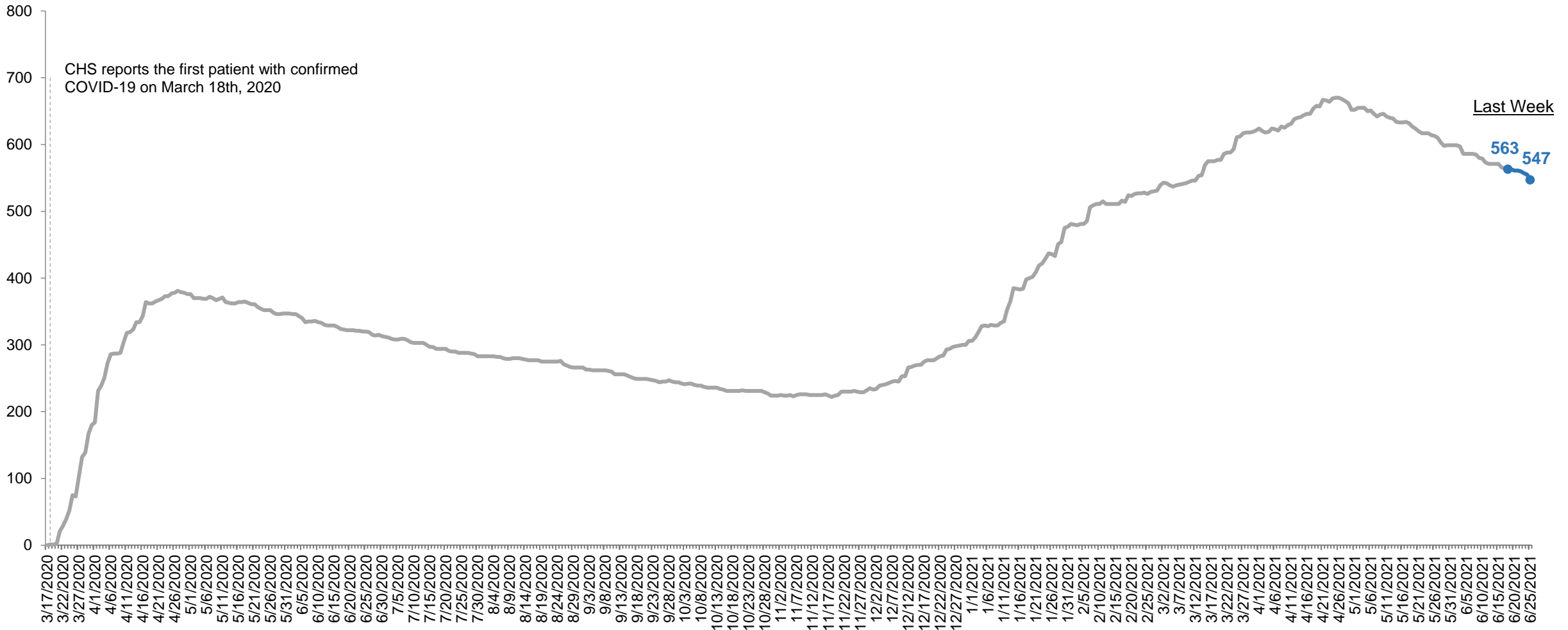
Number and Percent of Patients with Confirmed COVID-19

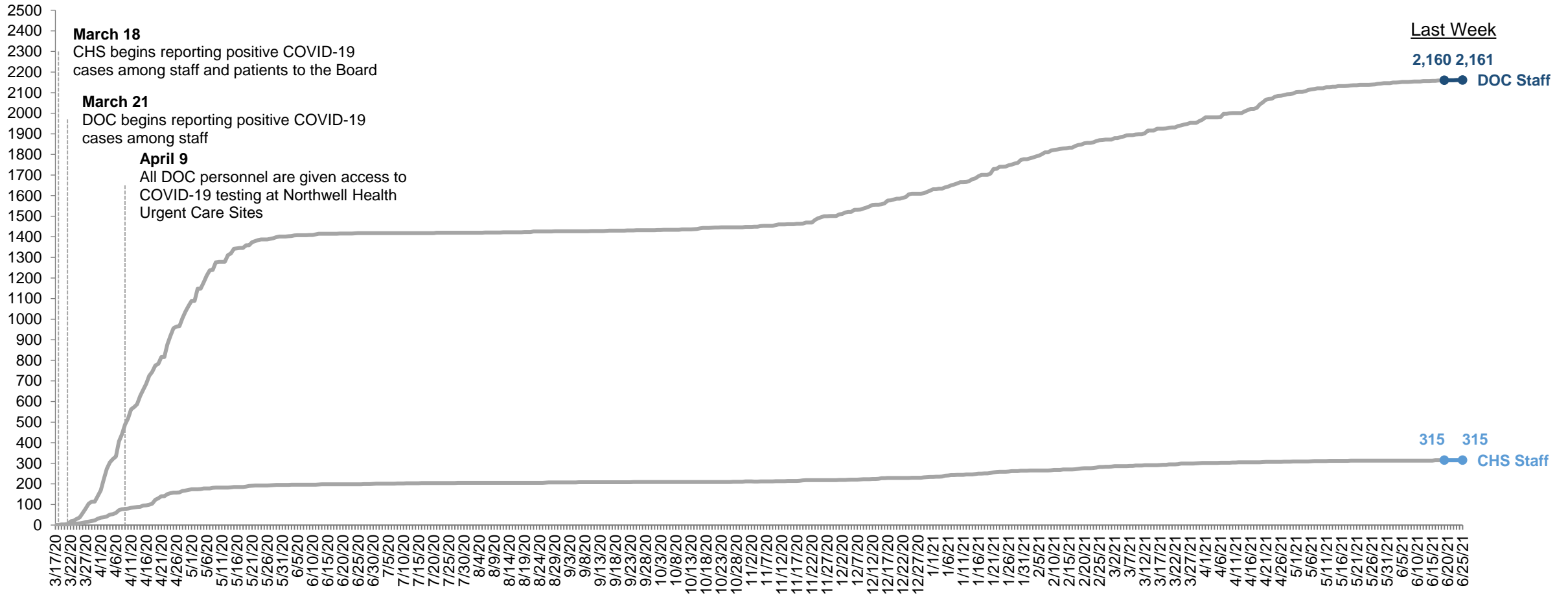

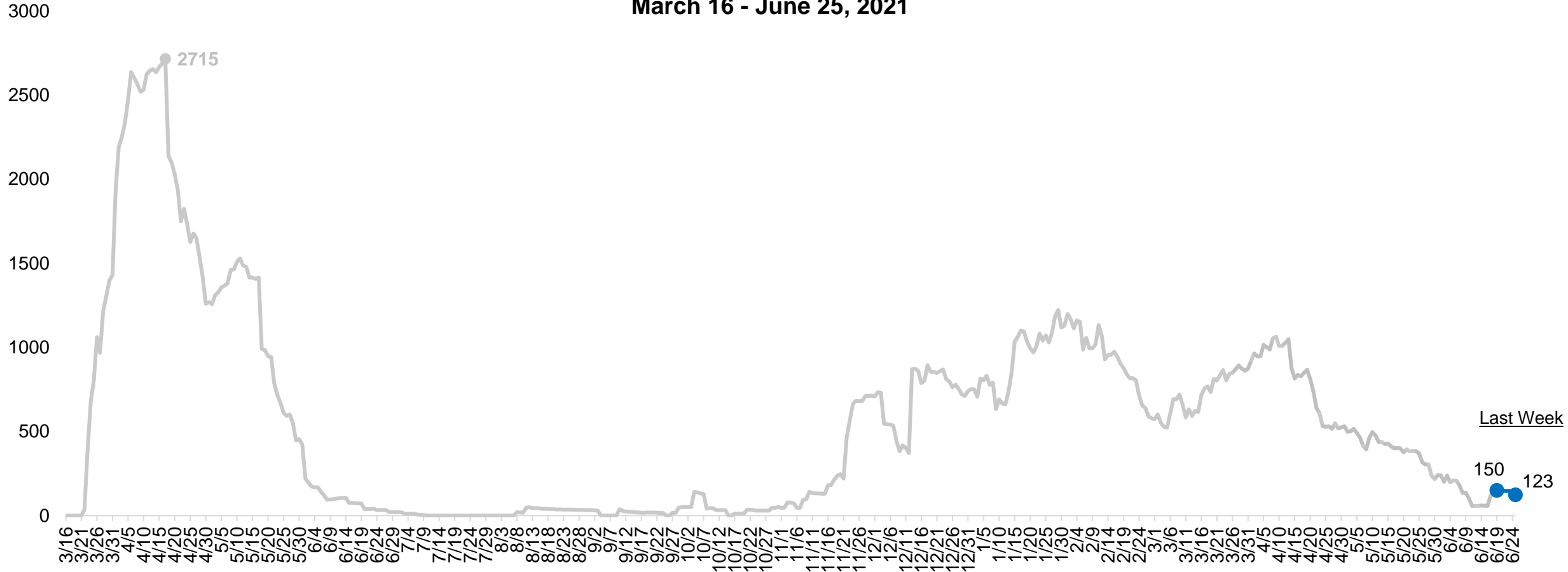

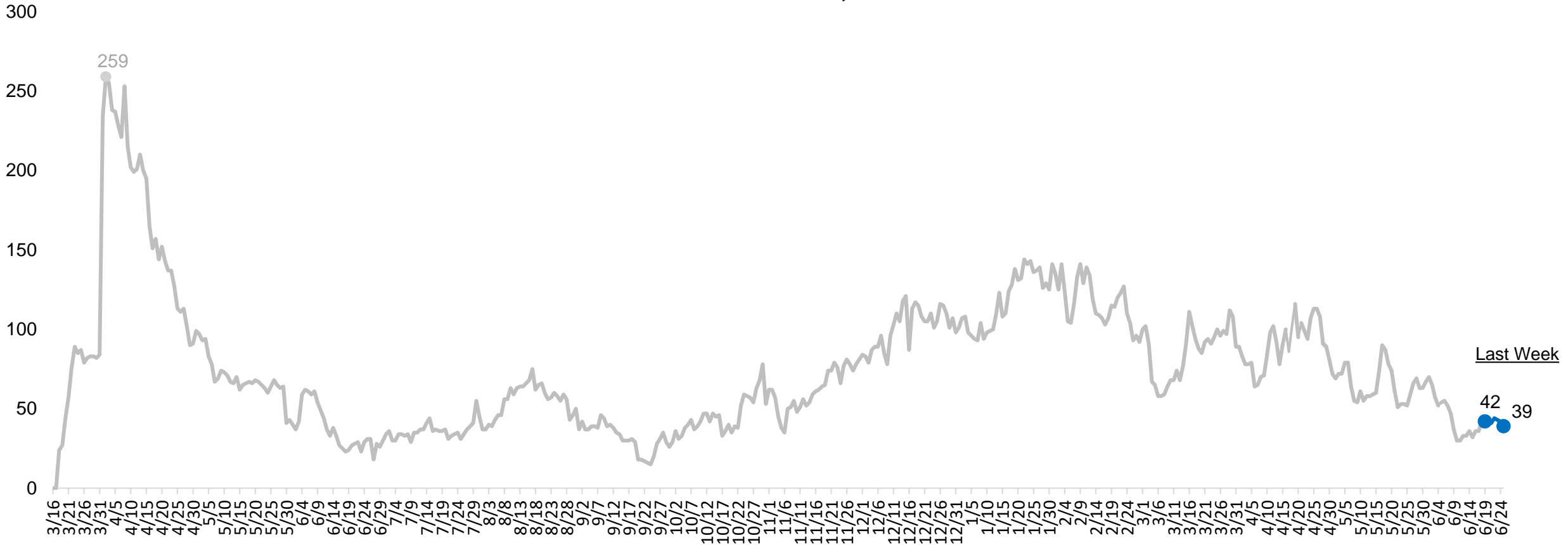

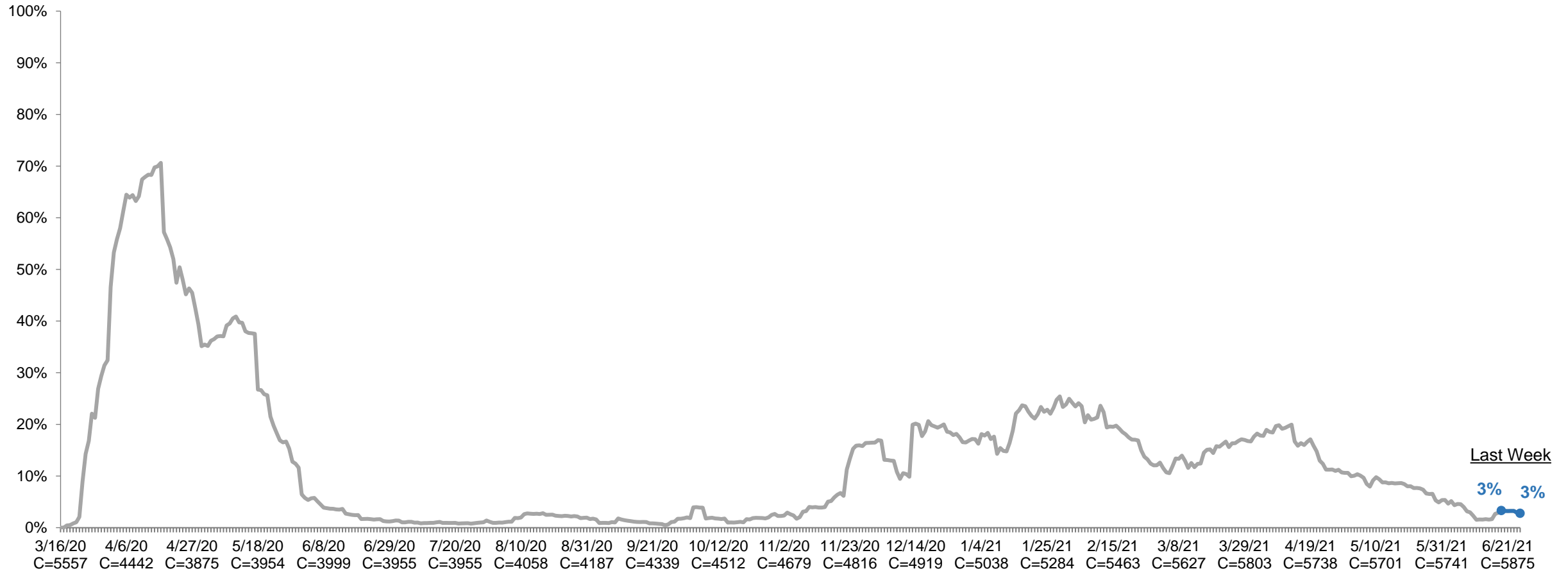

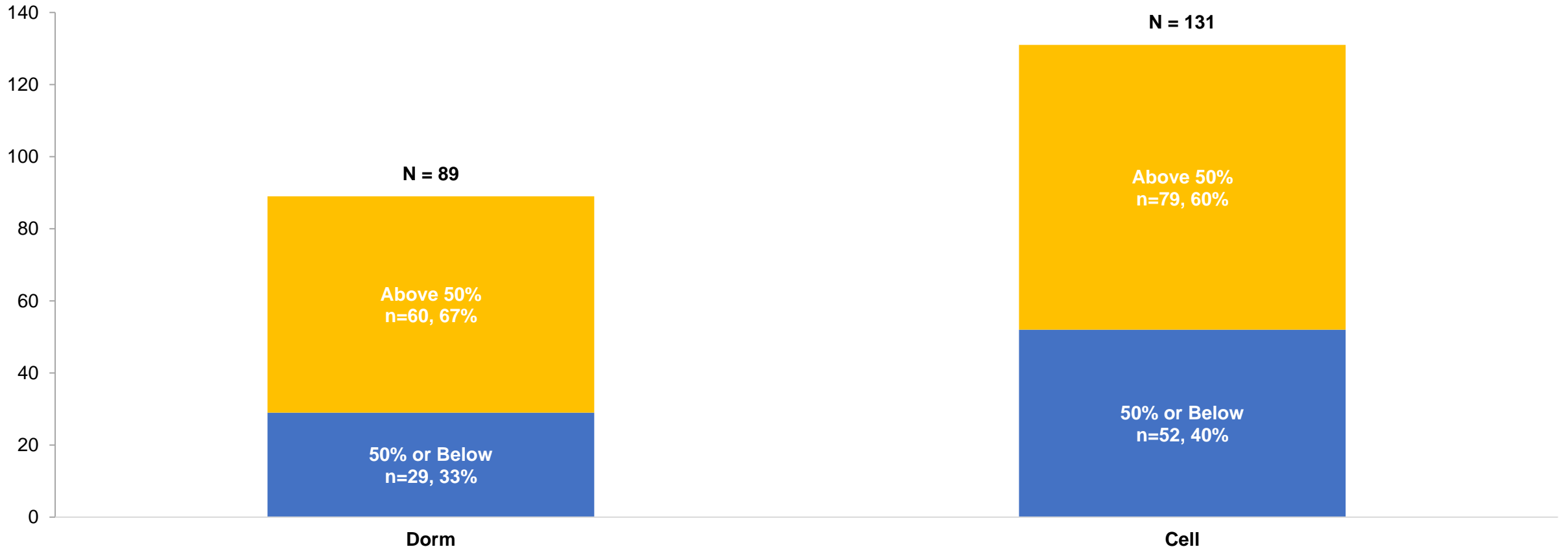

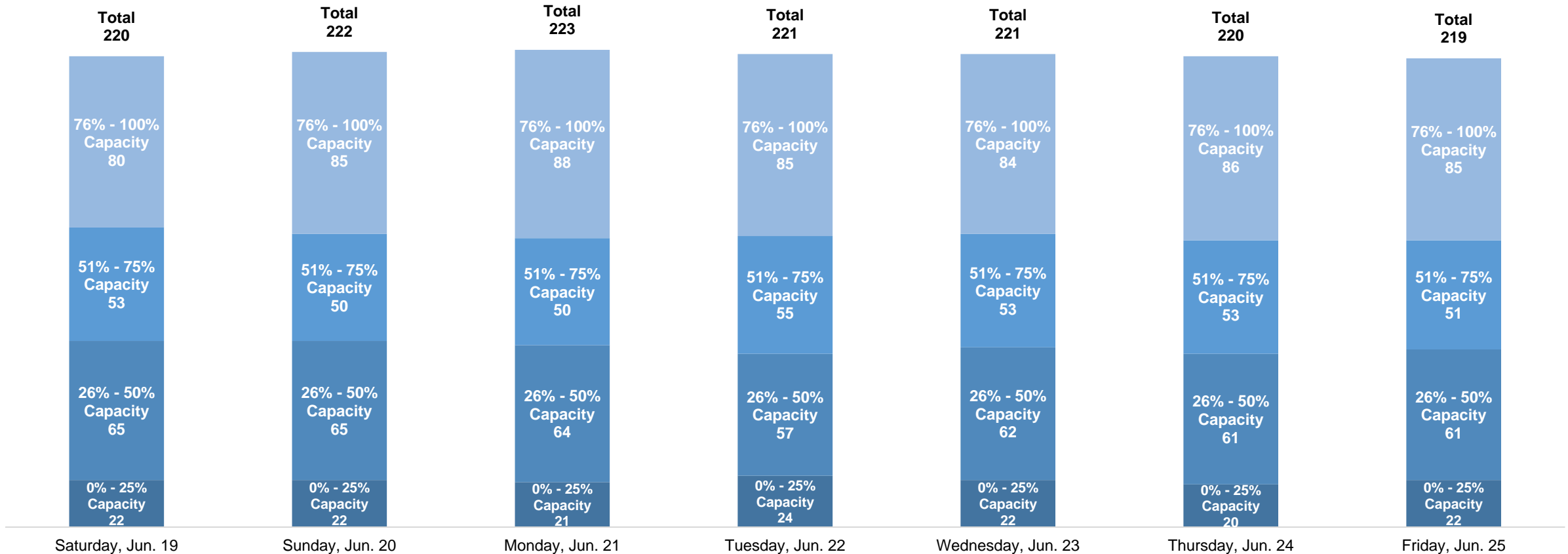
