

BOARD OF ESTIMATE AND APPORTIONMENT

BOARD OF ESTIMATE AND APPORTIONMENT—CITY OF NEW YORK, MAYOR'S OFFICE, CITY HALL, Tuesday, December 23, 1890—11 o'clock A. M.

The Board met in pursuance of an adjournment.

Present—All the members, viz.:

Hugh J. Grant, the Mayor; Theo. W. Myers, the Comptroller; John H. V. Arnold, the President of the Board of Aldermen; Michael Coleman, the President of the Department of Taxes and Assessments.

The minutes of the meeting held December 22, 1890, were read and approved.

Ambrose Snow, representing the Chamber of Commerce, and F. W. Devoe, Chairman of the Committee on Nautical School, Board of Education, appeared before the Board and made statements relative to the transfer of the supervision of the said school from the Board of Education to the Chamber of Commerce.

Chamber of Commerce.

Whereupon the question was taken upon the following resolution:
Resolved, That this Board recommends the transfer, by the Legislature, of the supervision of the Nautcal School from the Board of Education to the Chamber of Commerce, and that the City be exempted from furnishing the necessary amount for maintaining the same.

Which was adopted by the following vote:
Aftirmative—The Mayor, Comptroller, President of the Board of Aldermen, and President of the Department of Taxes and Assessments—4.

The Chairman presented the following:

NEW YORK, December 23, 1890.

Hon. HUGH J. GRANT, Mayor :

DEAR MR. MAYOR—If agreeable to the Board of Estimate and Apportionment, I should like five minutes with them to discuss the question whether it is wise for them to give the merchants of New York a chance to see if the St. Mary's Schoolship can, with propriety, be placed under their management through the medium of the Chamber of Commerce. Personally, I think the experiment worth the trial, and if so, and your Board agree, it will follow that sufficient appropriation and appropriate legislation must be had. Yours, truly, CHAS. S. Hon. THEO. W. MYERS, Comptroller:

Hon. Theo. W. MYERS, Compireder:

SIR—I have examined the premises No. 160 Flm street, which the Board of Education desires to lease at \$1,500 per annum for one year, with an option for two years, with an increase of \$100 for each additional year.

I think the rent proposed is reasonable.

It is proposed that the building be connected by openings with the present building, and it is expected, by using the lower part as a store-house for school books and supplies, and the upper part as offices, draughting-rooms and store-rooms for the Superintendent of School Buildings, to relieve the main building of its overcrowded condition. This main building was erected fifty years ago, when it was ample in size, but the enormous increase of business in those years renders it now cramped and inadequate. and inadequate.

I entertain no doubt as to the propriety of obtaining this additional space,
