A T A MEETING OF THE BOARD OF HEALTH of the Health Department of the City of New York, held at its office on the 8th day of February, 1878, the following resolution wa adopted:

Resolved, That the following sections of the Sanitary Code be and are hereby annulled:

Section 33. That no person shall, in the built-up portion of the City of New York, or adjacent thereto, sell or have for sale any fish in or from any vehicle, or in any street or public place, from which all parts which are not usually cooked for food have not been removed.

Section 62. That no person shall become, or continue, or engage as, or in the business of a butcher, at or in any public or private market or stand in the City of New York, without a permit therefor from this Department.

Section 66. That no person engaged in the selling or keeping for sale of any fish, meat, birds, fowl, fruit, or vegetables, shall, without a permit from this Department occupy or encroach upon any p rition of any street or sidewalk, or public place in the City of New York.

And Section 168 That every car used for the transportation of passengers in the City of New York, shall be so constructed as at all times to provide and secure good vent-lation.
