DEPARTMENT OF DOCKS.

At a meeting of the Board of Docks, held January 8, 1879.

Present—Commissioners Dimock and Vanderpoel.

Absent—President Westervelt.

On motion, Commissioner Dimock took the chair.

The minutes of the meeting held December 31, 1878, were read and approved.

A report was received from the Engineer-in-Chief, with plans duly approved by him, of two piers, etc., to be built at the foot of Houston street, East river, by the Nassau Ferry Company, in pursuance of the conditions of the lease purchased by said company at public sale on 16th December, 1878, and, being read,

On motion, the communication from the Nassau Ferry Company, under date April 16, 1878, was taken from the table and placed on file, and the following resolution adopted:

Resolved, That permission be and is hereby granted to the Nassau Ferry Co., lessee, pursuant to the terms and conditions set forth in the notice of public sale, held December 16, 1878, of wharf property and rights, foot of Houston street, East river, to erect at its own cost and expense in front of the bulkhead on the easterly side of Tompkins street, about 130 feet southerly from the south side of Houston street, extended, a pier upon piles about 225 feet in length and having a width at the outer end of about 24 feet, and inner end of about 53 feet; and also about 32 feet northerly of said pier, another pier on piles about 140 feet long and having a width at the outer end of about 12 feet, and about 52 feet at the bulkhead; with the privilege of placing and erecting in front of said bulkhead such floats, bridges and racks as may be necessary to establish a first class ferry, with the liberty to make from time to time such repairs thereto as may be required; provided, that the said company shall construct and erect both of said piers in conformity with the plans approved this date by the Engineer-in-chief of this Department, and that all the work hereby authorized, including the erection of said floats, bridges and racks, shall be done under the supervision of that officer; and provided further, that the said company shall agree in writing to pay to this Department, as rent for the land under water covered by said first mentioned pier, the sum of \$300 per annum, payable quarterly in advance, from and after 1st May, 1879, subject to the stipulations in regard to the title to said land under water, contained in the aforesaid notice of sale.

On motion, the Secretary was directed to forward to the Nassau Ferry Company the plans of the bulkhead and pier to be built by said company, at the foot of Houston street, East river, which have been this day approved by the Engineer-in-Chief of this department.

The following communications were received, read, and

On motion, laid on the table to await action where taken as stated, to wit:

From Wm. A. Jenks—For permit to occupy dock at Twenty-second street, East river.

From George W. Wingate—In reference to renewal of lease of inner half of upper side of Pier 22, and inner half of lower side of Pier 23, and bulkhead between said piers, East river, to the Fulton Market Fishmongers' Association.

The following communications were received, read, and

On motion, placed on file, action being taken, where necessary, as stated, to wit:

From Department of Public Charities and Correction, stating that no stone from the cap-sizing of a scow had been sunk opposite Bellevue Hospital, East river, as complained of by Board of Commissioners of Pilots. Communication from said Board taken from the table, and placed on file.

From Margaret Manning, being judgment claim in the sum of \$5,614.55, against John Hogan, contractor, to be filed with contract.

From Patrick H. Lydon, being claim for \$4,355.22, against J. M. C. Scully, contractor.

From Engineer-in-Chief—

1st. Report of work performed during week ending January 4, 1879.

2d. Report stating that the roof of the shed erected by Phelps Brothers on the pile platform, upper side of Pier 40, East river, needed to be strengthened. Engineer-in-Chief to notify Phelps Brothers to strengthen said shed, in conformity with his recommendation.

3d. Report as to repairs needed to be made to pier at Eighty-sixth street, East river. Engineer-in-Chief directed to make the repairs in conformity with his report.

4th. Report stating that the shed, office, etc., erected on pier at Fifty-first street, East river, by the Morrisania Steamboat Co. lessee, had been removed by said company. The Secretary directed to notify said company that, by the permit issued December 19, 1877, for the erection of said office, shed, etc., it was expressly provided that the improvements should revert to and become the property of the Corporation, and ask an explanation from said company in reference to said removal.

A report was received from Superintendent Smith, stating that canal boat No. 112 had sunk at the north side of Pier, new 1, North river; and, being read,

On motion, it was

Resolved, That the owner or owners of Canal-boat 112, loaded with coal, and sunk on January 2, instant, at the north side of Pier, new 1, North river, as reported by the Superintendent of the district, are hereby notified to remove the said boat without delay.

On motion, the Engineer-in-Chief was directed to repair the holes in the bulkhead between Piers 50 and 51½, East river.

On motion, The Secretary was directed to notify R. Cornell White to be present at the next meeting of the Board, in reference to the arrearages of rent due under the lease of Pier No. 37, East river.

The following communications were,

On motion, taken from the table and placed on file.

From Counsel to the Corporation—In reference to lease of land under water adjoining Pier 36, East river.

From Geo. H. Pennimann, Executor—Petition to widen Pier 36, East river, etc.

From Police Department—As to dumping ashes, etc., at Fifty-sixth to Fifty-eighth streets, East river.

From Engineer-in-Chief—Report as to dredging between Fortieth and Forty-first streets and Fifty-fifth and Fifty-ninth streets, North river.

On motion, the Engineer-in-Chief was directed to report as to the dimensions of premises required by the Health Department, at the East Seventeenth street yard, for the purpose of erecting thereat a Reception Hospital, the Commissioners of the Sinking Fund at their meeting held December 24, 1878, having given consent to the said Health Department to use the premises at said yard, now occupied as a dog pond.

On motion, the following preamble and resolution was adopted.

Whereas, In view of the largely increased duties and responsibilities devolved by this Board upon the Chief Clerk, and in view of the fact that by this readjustment of the duties of the office, clerical expenses are considerably reduced: be it

Resolved, That the compensation of the Chief Clerk from January 1, 1879, shall be at the rate of \$3,000 per annum.

On motion, the Board adjourned.

Resolved, That the Comptroller be and he is hereby authorized to issue, from time to time, as may be required, and at such rates of interest, not exceeding six per cent. per annum, and for such period, conformable to law, as he may determine, "Assessment Bonds of the Corporation of the City of New York," to the amount of fifty thousand dollars, under the provisions of chapter 397, Laws of 1852, and chapter 580, Laws of 1872.

The Chairman put the question whether the Board would agree with said resolution.

Which was decided in the affirmative by the following vote:

Affirmative—The Mayor of the City of New York (Chairman), the Comptroller of the City of New York, the President of the Board of Aldermen, and the President of the Department of Taxes and Assessments—4.

The Comptroller offered for adoption the following resolution:

Resolved, That the sum of thirteen hundred and fifty-eight dollars and fifty-seven cents be and the same is hereby appropriated from the Excise Fund to the "St. Stephen's Home for Children," in the City of New York, for the support of fifty-three children in said institution committed by police magistrates, pursuant to chapter 404, Laws of 1878, from October 1 to December 31, 1878, aggregating 4,755 days, at two dollars per week, being at the rate of about 28 57-100 cents per day for the support of each child, the appropriation being made in accordance with the opinion of the Counsel to the Corporation, dated January 16, 1877.

The Chairman moved that it be laid over until the next meeting.

Which was agreed to.

The Comptroller offered for adoption the following resolution:

Resolved, That the sum of eight hundred and fifty-six dollars be and the same is hereby appropriated from the Excise Fund to the "Home for Fallen and Friendless Girls," for the support of forty-two inmates, from October 1 to December 31, 1878, inclusive, at the rate of \$150 each per annum, pursuant to chapter 868, Laws of 1873.

The Chairman moved that it be laid over until the next meeting.

Which was agreed to.

The Comptroller offered for adoption the following resolution:

Resolved, That the sum of six hundred and sixty-eight dollars be and the same is hereby appropriated from the Excise Fund to the "American Female Guardian Society," for the support of thirty-nine children in the home under the management of said Society, committed by Police magistrates, under the provisions of chapter 249, Laws of 1847; and chapter 404, Laws of 1878, from October 1 to December 31, 1878, aggregating 2,338 days, at two dollars per week, the appropriation being made in accordance with the opinion of the Counsel to the Corporation, dated January 16, 1877, and chapter 105, Laws of 1878.

The Chairman moved that it be laid over until the next meeting.

Which was agreed to.
