

Special Guest Commissioner's Corner



James Roberts, DEP's Deputy Commissioner for the Bureau of Water and Sewer Operations, is a guest commentator this week.

Last week, DEP announced the completion of two water and sewer infrastructure upgrades in the Staten Island neighborhoods of Arden Heights and Annadale. Prior to these projects, most of the roadways in these areas were not equipped with catch basins or storm sewers and they often flooded during heavy rain storms. As part of the upgrade, more than a mile and a half of storm sewers and 100 catch basins were installed to help drain precipitation from the roadways. The stormwater will be diverted to a new bluebelt area where it will be stored and naturally filtered before it empties into the Arthur Kill. The projects also included the installation of more than a mile and a half of sanitary sewers that will allow 114 homes to connect to the City's sewer system and discontinue the use of septic tanks. In addition, work included the installation of new water mains, the reconstruction of the roadways and sidewalks, and the addition of more than 100 street lights, 31 traffic signals and nearly 300 street trees.

In Arden Heights, work included the installation of approximately 4,000 feet of distribution water mains. By replacing the old cast iron water mains with new ductile iron mains, the project will help ensure a reliable supply of high quality drinking water for area residents



and businesses. The construction of 3,800 feet of sanitary sewers allows nine homes to connect to the City sewer system and discontinue the use of septic tanks. These new sanitary sewer lines will also serve as an outlet for other south shore communities to connect to in the future. In addition, the installation of 1.530 feet of storm sewers and 23 catch basins will divert precipitation from the roadways into a new Bluebelt wetland. The constructed wetland, located on State preserved property, also provides new habitat for wildlife including turtles, herons, and ducks. This work included the removal of invasive plants and the addition of diverse, native trees, shrubs and wildflowers to help protect water quality.

The Annadale neighborhood saw the addition of 4,475 feet of distribution water mains, over 5,000 feet of sanitary sewer lines, nearly 7,000 feet of new storm sewers and 76 catch basins. The new sanitary service will allow 105 homeowners to connect to the City's sewer system.

Thanks to this \$23 million investment in the neighborhoods of Arden Heights and Annadale, the streets are now less susceptible to flooding and an additional 114 homeowners can discontinue the use of septic systems. These infrastructure upgrades will protect public health and the environment, but just as importantly they will improve the quality of life for residents.

Did You Know?



That DEP opened nearly 5,000 acres of City-owned property throughout the watershed for low-impact recreation last year? The newly opened properties include 2,626 acres in Delaware County, 1,248 acres in Greene County, 444 acres in Putnam County, 200 acres in Schoharie County, and 302 acres in Ulster County. In total, there are now more than 125,000 acres of lands and reservoirs open for fishing, hiking, hunting and other forms of recreation. DEP will continue to work with our partners in the region to improve the access and programs that help support the tourism and outdoor recreation economies that are so important to communities in the watershed.

- Inspect your vehicle before every use to ensure that the tires, lights, wipers and other equipment are in good working order and that there is sufficient window washing fluid
- Make sure that you brush/scrape snow and ice off all windows, mirrors and lights on your vehicle prior to driving
- · Report defective vehicles to your supervisor immediately
- · Make sure you can see and be seen
- · To properly use antilock braking systems, "Stomp, stay, and steer"
- If you hit a slick patch, don't overcompensate by trying to steer out of it. Take your foot off the gas and allow the steering system to right itself, and then slowly steer out of the situation
- · Don't be fooled by all-wheel drive or electronic stability control
- Adjust speed for road conditions and maintain a safe distance from other vehicles
