LEGISLATIVE DEPARTMENT.

[From proceedings of Board of Aldermen of October 5, 1876.]

Alderman Hess called up G. O. 359, being a resolution and ordinance, as follows; also a petition in favor of extending the high-service water north to Sixty-fifth street:

Resolved, That the Commissioner of Public Works be authorized and directed to extend the distribution of water from the high service reservoir, to include the district lying between Third avenue and Avenue A, and between Fifty-sixth and Sixty-first streets, as provided in section 2 of chapter 477, Laws of 1875.

He then moved to amend by striking out the compound word "Sixty-first" and inserting in lieu thereof "Sixty-fifth," before the word "streets."

The President put the question whether the Board would agree with said motion.

Which was decided in the affirmative.

And the resolution as amended was again laid over.

Whereas, On Thursday, the 21st instant, the historic day of the State of New York, a representation of the Police Department of this city, numbering about six hundred men, purpose visiting the Centennial Exposition at Philadelphia, by an arrangement made by the Commissioners of Police of this city, at an expense of four dollars each, which is imposed upon every member of the Police force taking part in the demonstration; and as it is intended purely as a display of the Police force of the city, it is unjust to ask each person to pay his own expenses, while acting as a representative of any part or portion of our municipal system of government; be it

Resolved, That, as there is no contingent fund to pay expenses of this character, the Board of Estimate and Apportionment be and is hereby respectfully requested to transfer from any unexpended balance of appropriation of former years the sum of three thousand dollars, for the purpose of defraying the expense of the members of the Municipal Police Force of this city, on a visit to the Centennial Exposition at Philadelphia, on the 21st day of September, 1876, being the historic day of this State; and that when such transfer shall have been made, and the necessary amount thus provided, the Comptroller be and he is hereby requested to pay the same upon the presentation of vouchers satisfactory to him to the Superintendent of Police, or so much thereof as may be necessary to pay the expenses of the said members of the Municipal Police who shall visit the Centennial Exposition on the 21st day of September, 1876, and the Superintendent of Police, upon the receipt of the moneys provided in this resolution, is hereby directed to refund to the members of the Police force the amount each shall have subscribed towards paying the expenses of the visit.
