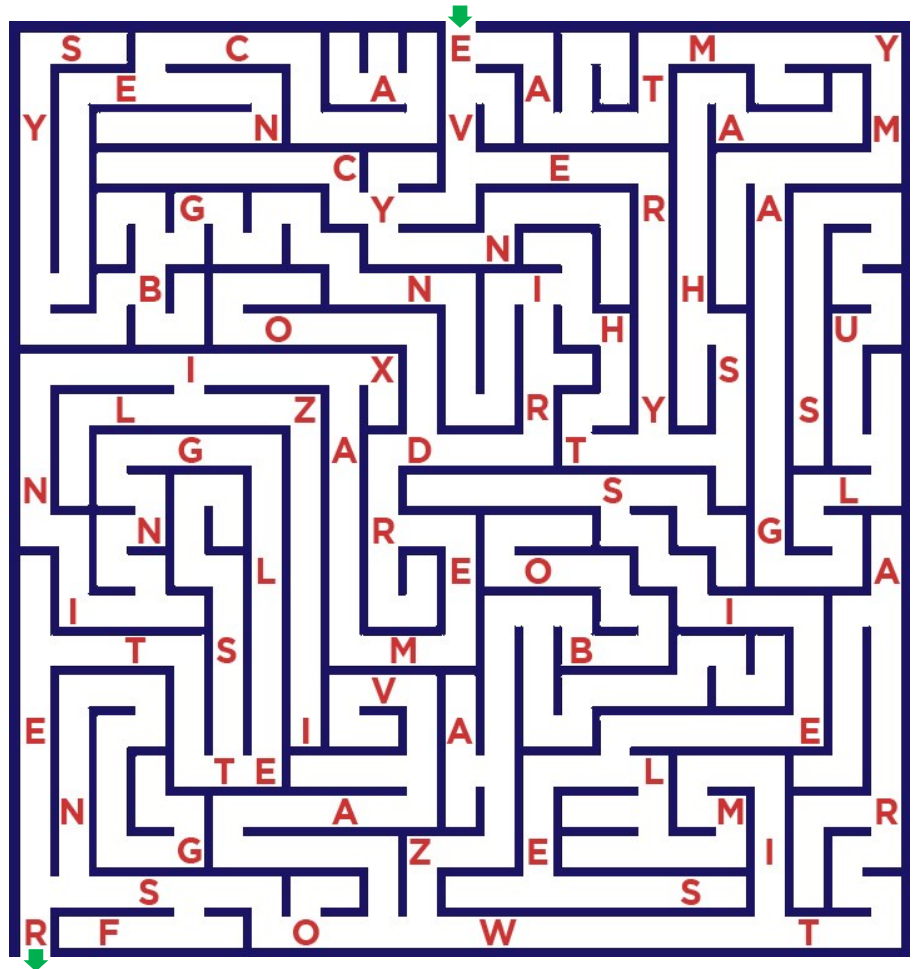
JULY PUBLIC SERVICE PUZZLER
