Jou ki te 16 mas, Depatman Pwoteksyon Konsomatè ak Travayè (Department of Consumer and Worker Protection, DCWP) Vil New York la te anonse yon règ ijan ki fè li ilegal pou monte pri machandiz pèsònèl oswa machandiz pou kay la twò wo oswa nenpòt sèvis yon moun bezwen pou evite oswa limite pwopagasyon nouvo kowonaviris (COVID-19) la oswa trete li.

Men kèk egzanp:

- Pwodui netwayaj
- Pwodui ak sèvis netwayaj
- Dezenfektan (wayp, likid, espre)
- Mask pou figi
- Gan
- Dezenfektan men
- Medikaman
- Sèvyèt an papyè
- Alkòl
- Savon
- Sèvyèt an papyè

Li ilegal pou ogmante kalite machandiz ak sèvis sa yo pa 10% oswa plis.

Eksepsyon:

Si ou montre pri bagay sa yo paske li koute w plis pou w gen yo nan rezèv ou, ou dwe bay prèv la bay DCWP.

Ou dwe konnen fòk nou ka konpare nenpòt ogmantasyon. Si ou peye \$2 an plis pou chak mask, ou pa ka fè kliyan yo peye \$50 an plis.

Do you sell any good or service needed to limit the spread of COVID-19?



It is **ILLEGAL** to overcharge customers.

On March 16, the NYC Department of Consumer and Worker Protection (DCWP) announced an emergency rule that makes price gouging illegal for any personal or household good or any service that is needed to prevent or limit the spread of or treat the new coronavirus (COVID-19).

Examples include:

- Cleaning products
- Diagnostic products and services
- Disinfectants (wipes, liquids, sprays)
- Face masks
- Gloves
- Hand sanitizer
- Medicines
- Paper towels
- Rubbing alcohol
- Soap
- Tissues

It is illegal to increase prices of these types of goods and services by 10% or more.

Exception:

If you raised the price of these items because it costs you more to supply them, you must provide proof to DCWP.

Be aware that any increase must be comparable. If you paid \$2 more per item, you cannot charge customers \$50 more.
