

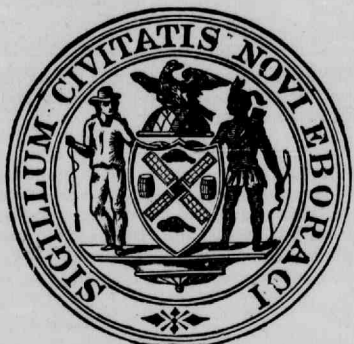

GENTLEMEN—The undersigned present this their petition to your Honorable Body, and respectfully ask you to grant them permission to attach their patent advertising sign-holders and signs to and suspend the same from and around each and every street lamp-post located on the corners of the streets, avenues, and places within the corporate limits of the City of New York, for a period of twenty-five years, for which privilege your petitioners are willing to pay annually into the city treasury three per cent. of their gross receipts from their business in the City of New York. Your petitioners, therefore, respectfully request the passage of the resolution hereto annexed.
And your petitioners will ever pray.

NEW YORK, November 19, 1878.

Resolved, That permission be and is hereby given to the "Metropolitan District Advertising Company (Limited) of New York," and their successors and assigns, to attach their patent advertising sign-holders and signs to and suspend the same from and around each and every street lamp-post located on the corners of the streets, avenues, and places within the corporate limits of the City of New York for a period of twenty-five years, said sign-holders to be of uniform design and dimensions, and so placed as not to extend outwardly from the centre of each lamp-post a distance of more than twelve inches, or downward from the top of each lamp-post a distance of more than thirty-six inches, and to be securely fastened thereby by means of two wrought-iron clamps, one of which is to be affixed at the top and one at the bottom of each of the sign-holders, so as to effectually prevent their becoming detached from the lamp-post to which they may be fastened ; said company shall file with the Comptroller of the City of New York, on the first day of November of each year, a written statement of the gross receipts from its business in the City of New York for the previous twelve months ; said statement to be duly authenticated by the seal of said company and the signatures of its president and secretary, and to be sworn to by its treasurer ; and at the time of filing said statement said company shall pay into the treasury of the City of New York, for and in consideration of the privilege hereby conferred, three per centum of its said gross receipts.

MOTIONS AND RESOLUTIONS.

By Alderman Reilly—

Whereas, The Legislature of 1878 passed the following act :

CHAPTER 380.

AN ACT relating to the public place or square known as Washington park, in the city of New York.
Passed June 1, 1878 ; three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows :
Section 1. The public park or place, or square in the city of New York, known as Washington square or Washington parade ground, shall (except as hereinafter provided) be used in perpetuity as one of the public parks, or squares, or places of said city, and shall be kept by the department of public parks in proper order, ornamented and protected, for the public use as a public park, and for no other use or purpose whatsoever.

Sec. 2. The street or roadway through said park, running from Fifth avenue on the north to South Fifth avenue on the southeast, shall be continued in use as one of the public streets of said city under the charge of the department of public works.

Sec. 3. This act shall take effect immediately.

Resolved, That the Commissioners of the Department of Public Parks be and they are hereby directed to inform this Board at its next meeting whether they have given any authority to the New York Elevated Railroad to occupy any portion of the Battery Park other than that granted in the year 1876.

The President put the question whether the Board would agree with said resolution.

Alderman Slevin presented the following opinion of the Counsel to the Corporation, on the question of the right of the clerks of the several markets to give permits for stands to occupy the streets, etc., within three hundred yards of the markets ; also the accompanying ordinance :

LAW DEPARTMENT,
OFFICE OF THE COUNSEL TO THE CORPORATION,
NEW YORK, September 27, 1878.

J. M. VARIAN, Esq., Superintendent of Markets :

DEAR SIR—You some time since requested my advice upon the following statement of facts :
Various persons are in the habit of selling and exposing for sale meat and other articles upon stoops and other structures in front of buildings standing in streets adjoining the public markets, without paying market fees or rents to the city. Such persons come into competition with dealers who hire stands in the markets, and pay rent therefor, and a considerable portion of the business which could otherwise be done by such dealers is thus drawn away from the markets. So much injury has been done in this way to the trade of persons having stands in the markets, that they have complained to the Comptroller, and have applied for a reduction of their rents. Under these circumstances, you desire to be advised whether the clerks of markets have authority, under the ordinances of the Common Council, to remove stands and merchandise placed upon stoops and other structures in front of buildings in streets near the markets.

Section 8 of article 2 of chapter 35 of the Revised Ordinances of 1859 makes it the duty of the clerks of markets to set apart certain portions of the street at or near such markets for the purpose of exposing for sale and selling garden produce ; and the same section declares that no person shall expose for sale or sell any garden produce, or other thing whatsoever, in any street at or near said markets, other than the places so set apart. Section 9 makes it the duty of said clerks to give directions respecting the arrangement or removal of any article in the market, or streets adjoining thereto. Section 10 provides that in case of refusal or neglect to obey the directions of the said clerks, or either of them, it shall be the duty of the clerk to forthwith remove, or cause such article to be removed, to such place as he shall have previously directed, or to such other place as he shall think proper, from such market or street adjoining thereto. Section 11 provides that if such article shall be replaced after having been removed, and shall remain in or incumber or obstruct such market or street adjoining thereto, it shall be the duty of the clerk of such market to order and cause the same to be removed into the yard of the Superintendent of Repairs to Public Buildings, or other suitable place within the city. And sections 56 and 57 of the same chapter contain provisions for the sale and final disposition of articles that may be so removed to the Corporation Yard.

As a matter of law, a street includes every portion of the space or ground which has been legally set apart or taken therefor. If, therefore, the word "street" is used in the ordinance above referred to in its legal sense, it would include the ground or space upon which stoops and other structures are placed in front of buildings, and the clerks of markets would be authorized to remove any meats or merchandise or stands therefrom. I presume, however, that the persons who are in the habit of selling meat and other articles from stoops in front of buildings have so great a pecuniary interest in the matter that they would resist any attempt on the part of the clerks of markets to remove such articles, and would perhaps take the matter into the courts. In such case it might be held that the word "street," as used in said ordinances, does not include stoops and other structures placed in front of buildings, but refers to the carriageway and sidewalks only. Under these circumstances, it seems to me that it would be advisable to request the Common Council to pass an ordinance which will relieve the matter from all doubt, and I have accordingly prepared, and herewith transmit, an ordinance which, if adopted, will enable the clerks of markets to remove any merchandise that may be exposed for sale on stoops and other structures in front of buildings which stand in streets near the markets.

AN ORDINANCE to explain and amend chapter 35 of the Revised Ordinances of 1859.

The word street or streets, whenever used in chapter 35 of the Revised Ordinances of the Mayor, Aldermen, and Commonalty of the City of New York, passed June 20, 1859, shall be deemed to include not only the carriageway and sidewalk, but every portion thereof, as established by law or ordinance, and also every porch, stoop, step, platform, stand, case, balustrade, post, rail, stairway, and every other structure, and every area, cellarway, and space, standing, placed, or being in or upon any portion of the ground which forms any such street or streets, as so established.

Alderman Morris moved that the opinion and ordinance be laid over and printed in the minutes.

The President put the question whether the Board would agree with said motion.

Which was decided in the affirmative, on a division called by Alderman Pinckney, viz. :

Whereas, The recent discovery of a defalcation or misappropriation of some of the funds of the Department of Docks by one of its employees suggests the inquiry : "Has the affairs of this Department ever been examined by the Commissioners of Accounts ?" and, as the first misappropriation of the moneys of the Department, although quite recently, and accidentally discovered, dates back to May 2, 1877, as appears by the evidence of one of its officers, either the officers of the Department or the Commissioners of Accounts have, seemingly, been remiss in their duties ; be it therefore

Resolved, That the Commissioners of Accounts be and they are hereby instructed to report to this Board when, if ever, any examination of the accounts of the Department of Docks has been made by them, or if it is in contemplation to make such investigation.

Sanitary Bureau.

The following is a record of the work performed in the Sanitary Bureau for the week ending November 2, 1878:

The total number of inspections made by the Sanitary and Assistant Sanitary Inspectors was 1,524, as follows, viz.: 2 public buildings, 610 tenement houses, 145 private dwellings, 80 other dwellings, 8 manufactories and workshops, 20 stores and warehouses, 43 stables, 1 market, 42 slaughter-houses, 1 slip, 7 fat-rendering establishments, 2 public sewers, 5 manure dumps, 1 oil works, 3 garbage dumps, 43 sunken and vacant lots, 2 soap factories, 1 head-cleaning establishment, 1 lime kiln, 1 dyeing establishment, 50 yards, courts, and areas, 54 cellars and basements, 109 waste pipes and drains, 156 privies and water-closets, 93 streets, gutters, and sidewalks, 2 dangerous stairways, 4 cesspools, 2 piggeries, 2 smoky chimneys, 15 other nuisances, together with 24 visits of the Sanitary Inspectors to cases of contagious disease.

The number of reports thereon received from the Inspectors was 525.

During the past week 78 complaints were received from citizens, and referred to the Sanitary and Assistant Sanitary Inspectors for investigation and report.

Permits were issued to the consignees of 75 vessels to discharge cargoes, on vouchers from the Health Officer of the port.

56 permits were granted scavengers to empty, clean, and disinfect privy-sinks.

The Disinfecting Corps have visited 42 premises where contagious diseases were found, and have disinfected and fumigated 36 houses, 36 privy-vaults, together with clothing, bedding, etc.

93. Thence on an arc of a circle of 55 feet radius whose centre lies on the prolongation westerly of the last above described curve for 96 41-100 feet to a point of tangency.

94. Thence southwesterly on a tangent of 107 56-100 feet to a point of curve.

95. Thence to the left on an arc of a circle of 265 feet radius for 265 feet to a point of tangency.

96. Thence southerly on a tangent for 157 61-100 feet to a point of curve.

97. Thence to the right on an arc of a circle for 239 14-100 feet to a point of tangency.

98. Thence westerly on a tangent for 118 82-100 feet to a point of curve.

99. Thence to the left on an arc of a circle of 109 9-10 feet radius for 69 17-100 feet to a point of tangency.

100. Thence southwesterly on a tangent for 156 75-100 feet to a point of curve.

101. Thence to the right on an arc of a circle of 120 feet radius for 208 11-100 feet to a point of tangency.

102. Thence northwesterly on a tangent for 225 53-100 feet to a point of curve.

103. Thence to the right on an arc of a circle of 315 54-100 feet radius for 166 21-100 feet to a point of tangency.

104. Thence northerly on a tangent for 157 52-100 feet to a point of curve.

105. Thence to the left on an arc of a circle of 57 53-100 feet radius for 108 63-100 feet to a point of compound curve.

106. Thence to the left on an arc of a circle of 214 96-100 feet radius for 253 4-10 feet to a point of tangency.

107. Thence southerly on a tangent for 157 63-100 feet to a point of curve.

108. Thence to the right on an arc of a circle of 433 23-100 feet radius for 377 16-100 feet to a point of reverse curve.

109. Thence to the left on an arc of a circle of 136 5-10 feet radius for 206 23-100 feet.
