

An Ordinance to amend section 9 of chapter XIII. of the Revised Ordinances of 1866, entitled "Of the firing of firearms, cannons, and fireworks."

The Mayor, Aldermen, and Commonalty of the City of New York do ordain as follows:

SECTION I. Section 9 of chapter XIII. of the above entitled ordinance is hereby amended by adding thereto the following: "The provisions of this section shall not apply to Fleetwood or Jerome

Parks," so that said section, when so amended, shall read as follows:

"§ 9. No person shall fire or discharge any gun, pistol, fowling piece, or other firearms in the City of New York, under the penalty of ten dollars for each offense. The provisions of this section shall not apply to Jerome or Fleetwood Parks." SEC. 2. All ordinances or part of ordinances inconsistent or conflicting with the provisions of this

ordinance are hereby repealed. SEC. 3. This ordinance shall take effect immediately.

Tweed, then Street Commissioner, on the part of this city, and Benjamin C. Clark, a broker doing business in Wall street, which said contract expired during the incumbency of George M. Van Nort of the office of Commissioner of Public Works, and was by him renewed, without, in either case, being advertised for estimates or bids, the city is now paying sixty dollars per ton for iron water mains, when men engaged in the business of manufacturing such water pipes stand ready to furnish similar, it not superior, material for thirty-eight dollars per ton; and

Whereas, It is very questionable if the said contract, by reason of not having been open to competition, or advertised for public letting, is a valid one, or binding upon the city, particularly in view of the fact that the present contractor is not now, nor has he ever been, engaged in the work of manufacturing iron water pipes, and simply sub-contracts for the material required by the city,

realizing thereby twenty-two dollars per ton clear profit, which, in the aggregate, amounts to a vast sum of money, that should and can be saved to the tax-payers of this city, in the event of the contract being declared irregular or fraudulent; be it therefore

Resolved, That the Commissioner of Public Works be and he is hereby directed to report to this Board, at his earliest convenience, all the facts in his possession, or that he may be able to ascertain, in relation to the contract in question, together with such suggestions or recommendations as he may

deem proper, touching the validity of said contract.

Section 22, of article III, of chapter V, of the Revised Ordinances of 1866, is hereby amended by adding thereto the following: "Every action commenced, as provided in this ordinance, shall be sued and tried only in the District Court of the district in which the defendant shall reside or do business, and in no other, except upon an appeal taken from the decision of any Judge of any such District Court," so that such section, when so amended, shall read as follows:

§ 22. He shall institute an action in any of the cases mentioned in section 20 of this chapter, when instructed to do so by the Common Council, or the chief officer of any Department or bureau, or upon the complaint of any other person, when in his judgment the public interest requires that the same shall be prosecuted. Every action commenced, as provided in this ordinance, shall be sued and tried only in the District Court of the district in which the defendant shall reside or do business, and in no other, except upon an appeal taken from the decision of any Judge of any such District

Sec. 2. All ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance are hereby repealed.

Sec. 3. This ordinance shall take effect immediately.

UNFINISHED BUSINESS.

The President, as provided in section 13 of chapter 335, Laws of 1873, called up a veto message from his Honor the Mayor of an ordinance to amend Chapter XL. of the Revised Ordinances of 1866, relating to hackney coaches and cabs.

The Board then proceeded to reconsider the same in the manner prescribed by law, and, upon a vote being taken thereon, was adopted, notwithstanding the objection of his Honor the Mayor, on a division, viz.:
