

CY 2023 Annual Summary FDNY Office of Community Affairs

A community relations opportunity is in the hand of each individual fire fighter, safety inspector and educator. When we listen; we observe; only then can we innovate. Only then can we serve. The Office of Community Affairs takes pride in our community outreach programs. The past two years have been a time of reflection and retooling for the FDNY, as New York and the world adjusts and resumes its pace in the aftermath of the COVID-19 pandemic. The agency has been challenged to evaluate our work and consider how we can be more effective in impacting the issues of fire and life safety. The lessons learned during this time helped shape the development of CAU's outreach strategies to improve and strengthen our relationships with the city's most vulnerable communities.

Community investment and education is the foremost fire prevention strategy. With this precept in mind, Community Affairs continued to strategize new methods of engagement to ensure a continuity in outreach. FDNY Community Affairs was able to adjust all unit operations to utilize digital platforms (Fire Safety Education, Mobile CPR and Community Engagement).

Education and outreach are essential components of CAU's work. Presentations are provided for organizations, community groups, businesses, and faith communities about fire safety education programs and resources. In addition to presentations, CAU staff attend community meetings, host information tables at community events, conduct neighborhood canvassing, and more.

Engagement and building strong relationships with elected office, community-based organizations and diverse faith leaders is a key tool when responding to fire and life safety incidents. Education and outreach focusing on the immigrant community has always been a fabric of the agency's work.

To this end, CAU maintains numerous youth and senior, immigrant and minority, school and community outreach platforms and programs. All community initiatives undertaken by the FDNY are aimed at reducing fire, enhancing public safety, and improving the quality of life for NYC residents.

Fire Safety Education Unit

Events included all classroom/group presentations, alarm installation efforts and public tabling with the exception of fatal fire outreach campaigns. However, the unit continued developing digital curriculum for school aged and adult populations that highlights all aspects of residential fire safety, and participated in various virtual presentations coordinated by educators, intergovernmental and community based organizations.

Highlights in 2023

- Fire Prevention Week occurred October 8- October 14. Tabling events were coordinated throughout NYC, and promoted via community/elected email blasts and social media. The week culminated with a virtual Open House on October 14th, in which we launched our interactive animated video.
- E-Micromobility: A multi-pronged approach to education
 - Fire Safety Education partnered with the Office of the Public Advocate for a e- micro-mobility safety town hall.
 - Co-facilitated outreach with Small Business Services directly to business in the Chinatown.
- Fire Safety Education collaborated with digital media team and school aged children to be featured in the FDNY Smart.
- The relaunch of the Sound the Alarm NYC with the Red Cross. Free smoke alarm installation programs contribute significantly to creating safer communities by proactively addressing fire risks and promoting a culture of preparedness and prevention. This program prioritizes vulnerable populations who may face barriers accessing or affording smoke alarms. It ensures that those most at risk are provided with essential safety measures. This collaborative approach enhances the reach and impact of the initiative.
- Educational reach for 2023 on social media platforms was to more than 19.2 million followers, with a total reach of more than 21.1 million.
- The New York City Department of Housing Preservation and Development (HPD) and FSE continued the citywide fire safety campaign titled "Keeping Homes Fire Safe," to educate New Yorkers on six key fire safety recommendations for residents and property owners. At various event, FDNY and HPD outreach staff handed out new pamphlets with fire safety tips and spoke with New Yorkers about the importance of self-closing doors and smoke detectors, among other important fire safety tips.

Fatal Fire Outreach

Fire Safety Education unit conducted 90 fatal fire outreach campaigns in CY 2023 with 106 deaths, distributing over 2,500 smoke alarms and various educational resources to communities.

Digital Content on FDNYSmart.org/connect

Since the beginning of the pandemic, Community Affairs worked with FDNY Digital and Social Media to transition to educational content to a digital platform by creating videos and PSAs on all topics relating to residential fire safety. Notably, we are expanding our lithium-ion battery safety cadre.

Outlook for 2024

- Fire Safety Education Unit is working with NYCHA, NYPD Housing Bureau Community Affairs,
 Resident Engagement Division to develop fire safety trainings for citywide Tenant Association
 committees and leaders. The aim is to educate tenant leaders and activate them seasonally to
 enhance fire safety messaging to NYCHA residents.
- Work with FDNY MAPs and Data analytics to launch community risk assessment campaign.
 Utilizing data on fire trends, building risk assessments and socio vulnerability. Community Affairs will develop citywide fire safety education plans geo-targeting areas ranked as having high fire vulnerability.
- FSE is working with the Department of Education to establish a resource portal for administrators
 to access existing fire safety education curriculum and formalize opportunities to increase Fire
 safety presentations in schools.
- Fire Safety Education Unit is bolstering a schedule of digital trainings for families and youth who
 participate in programs through community-based organizations including but not limited to;
 Department of Youth and Community Development, Children's Aid Society and Catholic
 Charities.
- FDNY in partnership with Administration of Children Services and American Red Cross is coordinating digital fire safety training for frontline child welfare staff. In this partnership workers learned how to examine homes for potential fire hazards and refer families for smoke alarm installations.
- Coordinate the translation of educational videos into the Top LEP languages. Through our FDNYSmart.org website, content can be translated in over 80 languages.





Mobile CPR Training Unit

Similar to Fire Safety Education, throughout 2023 trainings were held both in person and virtually. The program equips New Yorkers with the skills to act in the event of cardiac arrest by offering free instruction across the five boroughs. The program, taught by certified FDNY EMS personnel, has successfully trained more than 50,000 New Yorkers in compressions-only CPR. The unit surpassed its annual goal of training over 2,500 New Yorkers in bystander CPR. In CY23, the following activities were carried out in support of the program:

Highlights in 2023

- CPR/ AED Awareness week June 1- June 7, Mobile CPR Training Unit coordinated a special educational campaign aimed at getting more New Yorkers to learn hands-only CPR. There were more than 10 pop up locations throughout the five boroughs.
- Promoted Burn Awareness information on all social media platforms for the month of February.
- FDNY Community Affairs is continued to work with the NYC Department of Education to coordinate high school- based outreach. This year we partnered with New York Giants and NYPD to train student athletes in CPR. High school students represented 39% of current training totals.
- Through support from the FDNY Foundation, the Mobile CPR Training unit has been able to
 expand its administrative functions by hiring retired EMS personnel to assist with scheduling,
 coordinating and performing outreach for all virtual trainings. The administrative team is
 composed of 1 EMS Officer and 6 retired EMS members. Additionally, Mobile CPR has developed
 a real time, web-based event tracking/scheduling system.
- Educational reach for 2023 on social media platforms was to more than 1.8 million followers
- Alongside with FDNY Digital media and Publications team, CPR has developed a real time, webbased event tracking/scheduling system.

Outlook for 2024

- Expand partnership with Public School Athletic league to train student athletes.
- Partner with DOHMH or HHC to establish schedule of coordinated virtual events, and implement evaluation tools to measure participant awareness of emergency response and healthy heart curriculum
- Develop public events that engage EMS Stations and community that include CPR and academy simulations for the community.
- Develop virtual event in partnership with NYC Department of Education for National CPR/AED Awareness Week to train citywide students week of June 1-7.

Community Engagement Unit

The Community Engagement Unit is composed of 3 Civilian employees; 1 Assistant Director and 2 Borough Managers. Community Engagement is responsible for:

- Attendance at monthly Community Board and Borough President district service cabinet, general board and public safety meetings to promote fire and life safety campaigns and mitigate community concerns over emergency operations
- Monthly presentations pertaining to seasonal fire/life safety campaigns for clergy/civic Associations
- Establishing partnerships with school and civic based organizations to increase fire safety education events
- Development and coordination of fire and life safety campaigns, which include but are not limited to;
 - o FDNY Summer Block Parties (May-August)
 - o National CPR/AED Awareness week. (June)
 - o Illegal Use of Fireworks (July)
 - o Be FDNY Smart Lithium Ion Battery Safety Campaigns
 - o Change Your Clock, Change Your Battery Campaigns (Spring/Fall)
 - o FDNY Citywide Open Houses (October)
 - o Fire Prevention Week (October)
 - o Holiday Safety (November/ December)
 - o Smoke Alarm Installation Outreach (Year-Round)

Highlights in 2023

- Promoted to a network of over 2,400 communities, faith, school and intergovernmental partners all FDNY PSAs which included content within FDNYSmart, specifically on seasonal fire safety campaigns.
- Coordinated with the NYC Department of Education and various private and community-based school partners to have over classroom presentations citywide.
- Partnership with 269 senior centers translating to impact of messaging to over 12,997 older adults.

Outlook for 2024

 Work with school, faith based, community boards and elected offices to coordinate various virtual Fire/Life Safety campaigns, that assist in reaching deliverables of installing over 12,000 alarms in the homes of New Yorkers and training over 2,600 via virtual CPR training platforms.

- Strengthen Clergy Advisory Council to amplify the messaging of fire safety education administration is committed to building a city where all communities can be fire safe. We will use active outreach and leadership development to bring community affairs resources in various neighborhoods. In conjunction, with the FDNY Foundation, Houses of Worship Grant (\$500,000) will be used to provide smoke and carbon monoxide home installations for congregants. By building on this collective of clergy leaders, and growing comprehensive community planning to educate congregations on fire and life safety and providing support to victims of fires. This partnership will embody a holistic, multi-pronged approach with the help of our very diverse NYC clergy. The aim is to use Community Risk Profiles to inform the work and outreach in various neighborhoods and create a clergy council toolkit.
- Targeted lithium-ion battery for fire safety education for delivery worker groups. Establishing
 train-the-trainer series for community stakeholders to be able to carry-out basic fire awareness
 training and ensures trainees understand fire safety precautions as it relates to lithium-ion
 batteries. Launch education campaign for most effected communities. This will include but is
 not limited to social media, community workshops, safety messaging, interactive webinars,
 school outreach and local partnerships
- Create and publish effective public education needs to cover a variety of disciplines for a variety
 of age groups. However, most of our endeavors focus on the groups most at-risk, and where the
 message is more likely to have a positive impact. Some of the planned publications include a PSA
 for persons deaf or hard of hearing in American Sign Language, burn awareness, more multilingual PSAs.
