

NOTICE IS HEREBY GIVEN PURSUANT TO THE AUTHORITY VESTED IN THE Police Commissioner by Section 435 of the New York City Charter and in accordance with Section 1043 of the Charter that the Police Department hereby amends Chapter 19 of Title 38 of the Official Compilation of Rules of the City of New York relating to parade permits. Matter underlined is new.

Written comments were accepted and a public hearing was held on December 28, 2010, at 1 Police Plaza in the Auditorium, between 11:00 A.M. and 2:00 P.M. Written comments and a summary of oral comments received at the hearing were available for public inspection, between the hours of 9:30 A.M. and 4:30 P.M. at the Office of the Deputy Commissioner, Legal Matters, New York City Police

Department, One Police Plaza, Rm. 1406A, New York 10038.

These amended rules were not included in the Department's most recent regulatory agenda because the need for them was not anticipated at the time the agenda was prepared.

Section 19-02 of Title 38 of the Rules of the City of New York is amended and section 19-05 is added to read as follows:

§19-02 Definitions.

For purposes of these rules, the following terms shall have the following meanings:

- (a) A "parade" is any procession or race which consists of a recognizable group of 50 or more pedestrians, vehicles, bicycles or other devices moved by human power, or ridden or herded animals proceeding together upon any public street or roadway.
- (b) "Same date or time" shall mean the same actual time period or hours.
- (c) "Same location" shall mean the location identified in the permit application.
- (d) "Demonstration" shall mean a group activity including, but not limited to, a meeting, assembly, protest, rally or vigil, moving or otherwise, which involves the expression of views or grievances, involving more than 20 people.
- (e) "Fifth Avenue" shall mean Fifth Avenue in the borough of Manhattan south of 114th Street and north of 15th Street.
- (f) "Applicant" shall mean the person or entity that applies for a permit authorizing a parade. Any person or entity responsible for organizing a parade, or any person or entity that publicizes a parade through advertisements or other means of mass communication, is authorized to act as the applicant.
- (g) "Charitable Athletic Parade" shall mean an event which is open to the public, the organizers of the event charge no fee or only an administrative fee for participation in the event and the proceeds of the event must be donated to a not-for-profit/charitable organization.
- (h) "Non-Charitable Athletic Parade" shall mean an event designed for public participation, which is competitive and recognizes the achievements of participants, for which a fee is paid to the organizers by individual members of the public to participate. Payments required from participants to participate in the event by organizers shall be considered a fee. Non-Charitable Athletic Parades shall be subject to fees pursuant to § 19-05(c).
- (i) "Administrative Fee" shall mean a fee collected by the organizers of a Charitable Athletic Parade which is intended solely to defray the administrative costs of the event.

$\S~19\text{-}05$ Fees for Non-Charitable Athletic Parades

- (a) The Chief of Department shall assess the fees set forth in subdivision c of this section for non-charitable athletic parades occurring on or after January 1, 2012.
- (b) The Chief of Department shall charge an applicant a fee in accordance with the following schedule, which shall be in addition to any fee requirement imposed by the Department of Sanitation or any other fee imposed by any city agency.
- (c) Application may be submitted no sooner than 180 days before the event and no later than ten days before the event. (i)Applications submitted between 180 days and 120 days before the event shall receive the fee assessment associated with the event no later than 90 days before the event. (ii) Applications submitted less than 120 days but 90 days or more before the event shall receive the fee assessment associated with the event no later than 45 days before the event
- (iii) Applications submitted less than 90 days but 30 or more days before the event shall receive the fee assessment associated with the event no later than 10 days before the
- (iv) Applications submitted less than 30 days but 10 or more days before the event shall receive the fee assessment as soon as reasonably practical.
- (d) Fees assessed must be paid prior to the event.
- (e) The fee shall be calculated as 100% of the Police Department's traffic control costs based upon number of police department personnel ("MOS") in the ranks of traffic enforcement agent and associate traffic agents, police officer, detective, sergeant and lieutenant, needed to safely perform traffic control functions as determined by the Office of the Chief of Department. However, for events which occur between January 1, 2012 and December 31, 2012 the fee assessed shall be 70% of the calculated fee.

- (d) This fee does not apply to the following:
 (i) City-sponsored events;
- (ii) "Occasions of extraordinary public interest" as defined in §19-01(b) of this title;
- (iii) Demonstrations, as defined in §19-02(d) of this title:
- (iv) Charitable Athletic Parades; or (v) Non-athletic Parades.

STATEMENT OF BASIS AND PURPOSE

The Police Department is charged with preserving the public

peace and preserving order at events which obstruct the free passage of public streets. This responsibility includes directing traffic, closing streets, and other traffic control functions to ensure the safety of the public and the participants in the event. To that end, the Department is authorized to promulgate rules and regulations governing permits for processions, parades, and races that occur on City streets. Parades require additional police presence for the performance of traffic control functions, and the resulting increase in overtime expenditures by the Department puts a strain on the NYPD's budget. Recoupment of traffic control costs associated with such events from the sponsors of the event is one way of ensuring that such events continue to be held without imposing an undue strain on NYPD and City resources. The Commissioner has determined to recover a fee only from organizations sponsoring athletic events when revenue is generated from fees charged to participants by the sponsoring organization.

Accordingly, in response to public comments received, the rule contains a fee schedule, based upon the number of NYPD personnel required to safely perform traffic control functions in order to clarify how the fee has been calculated and phases in implementation of the fee.

NOTICE TO ALL NEW YORK CITY CONTRACTORS

The New York State Constitution ensures that all laborers, workers or mechanics employed by a contractor or subcontractor doing public work are to be paid the same wage rate that prevails in the trade where the public work is being done. Additionally, New York State Labor Law §§ 220 and 230 provide that a contractor or subcontractor doing public work in construction or building service must pay its employees no less than the prevailing wage. Procurement notices in the CR are arranged by alphabetically listed Agencies, and within Agency, by Division if any. The notices for each Agency (or Division) are further divided into three subsections: Solicitations, Awards; and Lists & Miscellaneous notices. Each of these subsections separately lists notices pertaining to Goods, Services, or Construction.

Notices of Public Hearings on Contract Awards appear at the end of the Procurement Section.

At the end of each Agency (or Division) listing is a paragraph giving the specific address to contact to secure, examine and/or to submit bid or proposal documents, forms, plans, specifications, and other information, as well as where bids will be publicly opened and read. This address should be used for the purpose specified unless a different one is given in the individual notice. In that event, the directions in the individual notice should be followed.
