Approval is also given subject to submission for committee review of (1) a mock-up of the orbital finish created with a heavy grit, which the committee will review at a site visit anticipated in early fall prior to fabrication to determine whether the stainless steel is too reflective for the roof; and (2) the final planting plan, as soon as it is finalized by Piet Oudolf as part of a separate contract for the Battery Perimeter. Commissioner Nordenson abstains.
