Re: Agency-based Voter Registration Under LL29 of 2000, Mayoral Directive One of 2014, LL61 of 2014 and LL63 of 2014

July 1 through December 31, 2021 Report

Local Law 29 of 2000 requires that specified agencies offer voter registration in their encounters with the public. Mayoral Directive One of 2014 strengthened the requirements of LL29, putting a structure in place to monitor agency efforts to increase voter registration. Local Laws 61 and 63 of 2014 increased the number of agencies required to offer voter registration.

The Board of Elections reported that it processed 3,748 voter registration applications originating at City agencies (called Code 9 applications) between July 1 and December 31, 2021. This does not include applications from DSS/HRA, where voter registration applications are offered, collected, and sent to the Board of Elections under the requirements of the National Voter Registration Act (NVRA) and are not denoted as Code 9. DSS/HRA reported sending 3,091 applications to the Board of Elections during the reporting period, yielding a combined total of 6,839 City agency submissions to the Board of Elections. The total for the comparable period in 2021 was 3,710.

Some highlights and challenges of agency activities during the reporting period include:

1. The persistence of the COVID-19 pandemic continues to challenge in-person activities, including in-person voter registration activities by City agencies. As a result, City agencies have been focusing their voter registration-related activities through a combination of in-person, mail and online:
 - a. ACS set up voter registration drives at a few NYCHA houses and kept the dialogue open through virtual presentations and via social media platforms. They also expanded voter knowledge in youth detention centers as well as civic engagement programs and provider meetings. They are planning to invite local elected officials to address concerns to residents who did not think their vote would make a difference in their communities.
 - b. DOC distributed voter packets to all people in custody. Each packet included voter registration paperwork and absentee ballot request paperwork in both English and Spanish. The packets also included NYCCFB instructions for completing both forms, also in English and Spanish. The packets additionally included an instructional cover page, which listed the key election and registration deadlines, as well as voter eligibility criteria with specific information for incarcerated persons. The Department also partnered with the health provider in NYC jails, Correctional Health Service (CHS), to conduct on- unit engagement and assistance. Some voter-related in-person activities were cancelled due to the surge of the Omicron variant, however, efforts have been made for individuals in custody to mail-in all voting-related materials or to have them delivered by DOC staff.
 - c. DOT has taken the opportunity to send customers voter registration packets with every request via their Customer Service, Language Access and Correspondence Units and to 311 callers with DOT inquiries. DOT finds innovative ways to distribute VR packets but are unable to compel or verify completion.

- d. DPR distributes packages with recreation center memberships and are kept on display at various public-facing offices.
- e. TLC focused primarily on distributing registrations forms in hiring packets and at different sites. They also promote registration in bi-monthly newsletters, informational flyers and prominently posted the link on their website.

ACS distributes voter registration forms throughout ACS borough offices and youth-concentrated programs which includes the Nicholas Scopetta Children's Center (NSCC), which serves as youth's first point of contact with the Agency before they are placed with a foster family, kin, released home following court, or other foster care setting; Family Permancy Services (FPS) which ensures high quality services are provided to children in foster care; Housing Academy Collaborative (HAC) which supports youth in foster care in obtaining housing; and our Youth Reception Centers (YRC), a residential safe place for youth in foster care and service provider that includes independent living skills, education, employment, and financial literacy. We have also enlisted ACS Human Resources to support voter registration by placing forms in each new hire packet.

The Divisions of Administration and Child Welfare and Family Well- Being (CFWB), the Racial Equity and Cultural Competence Committee (RECC) and the African American Heritage Committee partnered with the Office of the NYC Public Advocate and the City University of New York for an interactive and intergenerational virtual discussion surrounding democracy, civic responsibility and the voting process. The dialogue also included:

- how Jim Crow laws suppressed the African American vote,
 - how the Voting Rights Act of 1965 protected voters by banning racial discrimination in voting practices,
 - the importance of increasing voter registration and civic engagements in your community.
- *nearly 100 staffers joined the event

ACS Website and Social Media Page: ACS' Intranet- based newsletter hosted content accessible to over 6,000 staff. The landing page served as a hub to provide resources promoting voter registration deadlines, voter education, and election information. Voter registration content was shared via the following methods:

- ACS Commissioner Public Service Announcement (PSA) - The PSA, featuring ACS commissioner, was shared via ACS social media platform (YouTube, ACS Intranet page, Twitter, Facebook) encouraging ACS Staff, partners, and stakeholders to register to vote, while providing guidance on how to vote safely. The PSA reached over 1,000 subscribers.
- ACS E- Bulletin - Early voting and election day reminders were sent out weekly, reaching over 6,000 employees.

Children's Center (CC) Voter Registration Workshop: ACS liased with NYC Votes and the NYC Campaign Finance Board (NYCCFB) to host several virtual interactive voter registration meetings with a focus on the youth demographic and how patterns in socioeconomics play a role in voter turnout in communities with higher incomes versus those living in low- income communities. Over 30 youth ages 15-21 participated in the workshop. During the presentation, the NSCC youth learned how to:

- support and obtain resources for their communities
- organize community events (beautification projects, vote registration drives, job fairs)
- use social media platforms to share information.
- contact local elected officials to insight change and other civic engagement.

ACS will continue to work with NYC Votes and NYCCFB to expand on voter knowledge and voter registration activities with the implementation and continuation of the following programs:

Prior to the November general election, the Department conducted in-person voter registration and absentee ballot registration drives throughout its facilities. Additionally, voter registration information was made available through weekly informational flyers distributed to the individuals in custody as well as voter educational posters which were placed in each housing area.

Describe challenges, both resolved and unresolved.

As per the past several reporting periods, conducting civic engagement and voting-related activities, especially those done in-person, remains a major challenge due to the ongoing global pandemic. The majority of in-person DOC programs and services resumed at the beginning of this reporting period only to be suspended again in December due to the surge of the Omicron variant in New York and around the world. In consideration of these ongoing challenges, the Department created and distributed

To ensure the Commission's staff can best address the needs of the public in a way that complies with health and safety guidance, the Commission schedules appointments to ensure we're best prepared for those meetings and encounters. During the COVID-19 pandemic, while the Commission has continued to primarily conduct its public facing engagement work remotely, consistent with Citywide policy, since the submission of the previous report, the Commission's Community Relations Bureau, has resumed its engagement and outreach work in-person. As a result, the Commission has been able to recommence the distribution of hard copy voter registration forms. Voter registration forms also remain available to the public at all five (5) Commission offices and at Commission events.

While working remotely, the Commission has and continues to develop digital distribution of these forms. For example, links to voting information are made available to the public on the Commission's website. In addition, links to voter registration information is also contained in a growing number of Commission communications to the public. Specifically, members of the public are informed of, and provided voter registration resources during virtual intakes, trainings, meetings, workshops, campaigns, and presentations.

Describe challenges, both resolved and unresolved.

Challenges noted in prior reports remain. The Commission continues to serve and reach thousands of individuals during the COVID-19 pandemic, both virtually and in-person. The Commission it is not able to track how many people who receive links to voter registration materials use them, analogous to the same challenges noted in prior reports to the distribution of hard copy voter registration forms which the public may use, but which are not submitted to the agency. Therefore, with specific regard to the latter, it is difficult to track the number of distributed voter registration forms that are ultimately submitted.

There are a number of factors that may determine the number of people served. They include the number of individuals in attendance at Commission workshops, presentations, and conferences, the number of intakes conducted by the Law Enforcement Bureau, and the number of those who use online resources to access the electronic voter registration form. It may also be determined by the event's location and proximity, virtual setting, technological platform, and type of event taking place, as well as the extent to which technology is accessible to the public. Although there has been a significant increase in the use of technology by the public, access to technology and electronic means of communication is still not completely widespread for a variety of reasons.

Another reality influencing the number of electronic voter registration forms that are submitted to the Board of Elections is the receiving population's eligibility to vote. Commission events are regularly frequented by individuals who may not be eligible to vote, which may depress the number of voter registration forms that are accessed, filled out, and ultimately submitted online.

Continuing to emphasize the importance of political engagement to the public across all channels may contribute to an increased number of distributions and submissions.

Describe how your agency distributes applications.

The TLC currently maintains a staff of approximately 600 employees, many of whom interface daily with TLC-Licensees. Voter registration forms are distributed in four separate ways to various TLC divisions and departments:

- **Human Resources** (located in Lower Manhattan) includes registration forms in hiring packets for new employees.
- **Policy/External Affairs** (located in Lower Manhattan) distributes voter registration forms at outreach events and presentations to Licensees and industry stakeholders across all 5 boroughs.
- **Licensing Division** (located in Long Island City, Queens) has forms available for visitors to take at its licensing transaction counters. Licensing maintains about 300 applications available for distribution at all times. Also, information on how to contact the Board of Elections is included on many TLC-issued forms for Licensees.
- **Safety + Emissions Division** (located in Woodside, Queens, and Staten Island) has forms available for distribution at its counter operations that Licensees must visit on a regular basis (ranging from three times a year to once every two years) for inspection of their vehicle.

By using these targeted strategies, TLC helps TLC-Licensees and incoming employees receive voter registration information.

COVID-19 continues to limit our in-person voter registration activities. However, voter registration and General Election information was shared multiple times with TLC-Licensees during the reporting period.

For National Voter Registration Day on September 28th, all TLC-Licensees received an email encouraging them to check their registration status and register to vote if eligible. TLC-Licensees were also informed of the October 8th registration deadline to be able to vote in the General Election. For Election Day on November 2nd, TLC-Licensees received an email encouraging them to vote and were provided with a link to look up the location of their poll site.

Voter registration and General Election information were also featured in our bi-monthly electronic newsletter Keys to the City. Our August issue mentioned the upcoming November election and encouraged TLC-Licensees to check their enrollment status and register to vote if eligible. Our October issue contained information pertaining to voting in the General Election, and informed TLC-Licensees of various voting methods including Early Voting and Election Day voting on November 2nd. TLC-Licensees were also provided with links to look up their poll site locations. Our Newsletters are posted on our website and can be viewed [here](#).

Additionally, COVID-19 limits our participation in public facing tabling events. Before COVID-19, Policy/External Affairs attended multiple public facing events where registration forms were made available to our licensees, as well as the general public.

Describe how your agency distributes applications.

DOT remains committed to registering voters during the Covid-19 pandemic. At the end of March 2020, due to Covid-19, DOT's public service centers (PSCs) closed. DOT will resume distribution of the voter registration packets as soon as the PSCs fully reopen. Prior to the pandemic, printed voter registration (VR) material was distributed. That was curtailed until Q3 of 2021, when DOT resumed mailing printed VR forms with all document requests. Since July 2020- October 30, 2021, DOT also included PDFs of VR packets emailed directly to customers. Now back in the office, :

- 1) The Customer Service, Language Access, and Correspondence Unit (CSLACU) includes hard copy VR packets with every literature request sent to customers.
- 2) DOT customers calling 311 are sent VR packets.
- 3) The DOT website has a "Register to Vote" icon/tile on its landing page. The hyperlink sends DOT customers directly to "NYC Votes".

Describe any special registration activities, if any.

Pre-Covid-19, DOT distributed voter registration materials at all DOT outreach events. DOT will resume this practice at expanded outreach events once it is safe to do so.

Describe challenges, both resolved and unresolved.

It is impossible for DOT to know which customers receiving the VR packets with their correspondence and/or documents, or visiting DOT's PSCs (when they reopen) are already registered to vote. DOT can readily disseminate the voter registration materials, but cannot compel customers to complete the forms and return them to the Board of Elections, or submit them to the PSC managers (when the PSCs reopen). If completed forms are not collected on-the-spot and sent to the BOE by the PSC managers, it is not possible to monitor and track the level of customer participation and the number of forms being returned to the Board of Elections.

DYCD partners with NYC Votes to encourage voter registration amongst participants in our programs, parents and families.

In addition, in direct response to the public outcry for the murder of George Floyd to the cancellation of SYEP, young people needed an outlet to be civically engaged and to move from marching to the electoral power of change. DYCD launched the We the YOUTH, You the People virtual town hall series which is a youth-led, developed, and driven platform for young people to discuss the issues that matter most to them. As a City agency that represents youth, we wanted to empower NYC youth and cultivate civic action. The pandemic coupled with civil unrest provided a unique opportunity to engage broadly with young people. The initiative is led by the We the YOUTH advisory council consisting of young people ages 14 – 24 from across New York City many of whom are not a participant of a DYCD-funded program. The Youth Town Hall is a vehicle to engage young people in meaningful dialogue

that will contribute to the development of a NYC Youth agenda to inform policy, practice and programs that engage and/or are created to support young people. Most importantly, we want to ensure that young people have a permanent seat at the table when decisions impacting them in NYC are being made.
