From 8 a. m. to 1 p. m. the fourth section shall for payment: patrol, third section in reserve and the first and second sections at home. From 1 to 6 p. m. the third section shall patrol, the fourth section in reserve, first and second sections at home. From 6 p. m. to 12 midnight the first and second sections shall patrol, third and fourth sections on reserve. From 12 midnight to 6 a. m. the third and fourth sections shall patrol, the second section in reserve and the first sec-

tion at home.

On the third day the second section begins the tour of patrol duty, the first, third and fourth sections being at home. From 8 a. m. to 1 p. m. the first section shall patrol, the second section in reserve, and the third and fourth sections at home. From I p. m. to 6 p. m. the second section shall patrol, the first section in reserve, the third and fourth sections at home. From 6 p. m. to 12 midnight the third and fourth sections shall patrol and the first and second sections in reserve. From 12 midnight to 6 a. m the first and second sections shall patrol, the fourth section in reserve and the third section at home.

On the fourth day the fourth section begins the tour of patrol duty, the first, second and third sections at home. From 8 a. m. to 1. p. m. the third section shall patrol, fourth section in reserve, the first and second sections at home. From I to 6 p. m. the fourth section shall patrol, third section in reserve and the first and second sections at home. From 6 p. m. to 12 midnight the first and second sections shall patrol, third and fourth sections in reserve. From 12 midnight to 6 a. m. the third and fourth sections shall patrol, the first section in reserve and the second section

On the fifth day the tours shall recommence as above. This schedule gives thirty-six hours patrol, twenty-eight hours reserve and thirty-two hours at home for

Captains will at once divide their forces into two platoons and four sections as above provided, and under directions of the Inspectors of their districts, divide their precincts into day and night posts or beats and number the same, and from time to

time designate the patrolmen who are to patrol the same.
