COMMISSIONERS OF THE SINKING FUND.

Abstract of the Proceedings of the Commissioners of the Sinking Fund at the meeting held, pursuant to adjournment, December 29, 1879.

Present—Hon. Edward Cooper, Mayor (Chairman); Hon. John Kelly, Comptroller; J. Nelson Tappan, Esq., Chamberlain; and Nicholas Haughton, Esq., Chairman Finance Committee Board of Aldermen.

The minutes of the meetings held December 4 and 27, 1879, were read and approved.

The Mayor, on behalf of the Committee appointed at the last meeting to prepare appropriate resolutions in relation to the death of the Hon. John K. Hackett, Recorder, and late a member of this Board, submitted the following preamble and resolutions, which, on motion, were unanimously adopted, viz.:

Whereas, By the death of the Hon. John K. Hackett, the Recorder of this city, on Friday, the 26th instant, the Board of Commissioners of the Sinking Fund has lost a member, who, since 1866, has faithfully and efficiently performed the duties of his office; and

Whereas, We desire to place upon record our high appreciation of the sterling qualities of our late associate as a public officer, and our recognition of his faithful services to the City of New York; therefore be it

Resolved, That we deeply regret the death of our late associate, and that we tender to his widow and family our heartfelt sympathy and condolence in their bereavement and affliction.

Resolved, That, as a mark of our respect for the memory of the deceased, the Commissioners of the Sinking Fund will attend the funeral in a body, at 10 o'clock A. M. to-morrow.

Resolved, That the Secretary of this Board be directed to transmit to the widow of the deceased a copy of these resolutions, and that they be entered in full on the minutes.

The Comptroller submitted the petition of Antoinette E. Wood, for deed of confirmation or release of two lots of ground, located on the north side of East Sixty-seventh street, 125 feet east of Madison avenue. Whereupon the following resolution, submitted by the Comptroller, was, on motion, adopted, viz.:

Resolved, That the petition of Antoinette E. Wood, for deed of confirmation or release of two lots of ground, located on the north side of East Sixty-seventh street, 125 feet east of Madison avenue, purchased of the Corporation at the sale by auction in 1867, be referred to the Counsel to the Corporation, to prepare such deed or release as the facts of the case may warrant and require, and that the Mayor and Clerk of the Common Council be authorized to execute such deed or release, when so prepared, on behalf of the Mayor, Aldermen, and Commonalty of the City of New York, and that the Comptroller be authorized to deliver such deed or release, when duly executed, to Antoinette E. Wood.

The petition of Anderson Fowler, for a confirmatory deed of premises No. 41 East Sixty-seventh street, 100 feet west of Park avenue, was received, and, on motion, referred to the Comptroller.

The Comptroller submitted the following report in relation to the payment of bonds of the City of New York, due January 10, 1880:

CITY OF NEW YORK—DEPARTMENT OF FINANCE,
COMPTROLLER'S OFFICE, December 27, 1879. }

To the Commissioners of the Sinking Fund:

GENTLEMEN—On January 10, 1880, bonds of the Mayor, Aldermen, and Commonalty of the City of New York, authorized by chapter 429, Laws of 1876, "to provide for payment for the use and occupation of armories and drill-rooms in the City of New York," become due and payable, amounting to the sum of two hundred and thirty-three thousand, four hundred and eighty-three dollars (\$233,483).

The payment and redemption of these bonds, are provided for by chapter 383, of the Laws of 1878, from the Sinking Fund, and I submit herewith a resolution for that purpose.

The report was accepted, and, on motion, the following resolution, submitted with the report, was adopted, viz.:

Resolved, That the Commissioners of the Sinking Fund hereby authorize and direct the payment, from "The Sinking Fund for the Redemption of the City Debt," of the following bonds, which fall due January 10, 1880, to wit:

Bonds of the Mayor, Aldermen, and Commonalty of the City of New York, authorized by chapter 429, Laws of 1876, to provide for payment for the use and occupation of armories and drill-rooms in the City of New York..... \$233,483 00

The Comptroller submitted the following report in relation to premises Nos. 19 and 21 Elizabeth street, viz.:

CITY OF NEW YORK—FINANCE DEPARTMENT,
COMPTROLLER'S OFFICE, December 23, 1879. }

To the Commissioners of the Sinking Fund:

GENTLEMEN—The Comptroller, to whom was referred the notice from the Collector of City Revenue of the expiration of the lease, on the 20th instant, of the premises Nos. 19 and 21 Elizabeth street, having examined the subject, respectfully recommends that the late lessee, John D. Keyes, be authorized to occupy the said premises until the 1st of May, 1880, at the same rent (\$800 per annum) as paid under the lease just expired.

On motion of the Mayor, the report was accepted and the recommendation adopted.

The application of James B. Smith, Producers & Co., to be refunded the amount overpaid on account of street vault at No. 42 East Fourteenth street, was received, and, on motion, the following resolution, submitted by the Mayor, was adopted, viz.:

Resolved, That a warrant be drawn against the Sinking Fund for redemption of the city debt, in favor of James B. Smith, Producers & Co., for forty-nine dollars and sixty-nine cents (\$49.69), refunding them this amount overpaid on street vault, No. 42 East Fourteenth street, as per certificates and vouchers herewith.

The Comptroller moved to take up for consideration the motion submitted by him at the meeting held July 23, 1879, and laid upon the table: "That the agreement, drawn by the Counsel to the Corporation, between the Mayor, Aldermen, and Commonalty of the City of New York and Francis B. Spinola and associates be approved and referred to the Comptroller to be executed;" which was adopted, the Comptroller, Chamberlain, and Chairman Finance Committee Board of Aldermen voting in the affirmative, and the Mayor in the negative.

The vote was then taken on the motion—"That the agreement, drawn by the Counsel to the Corporation, between the Mayor, Aldermen, and Commonalty of the City of New York and Francis B. Spinola and associates, be approved and referred to the Comptroller to be executed"—which was adopted, the Comptroller, Chamberlain and Chairman Finance Committee Board of Aldermen voting in the affirmative, and the Mayor in the negative.

The following resolution, laid over for consideration at the meeting held October 24, 1879, was taken up for action, and, on motion of the Comptroller, unanimously adopted, viz.:

Resolved, That a warrant be drawn in favor of the Chamberlain, on account of "The Sinking Fund for the payment of interest on the city debt," for the sum of \$107,922.47, being the cash balance, as appears by the report of the Comptroller, submitted to the Commissioners of the Sinking Fund on this date, in said fund on December 31, 1878, transferring the same to the General Fund, under the provisions of chapter 163 of the Laws of 1862.

Communication from Frederick Unbekant, Colonel commanding 11th Regiment Infantry, N. Y. S. N. G., was received, in relation to the necessity of alterations of and additions to the armory of the said regiment, which, on motion, was referred to the Comptroller.

Notice in relation to premises No. 115 Christopher street, bought by the Corporation at a foreclosure of mortgage sale, was received, and, on motion, referred to the Comptroller.

On motion, adjourned to Tuesday, January 6, 1880, at 2 o'clock P. M.

The minutes of the meetings held November 28, December 2 and 3, 1879, were read and approved.

A communication was received from the Engineer-in-Chief, as to the amount of material removed in scows belonging to this Department for dredging slips, etc.; and, being read,

On motion, the following resolutions were adopted:

Resolved, That the Treasurer be and is hereby authorized and directed to prepare a statement of claim in the sum of \$69.24, and present the same to Chandler H. Loomis for payment, being for use of scows of the Department in removing, from November 1 to 30, 1879, 3,462 cubic yards of material dredged by him under contract of 18th June, 1879, with this Department, at two cents per cubic yard.

Resolved, That the Treasurer be and is hereby authorized and directed to prepare a statement of claim in the sum of \$215.20, and present the same to the Union Dredging Co. for payment, being for use of scows of the Department, in removing from November 1 to 30, 1879, 10,760 cubic yards of material dredged by the Company under orders of the Treasurer of this Department, at two cents per cubic yard.

On motion, laid on the table to await action as stated, to wit:

From John Fagan—In reference to his occupancy of water front at the foot of Sixty-second street, East river. Applicant requested to call upon the Commissioners in reference to the subject.

From N. Y., Lake Erie & Western R. R. Co., lessee—For permission to erect a shed on Pier, new 20, North river. Referred to the Engineer-in-Chief to examine and report on the plans of the structure submitted by said Company.

From Knickerbocker Ice Co., lessee—For permission to erect platform at south side of pier at Twentieth street, North river, to facilitate the landing of ice. Applicant requested to file in this office the consent of the Harbor Master of the District to the erection of the proposed platform.

From Old Dominion S. S. Co., lessee—For permission to erect shed on Pier, new 26, North river. Engineer-in-Chief directed to examine and report on the plans of the proposed structure submitted by said Company.

From H. L. Morris and E. A. Galindo—For permission to erect dock on east side of Harlem river, adjacent to One Hundred and Fiftieth street. Engineer-in-Chief directed to examine and report if any objection exists to a pier being built at that point.

From Engineer-in-Chief—As to work performed during week ending December 6, 1879.

To the Board of Estimate and Apportionment:

In pursuance of the provisions of section 8 of chapter 383 of the Laws of 1878, the Comptroller hereby certifies to the Board of Estimate and Apportionment that the sum of sixty-three thousand two hundred and twelve dollars and thirteen cents is the sum to be included in the annual estimate for the year 1880, which, with the sum to be included in the annual estimate each year thereafter, is sufficient with the accumulation of interest thereon, to meet and discharge the amount of the bonds and stocks payable from taxation, other than revenue bonds, issued after the third day of June, 1878, the date of the passage of said act, "by the time they shall be payable," as therein provided, and as shown by statement of the same herewith submitted.

To the Board of Estimate and Apportionment:

Upon examination of the claim of Walter R. Marvin and Willis B. Marvin against the city for rent of premises at No. 262 Broadway, owned by them and occupied by the Attorney for the Collection of Arrears of Personal Taxes, from the 9th day of September, 1872, to the 1st day of May, 1874, as provided by chapter 498, Laws of 1879. I find, and hereby certify to the Board of Estimate and Apportionment, the amount due to be the sum \$2,420.20, which amount is to be appropriated and raised by the tax in 1880, to be applied to the payment of said claim.

The Board proceeded to consider the Final Estimate for 1880.

The Comptroller moved that the sum of \$16,800 be allowed under the title "Claims payable under special Acts of the Legislature," to meet the claim of John Hogan, under chapter 495, Laws of 1879, subject to investigation and adjustment by the Comptroller. Also, the sum of \$2,420.20, to meet the claim of Walter R. Marvin and Willis B. Marvin, under chapter 498, Laws of 1879.

Which was agreed to.

The Comptroller moved that the sum of \$1,563.63 be allowed under title of "Claim of estate of William Walsh, formerly County Clerk." Amount appropriated to meet the claim of Rev. P. J. Martin, executor of estate of William Walsh, against the city, subject to investigation and adjustment by the Comptroller.

Which was agreed to.

The Board took up the Estimate of the Department of Public Works for consideration.

The Chairman moved that the items "Aqueduct—Repairs and Maintenance," and "Strengthening Croton Aqueduct," be consolidated under the head of "Aqueduct—Repairs and Maintenance, and Strengthening."

Which was agreed to.

The various items were unanimously agreed to, except as follows, viz.:

The Chairman moved that the sum of \$4,000 be allowed for "Removing obstructions in streets and avenues."

The Comptroller moved to amend, by substituting the sum of \$3,000.

The amendment was agreed to.

The question was then taken on the original proposition, as amended.

Which was agreed to.

The Chairman moved that the sum of \$91,000 be allowed for "Repairing and Renewal of Pipes, Stop-cocks, etc."

Which was lost, by the following vote, viz.:

Affirmative—The Mayor and the President of the Board of Aldermen—2.

Negative—The Comptroller and the President of the Department of Taxes and Assessments—2.

The President of the Board of Aldermen then moved that the sum of \$81,000 be allowed for the said purpose.

Which was lost, by the following vote, viz.:

Affirmative—The Mayor and the President of the Board of Aldermen—2.

Negative—The Comptroller and the President of the Department of Taxes and Assessments—2.

The President of the Board of Aldermen then moved that the sum of \$75,000 be allowed for the said purpose.

Which was agreed to by the following vote, viz.:

Affirmative—The Comptroller, the President of the Board of Aldermen, and the President of the Department of Taxes and Assessments—3.

Negative—The Mayor—1.

The Chairman moved that the sum of \$60,000 be allowed for "Sewers—Repairing and Cleaning."

Which was lost by the following vote, viz.:

Affirmative—The Mayor—1.

Negative—The Comptroller, the President of the Board of Aldermen, and the President of the Department of Taxes and Assessments—3.

The President of the Department of Taxes and Assessments then moved that the sum of \$53,200 be allowed for the said purpose.

Which was agreed to by the following vote, viz.:

Affirmative—The Comptroller, the President of the Board of Aldermen, and the President of the Department of Taxes and Assessments—3.

Negative—The Mayor—1.

The Chairman moved that the sum of \$5,000 be allowed for "Street Improvements, for Surveying, Monumenting, and Numbering Streets."

The Comptroller moved to amend by substituting the sum of \$2,500.

The amendment was lost by the following vote, viz.:

Affirmative—The Comptroller and the President of the Department of Taxes and Assessments—2.

Negative—The Mayor and the President of the Board of Aldermen—2.

The President of the Board of Aldermen then moved that the sum of \$3,000 be allowed for the said purpose.

Which was agreed to by the following vote, viz.:

Affirmative—The Comptroller, the President of the Board of Aldermen, and the President of the Department of Taxes and Assessments—3.

Negative—The Mayor—1.

The Board then took up the estimate for the Department of Public Parks for consideration.

The Comptroller moved that the item "Maintenance and Government of Parks and Places—For Salaries," be inserted to read the same as last year.

The Chairman moved to amend by striking out the words "and also excepting the Superintendent and Engineer in Charge of Public Places, Roads, Avenues and Bridges, Twenty-third and Twenty-fourth Wards."

The amendment was lost by the following vote, viz.:

Affirmative—The Mayor—1.

Negative—The Comptroller, the President of the Board of Aldermen, and the President of the Department of Taxes and Assessments—3.

The question was then taken on the original proposition.

Which was agreed to.

The Chairman moved that the item "Maintenance Twenty-third and Twenty-fourth Wards" be inserted as follows:

"For the Maintenance and Government of Public Places, Roads, and Avenues in the Twenty-

third and Twenty-fourth Wards, including Supplies and Wages of Foremen, Mechanics, Laborers, Carts and Teams, and all persons employed in the work."

Which was lost by the following vote, viz.:

Affirmative—The Mayor and the President of the Board of Aldermen—2.

Negative—The Comptroller and the President of the Department of Taxes and Assessments—2.

The Chairman moved that the sum of \$15,000 be allowed for "Laying New and Repairing Old Walks in City Parks."

Which was lost by the following vote, viz.:

Affirmative—The Mayor and the President of the Board of Aldermen—2.

Negative—The Comptroller and the President of the Department of Taxes and Assessments—2.

The Chairman moved that the sum of \$20,000 be allowed for "Laying New and Repairing Old Walks in Central Park."

Which was lost by the following vote, viz.:

Affirmative—The Mayor and the President of the Board of Aldermen—2.

Negative—The Comptroller and the President of the Department of Taxes and Assessments—2.

The Chairman moved that the sum of \$20,000 be allowed for "Laying New and Repairing Old Walks in City Parks."

Which was lost by the following vote, viz.:

Affirmative—The Mayor and the President of the Board of Aldermen—2.

Negative—The Comptroller and the President of the Department of Taxes and Assessments—2.

The Chairman moved that the sum of \$25,000 be allowed for "Laying New and repairing Old Walks in Central Park."

Which was lost by the following vote, viz.:

Affirmative—The Mayor and the President of the Board of Aldermen—2.

Negative—The Comptroller and the President of the Department of Taxes and Assessments—2.

The Board then took up the Estimate for the Department of Buildings for consideration.

The Chairman moved that the sum of \$50,000 be allowed for "Salaries and Contingencies—Department of Buildings."

Which was lost by the following vote, viz.:

Affirmative—The Mayor and the President of the Board of Aldermen—2.

Negative—The Comptroller and the President of the Department of Taxes and Assessments—2.

The President of the Department of Taxes and Assessments moved that the sum of \$71,500 be allowed for the purpose.

Which was lost by the following vote, viz.:

Affirmative—The Comptroller and the President of the Department of Taxes and Assessments—2.

Negative—The Mayor and the President of the Board of Aldermen—2.

The estimate was then laid over, and upon being taken up, the Comptroller moved that the sum of \$71,500 be allowed for the purpose.

Negative—The Mayor and the President of the Board of Aldermen—2.

The Chairman then moved that the sum of \$55,000 be allowed for the said purpose.

GENTLEMEN—At a meeting of the Board of Police, held this day, it was

Resolved, That the resolution of the Board of Police, passed December 19, 1879, requesting the Board of Estimate and Apportionment to transfer the sum of \$360.52 from the appropriation made to the Police Department for the year 1878, entitled "Police Fund," to the appropriation for the year 1879, entitled "Contingent Expenses," be and is hereby rescinded, and in place thereof, be it

The President of the Board of Aldermen moved that the sum of \$400,000 be allowed for the said purpose.

Which was lost by the following vote, viz.:

Affirmative—The Mayor and the President of the Board of Aldermen—2.

The Chairman then moved that the sum of \$350,000 be allowed for the purpose.

The Comptroller moved that the sum of \$300,000 be allowed for the purpose.

The Comptroller moved that the sum of \$296.50 be allowed for deficiency in amount for compensation of extra stenographers in Superior Court.

Affirmative—The Mayor of the City of New York (Chairman), the Comptroller of the City of New York, the President of the Board of Aldermen, and the President of the Department of Taxes and Assessments—4.

The Chairman put the question whether the Board would agree to overrule the action of the Board of Aldermen on the following items:

Fire Department—Bureau of Chief of Department Pay-roll, increased from \$32,700 to \$37,700.

Common Council—Salaries of Clerks and Officers of the Board of Aldermen, increased from \$16,200 to \$18,000.

Which was decided in the affirmative by the following vote, viz.:

Affirmative—The Mayor of the City of New York (Chairman), the Comptroller of the City of New York, the President of the Board of Aldermen, and the President of the Department of Taxes and Assessments—4.

The Comptroller offered for adoption the following preamble, resolution, and Final Estimate for the support of the City Government for the year 1880:

Whereas, The Board of Estimate and Apportionment have considered the objections to, and rectifications of, the Provisional Estimate made by said Board on the 31st day of October, 1879, of the amounts required to pay the expenses of conducting the public business of the City and County of New York, in each Department and branch thereof, and the Board of Education, for the next ensuing financial year, to wit, for the year eighteen hundred and eighty (1880); in which estimate is included such sum as is necessary for the payment of the interest on the bonds of the said city and county, which become due and payable within said year, and also such sum as is necessary to be raised by tax to pay the principal of any bonds and stocks which become due and payable during the said year; also the amount to be raised by tax annually, which will be sufficient, with the accumulations of interest thereon, to pay the bonds and stocks, payable from taxation, issued after June 3, 1878, pursuant to chapter 383, Laws of 1878; and also so much as may be necessary to pay the proportion of the State tax required to be paid by the City and County of New York, in said year, which objections to, and rectifications of, said Provisional Estimate made by the Board of Aldermen, were transmitted by the Clerk of said Board, under date of November 25, 1879, and presented to the Board of Estimate and Apportionment on November 26, 1879; therefore

Resolved, That after such consideration of the said objections to, and rectifications of, said Provisional Estimate, the Board of Estimate and Apportionment does hereby make this a
