

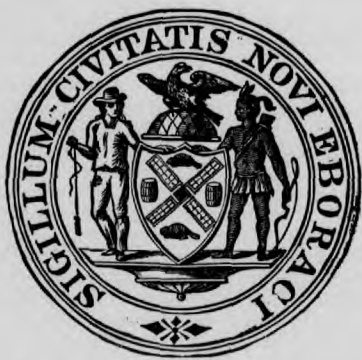

DEPARTMENT OF DOCKS.

An adjourned meeting of the Board of Docks of the City of New York, held at the office of the Board, Pier "A," Battery place, Tuesday, July 22, 1890.

Present—President Post.

“ Commissioner Matthews.

“ Cram.

Mr. Forget, General Agent of the Compagnie Generale Transatlantique, submitted a written proposition, dated 18th day of July, 1890, requesting a lease of Pier, new 42, North river, for ten years, with an option of an additional ten years, to which written proposition reference is hereby made.

On motion, the question of the annual rental of the pier as it now stands, and of the pier if extended, was referred to President Post to examine and report.

The location designated for the free swimming bath, foot of Thirty-fourth street, North river, June 26, 1890, was changed to the south side of Pier, new 59, foot of West Twenty-ninth street.

The report of the Engineer-in-Chief on Secretary's Order No. 10248, respecting the condition of the bulkhead between Piers 47 and 48, East river, was,

Upon motion, tabled.

The following communications were received, read, and,

On motion, ordered to be placed on file, action being taken where necessary, as stated, to wit:

From Commissioner of Street Cleaning—Reporting that the matter of cleaning the bulkhead from Seventy-seventh to Eightieth street, North river, has been referred to their Superintendent for immediate action.

From the Finance Department—Returning the proposal of the Morris & Cumings Dredging Company, for dredging at Forty-sixth and Fifty-first streets, North river, under Contract No. 340, with his approval of the adequacy and sufficiency of the sureties thereto.

From the Counsel to the Corporation—Approving specifications and form of contract for building a Pier foot of Fifty-second street, North river.

From the New York City Civil Service Boards:

1st. Inclosing examination papers of James Weir and Louis S. Kellogg, clerks, and requesting a rating thereon. The action of the Secretary in complying with said request approved.

2d. Reporting that James Weir and Louis S. Kellogg passed the prescribed examination and are therefore eligible for promotion.

From William Kelly—Requesting permission to unload sand temporarily on the bulkhead between Piers 47 and 48, East river. The action of the President and Commissioner Matthews in issuing a permit approved.

From Scott & Co.—Requesting permission to dredge in front of the bulkhead, between Thirty-fourth and Thirty-fifth streets, North river. The action of the President in issuing a permit approved.

From National Line of Steamships—Complaining that the bulkhead north and south of Pier, new 39, North river, is constantly blocked with brick barges, coal and lumber boats, and requesting relief. The action of Commissioner Cram in directing the Dock Master to see that the rights of the said company are in no way interfered with was approved.

From C. H. Mallory & Co.—Complaining of obstructions in the slip between Piers 19 and 20, East river. The action of the President in directing the Dock Master to afford them every facility possible was approved.

From Stephen A. Walker, attorney—Desiring to be informed if there is any objection to the Messrs. Cornell using that portion of the bulkhead between Piers, new 56 and 57, North river, adjacent to the former pier, at regular wharfage rates, until they are placed in possession of the bulkhead between said piers. Permit granted, to continue only during the pleasure of the Board, provided the use of said bulkhead does not interfere with the work of this Department.

From Hoadly, Lauterbach & Johnson, attorneys for the Pacific Mail Steamship Company—Requesting that the American Surety Company be substituted as surety on their lease in lieu of the bond heretofore given by said company. Referred to the Treasurer with power.

From Lehigh Valley Railroad Company—In reference to the widening, extending and repairing of Pier, old 56, North river, and extending temporary bulkhead on the north side of said pier. Referred to the Engineer-in-Chief to examine and report.

From J. Wesley Smith—Requesting a berth on the North river between West Eleventh and Fortieth streets, for the purpose of discharging ice. Referred to the Dock Masters of the respective districts to examine and report.

From Dockmaster Abeel—Reporting that the lighter "Mary" capsized in the slip between Piers, new 39 and 40, North river, with a cargo of soda ash on board. The action of the President in directing the owners to remove said boat and cargo was approved.

From Health Department—Inclosing report of Sanitary Inspector Hosmer respecting the condition of the premises at Second avenue and Harlem river, and requesting the construction of a urinal thereat. The Secretary directed to state that this Department is not authorized to expend money for such purpose.

From Thomas Smith, Jr., and Gustave L. Seager, sureties on lease of Brian G. Hughes, of Pier at One Hundred and Seventeenth street, Harlem river—Consenting to the assignment of said lease to John H. McCarty. The Secretary directed to file the aforesaid consent with the lease.

From the Engineer-in-Chief:

1st. In reference to the washing away of the filling behind the crib-bulkhead, between One Hundred and Twenty-ninth and One Hundred and Thirtieth streets, North river. The Engineer-in-Chief directed to level off said filling as recommended.

2d. In reference to the bulkhead foot of One Hundred and Thirty-fourth street, North river, and reporting that if a new pier is to be built thereat it will become necessary to terminate the rights of John A. Bouker as provided in his lease; whereupon the following preambles and resolution were adopted:

"Whereas, This Board, on the 17th day of April, 1890, leased at public auction to John A. Bouker the right to collect all wharfage which should arise, accrue or become due for the use and occupation, during the term of three years, from the first day of May, 1890, of all that certain wharf property known and described as the bulkhead at the foot of West One Hundred and Thirty-fourth street, North river; and

"Whereas, The rental therefor has been paid to this Department up to the first day of August, 1890; and

"Whereas, This Board has determined to proceed with the work of building a new pier at West One Hundred and Thirty-fourth street, on the North river, which renders it necessary to terminate the interest of the said John A. Bouker in the wharfage to arise, accrue or become due from the said wharf property or any part thereof; therefore,

"Resolved, That, in accordance with the terms and conditions of the lease aforesaid, the said lease is hereby canceled and annulled, to take effect August 1, 1890."

3d. Recommending the painting of Dock Master's office, at Pier, new 43, North river. Recommendation adopted.

4th. Reporting that he had directed that Laborer Acting Watchman Otto Junkerman be not again assigned to duty as Acting Watchman, and recommending that his action be approved.

On motion, the Engineer-in-Chief was directed not to assign the said Junkerman to perform duty as Acting Watchman for a period of thirty days.

5th. Report on Secretary's Order No. 10251, as to dredging required between Piers 56 and 57, East river. The Engineer-in-Chief directed to make requisition for dredging thereat to the extent of about four thousand eight hundred cubic yards.

6th. Report on Secretary's Order No. 10261, as to the condition of Pier foot of Eighty-sixth street, East river. The Engineer-in-Chief directed to repair.

7th. Report on Secretary's Order No. 10273, as to the condition of Pier, new 59, North river. The Engineer-in-Chief directed to repair.

8th. Report on Secretary's Order No. 10211, respecting the application of James Smith for permit to erect a watchman's house on shore end of Pier 55, East river. Permit granted, to remain only during the pleasure of the Board.

9th. Report on Secretary's Order No. 9576, submitting plans, specifications and form of contract for building pier and bulkhead at One Hundred and Thirty-third street, North river.

On motion, ordered to be placed on file, and the following resolution adopted:

Resolved, That the plans, specifications and form of contract, as prepared and submitted by the Engineer-in-Chief of this Department, for building a Pier at the foot of One Hundred and Thirty-third street, North river, two hundred feet long, and a crib-bulkhead from West One Hundred and Thirty-second to West One Hundred and Thirty-third street, North river, be and hereby are approved, subject to the approval of the Counsel to the Corporation as to form, and the Secretary be and hereby is directed to have a sufficient number of blank forms of proposals printed and proper advertisements, inviting estimates for doing the said work, inserted in the various newspapers designated by law.

Commissioner Matthews, to whom was referred the subject matter respecting the compensation to be charged the Mutual Benefit Ice Company for berth at the north side of Pier 61, East river, with the privilege of erecting a temporary platform thereat, reported that he had fixed the amount of rental at seventy-five dollars per month, commencing Thursday, July 17, 1890, payable monthly, when due, to the Dock Master of the district, and to continue only during the pleasure of the Board.

On motion, said action was approved, and the Board adjourned.

Commissioner Cram, to whom was referred the recommendation of the Engineer-in-Chief that Hugh Daly, John R. Grant, Daniel McLaughlin, and John McNamara, carpenters, be made ship carpenters, reported favorably thereon.

Upon motion, report was received and approved and the individuals named promoted to ship carpenters, to take effect July 26, 1890.

In the absence of the President Commissioner Cram acted as President pro tem.

The Board met for the purpose of receiving estimates for dredging on the North and East rivers, under Contracts Nos. 330 and 343, and for repairing Pier at Twenty-fourth street, East river, under Contract No. 332, advertised to be opened this day at 12 o'clock M., a representative of the Comptroller being present.

Two estimates were received for dredging at the following-named places on the North and East rivers:

North river—Canal street dumping-board, dumping-board at West Nineteenth street.

East river—Dumping-board at Pier 12, dumping-board at Pier 44, slip between Piers 51 and 52, dumping-board at East Seventeenth street, dumping-board at East Twenty-second street, under Contract No. 330.

Resolved, That the contract opened this day for removing certain portions of and for repairing the one hundred and forty feet of the old wooden pier and for building complete the inner length of the Pier foot of East Twenty-fourth street, East river, be and hereby is awarded to John Gillies, he being the lowest bidder, upon the approval of the sureties by the Comptroller.

Resolved, That the contract opened this day for dredging for a new pier at foot of West Forty-ninth street, on the North river, be and hereby is awarded to the North American Dredging and Improvement Company, they being the lowest bidders, upon the approval of the sureties by the Comptroller.

On motion, the Board adjourned.

GENTLEMEN—It seems to me that the requisitions herewith submitted should be approved.

The annual report of the Comptroller, referred to in his requisition, shows the operations of the Finance Department throughout the year 1889 and the condition of the city's treasury at the opening of 1890. Without such a report the public would be involved in doubt respecting the city's financial condition at the close of the year inasmuch as the law specifically provides only for reports to be made by the Comptroller and the Commissioners of Accounts for periods ending respectively in September and November.

The two other requisitions from the Finance Department are for articles necessary to its operation, and of which you were informed by the general requisition approved by you last December.

1st. Report on Secretary's Order No. 10256, submitting report of cement tested for Erskine W. Fisher. The Secretary directed to send Mr. Fisher a copy of said test.

2d. Report on Secretary's Orders Nos. 10255, 10257, 9566, 10269, 10194, 10187 and 10137, that he had superintended laying a sewer-pipe from Seventy-seventh street and Twelfth avenue into the North river, the replacing of piles at Piers 16 and 17, East river, dredging under inner end of pier and driving piles at East Eleventh street, repairing ferry-rack at East Twenty-third street, and he laying of a section of pipe from the East river across the roadway between Fifty-first and Fifty-second streets, East river, and repairing Pier 48, East river.

3d. Report on Secretary's Orders Nos. 10272, 10233, 10147, 10229 and 10017, that he had removed fence between Twenty-fifth and Twenty-sixth streets, North river, and repaired deck of Pier at West Forty-seventh street, and Piers 56 and 62, East river.

The Treasurer, Commissioner Matthews, reported that he had received the following estimates for furnishing this Department with about four hundred and ten sound and straight white pine, yellow pine, Norway pine, cypress or spruce piles, eighty to eighty-five feet long :

The action of Commissioner Matthews in awarding the order to Beard & Kimpland, they being the lowest bidders, was approved.

Whereas, by section 715 of chapter 410 of the Laws of 1882, the Board of the Department of Docks of the City of New York, is authorized to acquire for purchase in the name and for the benefit of the Corporation of the City of New York, wharf property in said city, and all rights, terms, easements and privileges pertaining thereto, subject to the approval of the Commissioners of the Sinking Fund, and agree with such owners upon a price for the same, and in case of failure to agree upon a price for the same to initiate legal proceedings to acquire the same for the improvement of the water-front of said city; and

Whereas, This Department is desirous of acquiring, in the name and for the benefit of the Corporation of the City of New York, all right, title and interest in and to the land, land under water and bulkhead rights between the southerly line of Twenty-sixth street and the centre line of the block between West Twenty-fifth and West Twenty-sixth streets, lying westerly of Thirteenth avenue; including the bulkhead westerly thereof on the Hudson river, and riparian rights and privileges and the easement to collect wharfage and cranaqe at said bulkhead; and

Whereas, It appears that Stephen A. Walker is attorney in fact of those who are now seized of the premises conveyed by grant by the Mayor, Aldermen and Commonalty of the City of New York to Thomas Williams, Isaac E. Smith and Ichabod S. Williams, dated the 2d day of December, 1858:

Resolved, That this Board offers to purchase the said premises and pay for a good and sufficient title therefor, to be approved by the Counsel to the Corporation of the City of New York, the sum of sixty thousand (60,000) dollars, subject to the approval of the Commissioners of the Sinking Fund, as provided by law; provided, **however**, that the owner or owners, representative or representatives of the parties in interest, or the parties duly authorized so to do, execute and deliver a release under seal to the Mayor, Aldermen and Commonalty of the City of New York, releasing and discharging the said city of and from all damages and claims whatsoever.

Resolved, further, That a copy of these preambles and resolutions be served upon Stephen A. Walker, attorney for the owners of the above-described premises, and he be and hereby is requested within ten (10) days from receipt thereof to notify this Board in writing whether the said owners will sell their respective rights and interests as aforesaid in the said premises to the Mayor, Aldermen and Commonalty of the City of New York for the price above mentioned; and in the event that he shall fail to notify this Board of his willingness to so convey their respective rights and interests as aforesaid, it shall be deemed that no price can be agreed upon for the said premises between the owners thereof and this Department.

Those entitled to exemption are: Clergymen, lawyers, physicians, surgeons, surgeon-dentists, professors or teachers in a college, academy or public school, licensed pharmacists or druggists, actually engaged in their respective professions and not following any other calling; militiamen, policemen, and firemen; election officers, jury non-residents, and city employees, and United States employees; officers of vessels making regular trips; licensed pilots, actually following that calling; superintendents, conductors and engineers of a railroad company other than a street railroad company; telegraph operators actually doing duty as such; Grand, Sheriff's, and Civil Court jurors; stationary engineers; and persons physically incapable of performing jury duty by reason of severe sickness, deafness, or other physical disorder.

Those who have not answered as to their liability, or proved permanent exemption, will receive a "jury enrollment notice," requiring them to appear before me this year. Whether liable or not, such notices must be answered (in person, if possible), and at this office only, under severe penalties. If exempt, the party must bring proof of exemption; if liable, he must also answer in person, giving full and correct name, residence, etc., etc. No attention paid to letters.

Persons "enrolled" as liable must serve when called or pay their fines. No mere excuse will be allowed or interference permitted. The fines, if unpaid, will be entered as judgments upon the property of the delinquents. All good citizens will aid the course of justice, and secure reliable and respectable juries, and equalize their duty by serving promptly when summoned, allowing

their clerks or subordinates to serve reporting to me any attempt at bribery or evasion, and suggesting names for enrollment. Persons between sixty and seventy years of age, summer absentees, persons temporarily ill, and United States jurors, are not exempt.

No. 6. FOR REGULATING AND GRADING ONE HUNDRED AND SIXTY-FIFTH STREET, from Eleventh avenue to Boulevard, and SETTING CURB-STONES AND FLAGGING SIDEWALKS THEREIN.

No. 7. FOR REGULATING AND GRADING A NEW STREET, from One Hundred and Sixty-fifth street to bulkhead, and SETTING CURB-STONES AND FLAGGING SIDEWALKS THEREIN.

Each estimate must contain the name and place of residence of the person making the same, the names of all persons interested with him therein, and if no other person be so interested it shall distinctly state that fact. That it is made without any connection with any other person making an estimate for the same work, and is in all respects fair and without collusion or fraud. That no member of the Common Council, head of a department, chief of a bureau, deputy thereof, or clerk therein, or other officer of the Corporation, is directly or indirectly interested in the estimate or in the work to which it relates or in the profits thereof.

Each estimate must be verified by the oath, in writing, of the party making the same, that the several matters therein stated are true, and must be accompanied by the consent, in writing, of two householders or freeholders in the City of New York, to the effect that if the contract is awarded to the person making the estimate, they will, upon its being so awarded, become bound as his sureties for his faithful performance; and that if he shall refuse or neglect to execute the same, they will pay to the Corporation any difference between the sum to which he would be entitled upon its completion, and that which the Corporation may be obliged to pay to the person to whom the contract shall be awarded at any subsequent letting; the amount to be calculated upon the estimated amount of the work by which the bids are tested.

The consent last above mentioned must be accompanied by the oath or affirmation, in writing, of each of the persons signing the same, that he is a householder or freeholder in the City of New York, and is worth the amount of the security required for the completion of the contract, over and above his liabilities as bail, surety, or otherwise, and that he has offered himself as surety in good faith, with the intention to execute the bond required by law.

No estimate will be considered unless accompanied by either a certified check upon one of the State or National banks of the City of New York, drawn to the order of the Comptroller, or money to the amount of five per centum of the amount of the security required for the faithful performance of the contract. Such check or money must NOT be inclosed in the sealed envelope containing the estimate, but must be handed to the officer or clerk of the Department who has charge of the estimate-box, and no estimate can be deposited in said box until such check or money has been examined by said officer or clerk and found to be correct. All such deposits, except that of the successful bidder, will be returned to the persons making the same within three days after the contract is awarded. If the successful bidder shall refuse or neglect, within five days after notice that the contract has been awarded to him, to execute the same, the amount of the deposit made by him shall be forfeited to and retained by the City of New York, as liquidated damages for such neglect or refusal; but if he shall execute the contract within the time aforesaid, the amount of the deposit will be returned to him.

THE COMMISSIONER OF PUBLIC WORKS RESERVES THE RIGHT TO REJECT ALL BIDS RECEIVED FOR ANY PARTICULAR WORK IF HE DEEMS IT FOR THE BEST INTERESTS OF THE CITY.

TO THE PEOPLE OF THE CITY OF NEW YORK.

It becomes my duty as Commissioner of Public Works and custodian of the many and immense interests involved in the City's water supply, to briefly present to the people of the City the present condition of the supply, and the extreme necessity for care and economy in the use of the water.

For a number of years past and up to the present time, the old Aqueduct and the Bronx river conduit have delivered in the City all the water which they are capable of carrying, the supply thus remaining stationary when the City has been constantly growing in population, buildings, manufactures and commerce, creating new and additional demands upon the water service. The consequence is that at certain seasons of the year, notably in extreme cold weather, when the habit of wasting water from faucets to prevent freezing in the pipes prevails, and in warm and dry weather, when various methods of waste are in vogue, the daily consumption exceeds the supply which can by any possibility be received through the old Aqueduct and the Bronx river conduit, the excess of consumption being drawn from the city reservoirs, diminishing the depth of water and the pressure in the distributing mains. There is no possibility of increasing the water supply received in the City until the new Aqueduct is brought into operation, and in the meantime the only reliance for a fair and equal distribution of water throughout the city is care and economy in its use on the part of the people. Already the depth of water in the reservoirs is being diminished at the rate of one inch per day, and if this should continue for any length of time, the pressure in the distributing mains would be so reduced that it would be impossible to deliver water in thousands of houses located on high ground, and in some other locations even in the basements or cellars.

I, therefore, most earnestly appeal to all citizens, residents and people carrying on business in this city to be careful and economical in the use of water, in justice to themselves, to the people at large, and especially to those who are so located as to be already suffering inconvenience from insufficient supply of water.

TO OWNERS OF LANDS ORIGINALLY ACQUIRED BY WATER GRANTS.

ATTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1889), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty, containing covenants requiring the grantees and their successors to pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repavement, the Common Council may, by ordinance, require the same to be paved, repaved or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property (who shall also be the owners of a majority of the property in frontage) on the line of the proposed improvement.

The act further provides that the owner of any such lot may notify the Commissioner of Public Works, in writing, specifying the ward number and street number of the lot, that he desires, for himself, his heirs and assigns, to be released from the obligation of such covenants, and elects and agrees that said lot shall be thereafter liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns shall thenceforth be relieved from any obligation to pave, repair, uphold or maintain said street, and the lot in respect of which such notice was given shall be liable to assessment accordingly.

The Commissioner of Public Works desires to give the following explanation of the operation of this act: When notice, as above described, is given to the Commissioner of Public Works, the owner of the lot or lots therein described, and his heirs and assigns, are forever released from all obligation under the grant in respect to paving, repaving or repairing the street in front of or adjacent to said lot or lots, except one assessment for such paving, repaving or repairs, as the Common Council may, by ordinance, direct to be made thereafter.

No street or avenue within the limits of such grants can be paved, repaved or repaired until said work is authorized by ordinance of the Common Council, and when the owners of such lots desire their streets to be paved, repaved or repaired, they should state their desire and make their application to the Board of Aldermen and not to the Commissioner of Public Works, who has no authority in the matter until directed by ordinance of the Common Council to proceed with the pavement, repavement or repairs.

PUBLIC NOTICE AS TO WATER RATES.

PUBLIC NOTICE IS HEREBY GIVEN THAT in compliance with the provisions of chapter 559, Laws of 1887, amending sections 350 and 921 of the New York City Consolidation Act of 1882, passed June 9, 1887, the following changes are made in charging and collecting water rents:

1st. All extra charges for water incurred from and after June 9, 1887, shall be treated, collected and returned in arrears in the same manner as regular rents have heretofore been treated.

2d. In every building where a water meter or meters are now, or shall hereafter be in use, the charge for water by meter measurement shall be the only charge against such building, or such part thereof as is supplied through meter.

3d. The returns of arrears of water rents, including the year 1887, shall be made as heretofore on the confirmation of the tax levy by the Board of Aldermen, and shall include all charges and penalties of every nature.

4th. A penalty of five dollars (\$5) is hereby established, and will be imposed in each and every case where the rules and regulations of the Department prohibiting the use of water through hose, or in any other wasteful manner, are violated, and such penalties will be entered on the books of the Bureau against the respective buildings or property, and, if not collected, be returned in arrears in like manner as other charges for water.

5th. Charges for so-called extra water rents of every nature, imposed or incurred prior to June 9, 1887, will be canceled of record on the books of the Department.
