COMMISSIONERS OF THE SINKING FUND OF THE CITY OF NEW YORK.

*Proceedings of the Commissioners of the Sinking Fund at a Meeting held at the Mayor's Office
at 1 o'clock P. M. on Tuesday, July 18, 1893.*

Present—Thomas F. Gilroy, Mayor; Frederick Smyth, Recorder; Theodore W. Myers, Comptroller, and Joseph J. O'Donohue, Chamberlain.

The minutes of the meeting held June 26, 1893, were read and approved.

The following communication was received from the Commissioner of Public Works for ornamental gates for the New Criminal Court Building:

Hon. THOMAS F. GILROY, Chairman, Commissioners of the Sinking Fund:

DEAR SIR—The architects of the New Criminal Court Building recommend that the specifications for the iron work on the building, which, on page 25, call for wrought-iron gates for the main entrances on Elm street and Centre street, be altered by substituting gates of a more ornamental character, and more in harmony with the architectural features of the building, and that to cover the additional cost of such ornamental gates, the wrought-iron window-guards for the first-story court-rooms, which are called for on page 24 of the specifications, be dispensed with. He states that the Jackson Architectural Iron Works, the contractors, have assented to this change without additional cost to the City.

The Superintendent of Repairs and Supplies approves of the change, and states that considering the height of the windows of the first-story court-rooms above the sidewalk, the iron window guards are unnecessary.

I respectfully ask the approval of the Commissioners of the Sinking Fund to this change in the specifications in accordance with the second paragraph on page 7 of the contract.

The Recorder thought it not advisable to dispense with the wrought-iron window guards for the first story court-rooms.

Discussion followed, and explanations were made by the Commissioner of Public Works and the Architect.

Whereupon the Comptroller offered the following:

Resolved, That, pursuant to the provisions of section 5 of chapter 371, Laws of 1887, the Commissioner of Public Works be and hereby is authorized to enter into a supplementary agreement with the Jackson Architectural Iron Works for ornamental gates for the main entrances of the New Criminal Court Building on Elm and Centre streets, in lieu of the wrought-iron gates called for by the contract for the iron work on the building, as recommended by the Architect, and approved by the Commissioner of Public Works, the cost thereof not to exceed the sum of four hundred and twenty-five dollars (\$425).

Which was unanimously adopted.

The following communications were received from the Board of Docks:

SIR—I beg to advise you that at a meeting of the Board of Docks, held this date, the following preamble and resolution was adopted:

Whereas, a large number of plans for proposed improvements and contracts and agreements for proposed purchases of water rights on the North and East rivers have been sent to the Board of Sinking Fund Commissioners for their approval, in which no action has been heretofore taken;

Resolved, That the Board of Docks respectfully ask the Commissioners of the Sinking Fund to take action at their earliest convenience on all Dock Department plans or purchases by either approving or rejecting them; that in the event of the plans being rejected, other plans may be substituted for them, and that in the event of the purchases not being approved, the owners of the property affected may be required by the Department of Docks to keep said property in proper repair.

Whereas, The Consolidation Act requires the approval of the Commissioners of the Sinking Fund before such work can be done by this Department;

Resolved, That the Commissioners of the Sinking Fund be respectfully asked to approve, at their next meeting, of the action of the Board of Docks in agreeing to build the sea-wall in accordance with the established plan, along the bulkhead line of the above-described premises.

Hon. J. SERGEANT CRAM, President Dock Commissioners, Pier "A," Battery Place, N. Y.:

DEAR SIR—This company is authorized, on behalf of the owners of the Pier foot of Barclay street and Park place, this city, and the adjacent bulkheads, or, to be more specific, the property owned by the two leases which this company hold under, to submit the following proposition:

They are willing that the new bulkhead within the limits above named shall be constructed by the Dock Department, or by themselves under the direction and supervision of said Department, at the cost and expense of said private owners, and that portion of the same which is embraced within

the piers at the foot of Barclay street and Park place, provided, that to reimburse said private owners for such improvements and the expense of constructing the same on their part, they are to have the same rights in the new bulkhead that they now have in the present bulkhead, viz.:

The right to collect wharfage, craning and other emoluments, and in the place and stead of the portions of the bulkhead which are included within the piers above named that they be at liberty to extend the existing piers to the "pier-line" upon the plans adopted by the Dock Department and to hold same (including those portions which have been recently added) by the same tenure that they hold the present so-called Barclay street and Park place Piers.

An agreement on the above basis between said owners on the one part, and the Dock Department on the other part, approved by the Sinking Fund Commissioners of this city, will be executed on the part of said owners and the work can be commenced without delay.

This company, on its part, will covenant to afford any assistance in its power; to pay the cost of the improvements if necessary, to facilitate the work (if done by the Department of Docks under the above agreement) at such times and in such manner as said Department may direct, and if done by it to proceed under the direction of your Department and prosecute the work to completion with all diligence.

Whereas, John H. Starin, in his own behalf, as owner in fee simple of the bulkhead running southerly from the Washington Market Section of the wall and immediately adjacent thereto, through Piers, old Nos. 19 and 18, has asked the Department to construct the sea-wall at his expense along the established bulkhead line on said premises; and

Whereas, The Consolidation Act requires the approval of the Commissioners of the Sinking Fund before such work can be done by this Department;

Resolved, That the Commissioners of the Sinking Fund be respectfully asked to approve, at their next meeting, of the action of the Board of Docks in agreeing to build the sea-wall in accordance with the established plan, along the bulkhead line of the above-described premises, at the expense of the said John H. Starin.

Whereupon, the Comptroller called up the communication from the Board of Docks with plans for the improvement of the water-front of Harlem river from One Hundred and Thirty-eighth street to Seventh avenue, received August 3, 1891 (Minutes, page 189); also,

Report of the Commissioner of Public Works and the Commissioners of Docks, with estimates of the cost for improvement of the water-front and exterior street from Forty-ninth to Fifty-third street, and from Fifty-ninth to Sixty-fourth street, East river, received July 2, 1890 (Minutes, pages 450-454); and

Report of Comptroller adverse to the purchase of wharfage rights, etc., incident to the pier and bulkhead at Forty-third street, North river, from the Knickerbocker Ice Company, September 14, 1892 (Minutes, page 441).

On motion, the several matters referred to in the said communications and reports were set down for a public hearing on Monday, September 18, 1893, at 11 o'clock A. M.

The Comptroller presented the following report on proposed plan for improvement of the water-front between Seventy-second and One Hundredth streets, North river:

FINANCE DEPARTMENT—COMPTROLLER'S OFFICE,
July 18, 1893.

To the Commissioners of the Sinking Fund:

GENTLEMEN—The Department of Docks, by resolution adopted May 25, 1893, submits for approval a plan for the improvement of the water-front on North river, between Seventy-second and One Hundredth streets.

If the plan proposed be considered simply as the development of a system for the accommodation of water traffic between the limits designated, I do not know that any objections can be urged against it. The bulkhead-line is fixed with due reference to the depth of water; a broad and ample exterior street is provided for, and the piers are laid down in the usual way on the prolongation of the streets. But the approval of the plan means that not only the water-front between Seventy-second and One Hundredth streets, but that between One Hundredth and One Hundred and Twenty-ninth streets, shall be appropriated to and improved for business purposes. It means the settlement forever of the question as to the extension of Riverside Park to the water-line.

This Park extends from Seventy-second street to One Hundred and Twenty-ninth street, a distance of about 15,000 feet, or 2.85 miles, and is now bounded on the west by the Hudson River Railroad. Along the bluff is the Riverside Drive, acknowledged by all to be the most beautiful in the city—its beauty being mainly in its superb river views. The Park is capable of the greatest picturesque development, even within its present limits, but, were it extended to the water, its beauty and its usefulness for park purposes would be infinitely enhanced. With such extension it could be made, beyond all comparison, the most attractive of all the places of such resort in the city. So many facilities for the combination of land and water attractions can seldom be obtained so perfectly and so naturally as in this location.

It is hardly necessary to say that if this front be devoted to commercial purposes, as proposed, all its picturesque attractiveness will be lost and the beauties of the Drive, and the Park itself, greatly diminished.

The city is being rapidly built up to the east of this Park, and especially within the limits of this plan. In a very few years this will probably be the most attractive part of the city.

For commercial purposes the water-front under consideration can never be of any very great value, on account of the fact that there are only two streets, Seventy-ninth and Ninety-sixth streets, by which it can be reached from the city.

I am convinced that a large proportion of those interested in this matter entertain the views herein expressed, and I think it would be wise, before settling so important a question, to obtain some public expression of opinion relative thereto.

Accordingly, I recommend that a date for a public hearing be fixed by the Commissioners of the Sinking Fund.

SIR—You are hereby notified that at a meeting of the Board governing this Department, held June 1, 1893, the following resolution was adopted:

Resolved, That, pursuant to the provisions of section 712 of chapter 410 of the Laws of 1882, as amended by chapter 397 of the Laws of 1893, the map or plan prepared and submitted by the Engineer-in-Chief, and adopted this day by the Board of Docks of the City of New York, for the alteration and amendment of the plan for improving the water-front and harbor of the City of New York, as determined by the Board of the Department of Docks April 13, 1871, and adopted by the Commissioners of the Sinking Fund April 27, 1871, on the North river, between the northerly side of Pier, new 46, near the foot of Charles street, and the southerly side of West Twenty-third street, be and is hereby directed to be transmitted to the Commissioners of the Sinking Fund for their approval.

To the Commissioners of the Sinking Fund :

GENTLEMEN—The Department of Docks, by resolution of the Board adopted June 1, 1893, submits to the Commissioners of the Sinking Fund a plan "for the alteration and amendment of the plan for improving the water-front and harbor of the City of New York, as determined by the Board of the Department of Docks April 13, 1871, and adopted by the Commissioners of the Sinking Fund April 27, 1871, on the North river, between the northerly side of Pier, new 46, near the foot of Charles street, and the southerly side of West Twenty-third street."

Had the plan herein proposed been adopted in the beginning, nothing could have been said against it. It provides broad exterior streets and long and ample piers for the accommodation of water traffic, but in doing this it necessitates the acquirement by the City of a vast deal of property, to say nothing of the enormous expense of dredging out the material which has in the course of years been placed outside of the proposed bulkhead line.

The improvement proposed will require the purchase of about 450 city lots 25 x 100 feet each, and this one item would amount to \$2,700,000, and the extinguishment of bulkhead rights and privileges in addition would amount to a very large and indefinite sum.

There would be over 1,300,000 cubic yards of dredging and excavation necessary, which involve a very large outlay of money.

I do not see that the advantages to be gained are a sufficient offset to the great cost and the upheaval of interests which have accumulated in the course of the time since this region has been filled in.

It does not appear to me that a radical change like that presented in this plan, calling for the expenditure of millions, and involving the interests of thousands whose business has been built up and carried on on the supposition that the present order of things would be permanent, should be made without such a public hearing by the Sinking Fund Commission as would give an opportunity for those interests to be presented and fully and deliberately considered.

The following communication was received from the Board of Docks, with agreement for purchase of wharf property on the southerly side of South street, between Market and Pike Slips, East river, from the Screw Dock Company.

SIR—In reply to your favor of the 3d instant, respecting the present status of the agreement made and entered into by this Department with the Screw Dock Company for the purchase and acquisition of the bulkhead property on the southerly side of South street, between Market and Pike Slips, I beg to state that November 19, 1891, Alfred C. Chapin, attorney for the Screw Dock Company, submitted to this Board a communication, stating that the said company was prepared to renew its negotiations for the sale to the City of certain bulkhead property, between Market and Pike Slips, East river ; whereupon the following preambles and resolution were adopted :

"Whereas, By resolution passed by this Board at the meeting held on the 5th day of November, 'it was deemed advisable, in the interests of the City, to enter into negotiations for the purchase of the property of the Screw Dock Company on the East river ; and

"Whereas, Said negotiations have been satisfactorily completed ; therefore be it
"Resolved, That, pursuant to section 715 of the New York City Consolidation Act of 1882, this Board enters into an agreement with the Screw Dock Company for the purchase and acquisition of all that bulkhead, wharf or dock property on the southerly side of South street, in the City of New York, commencing at a point twenty-six feet easterly of the easterly side of Market Slip, and extending along the said southerly side of South street three hundred and three feet ten inches, more or less, including all the right, title and interest of the Screw Dock Company in and to Pier 39, East river, for the sum of one hundred and ninety-six thousand nine hundred and fifty dollars (\$196,950). Such agreement and purchase to be subject to the approval of the Commissioners of the Sinking Fund, as provided by section 715, chapter 410 of the Laws of 1882, and subject also to a lease which by its terms expires in 1893, provided that the Counsel to the Corporation shall certify that a good and sufficient title can be acquired, and that the said lease shall be duly assigned to this Department."

In accordance therewith, the inclosed agreement was prepared and, after approval by the Counsel to the Corporation, transmitted to his Honor the Mayor, as Chairman of the Commissioners of the Sinking Fund, June 9, 1892.

To the Commissioners of the Sinking Fund :

GENTLEMEN—This wharf property is offered for sale by the Screw Dock Company for \$196,950, and includes the old Pier No. 39, and all the bulkhead rights and privileges. For these the City would pay under the agreement at the rate of \$648 per running foot, which I consider excessive.

It may be worth this amount to the owners in the way of business, but we are acquiring now more valuable wharf property on the North river at the rate of \$500 per foot.

The following resolution therefore is submitted disapproving of the purchase.

Resolved, That the Commissioners of the Sinking Fund do not approve of the agreement entered into by the Dock Department on April 30, 1892, under a resolution adopted by the Board of Docks on November 19, 1891, for the purchase from the Screw Dock Company of certain wharf property between Pike Slip and Market Slip, including Pier 39, East River, for the sum of one hundred and ninety-six thousand nine hundred and fifty dollars (\$196,950).

The report was accepted and the resolution unanimously adopted.

The following communication was received from the Commissioner of Public Works, returning plans, specifications, etc., for flagging sidewalks around the new Criminal Court Building :

Hon. THOMAS F. GILROY, Chairman, Commissioners of the Sinking Fund :

DEAR SIR—By resolution of your Board the enclosed plan and specifications for sidewalks, curbing, coping, etc., around the New Criminal Court Building, first transmitted with my letter of the 17th ultimo, were referred back to me with the objections presented thereto in the report made by the Engineer of the Finance Department.

The objections presented are that the sidewalk on the Elm street front of the building would be too narrow, and it is recommended that the sidewalk be widened to the width of nineteen feet, proportionate to an eighty-foot street, in accordance with the general ordinance regulating widths of carriageways and sidewalks.

It is well known to the members of your Board that the project of widening Elm street in order to secure a wider street parallel to Broadway for vehicle traffic, and relieve the immense traffic on Broadway, has been pending for a number of years and is now approaching consummation. To widen the sidewalk on the block occupied by the Criminal Court Building, as proposed by the Comptroller's Engineer, would, to that extent, encroach on the carriageway, and would cause a break or projection in the line of curb, instead of a continuous street line and uniform width of carriageway.

I believe that, under these circumstances, the object of retaining the carriageway of Elm street at the regular proposed width is of much greater importance than the establishment of a wide sidewalk where there will be comparatively little pedestrian travel. I therefore retransmit the plan and specifications, with the recommendation of their speedy approval.

On motion of the Comptroller the width of the sidewalk was increased three feet on the east side of Elm street between White and Franklin streets.

The Comptroller then offered the following resolution :

Resolved, That the Commissioners of the Sinking Fund hereby approve of the plans, specifications, estimates and form of contract for flagging, etc., the sidewalks around the Criminal Court Building, submitted by the Commissioner of Public Works, under date of June 17, 1893, and approved by the Counsel to the Corporation, except as to the width of the sidewalk on Elm street, which is to be nineteen feet instead of sixteen feet, as laid down on the plans ; and the Comptroller hereby is authorized and directed to advertise for proposals for said work pursuant to the provisions of section 5, chapter 371, Laws of 1887.

Which was unanimously adopted.

The Comptroller presented the following report on proposed re-sale of the lease of the ferries now operated by the Union Ferry Company between New York and Brooklyn :

To the Commissioners of the Sinking Fund :

GENTLEMEN—By a lease bearing date the 5th of January, 1887, the Commissioners of the Sinking Fund granted to the Union Ferry Company of Brooklyn, for a term of five years from May 1, 1886, the franchises for the following ferries : (1) The Fulton Ferry, between Fulton street, in the City of New York, and Fulton street in the City of Brooklyn ; (2) The Wall Street Ferry, between Wall street, in the City of New York, and Montague street, in the City of Brooklyn ; (3) The Catharine Street Ferry, between Catharine street, in the City of New York, and Main street, in the City of Brooklyn ; (4) The South Ferry, between Whitehall street, in the City of New York, and Atlantic avenue, in the City of Brooklyn ; and (5) The Hamilton Avenue Ferry, between Whitehall street, in the City of New York, and Hamilton avenue, in the City of Brooklyn. The original lessee, expired by limitation of its charter in November, 1890, and was succeeded by a new corporation known as the Union Ferry Company of New York and Brooklyn, which had previously acquired all the rights of the former corporation by assignment made November 10, 1890.

The lease provided for an annual rental of 12 3/4 per cent. of the gross receipts of the ferries, and it furthermore contained a provision that upon its termination the City should cause to be purchased from the company its boats, buildings and other property used in and actually necessary for the operation of the ferries at a fair appraised valuation, to be fixed by two appraisers, one to be appointed by the Comptroller, and the other by the lessee.

Pursuant to this provision, appraisers were appointed by the respective parties on December 22, 1890, and they appraised the property of the ferry company at \$3,803,000. Under the belief that this valuation was excessive and prejudicial to the interests of the City, an action was begun in the Court of Common Pleas to set it aside and obtain another appraisement. This action was begun by one Edmund W. McClave, under the taxpayer's act, but the Commissioners of the Sinking Fund, named as defendants, having by their answer united in praying for the same relief upon the same ground, the plaintiff retired from the prosecution of the action, and the issue was practically left to the City and the ferry company as parties litigant. During the pendency of this action, an agreement was entered into with the ferry company, ratified by the Commissioners of the Sinking Fund, April 28, 1891, whereby the company was allowed to continue operating its ferries on the same terms in respect to rent and rates of fare as were provided in the lease then about to expire.

On June 25, 1892, the action in the Court of Common Pleas was decided, Chief Justice Daly holding that the appraisement should be reduced from \$3,803,000 to \$3,229,401.

Attention is called to a communication from Messrs. Lowrey, Stone & Auerbach, attorneys for the Union Ferry Company, to the Commissioners of the Sinking Fund, under date of March 28, 1891, showing to what extent the business of the ferries operated by that corporation has suffered from the opening of the Brooklyn Bridge.

For the year ending April 30, 1883 (the year of the opening of the Brooklyn Bridge), the gross receipts of all these ferries were..... \$1,161,806 00
For the corresponding period in 1893, the gross receipts were..... 844,904 90
For the year 1892..... 849,386 62
For the year 1891..... 848,048 72

It is alleged by the lessee that these ferries cannot be profitably operated under a lease calling for the payment of 12 3/4 per cent. of their gross receipts ; and representatives of the Union Ferry Company have recently stated to me in the most positive terms that that corporation will not be a bidder for the franchises if that figure be fixed as the upset price.

With a view to ascertaining the valuation and rental value of the wharf property belonging to the City, now occupied by the Union Ferry Company, I have caused separate appraisements thereof to be made by the Bureau of City Revenue and by Mr. Eugene E. McLean, Engineer of the Finance Department. These appraisements were most carefully made, from data received from the Department of Docks and on file in the Finance Department, from personal inspection and from opinions obtained from well-informed judges of water-front property. The values found by these appraisals, which were separately conducted and based on different methods, were remarkably close together—that of Mr. McLean fixing the rental value at \$139,181, and that of the Bureau of City Revenue at \$140,900.

The amount paid to the City by the Union Ferry Company during the year ending October 31, 1892, being 12 3/4 per cent. of its gross receipts, was \$108,469.78. It thus appears that the City is renting this property for less than it could obtain from other lessees ; and instead of obtaining a revenue from the grant of the right to run the ferries, is actually paying a large sum annually for the privilege of maintaining transit connection with Brooklyn.

On February 20, 1891, a communication to me from Messrs. W. H. Male and H. K. Knapp, a committee of the Union Ferry Company, was presented to the Commissioners of the Sinking Fund, in which communication the Ferry Company offered to bid not less than 12 3/4 per cent. of the gross receipts, provided the conditions of the lease were modified in the following three particulars : (1) The new lease to be for a term of ten years ; (2) The lease to provide that the maximum fare on the South and Hamilton ferries shall be not to exceed two cents at all hours of the day ; and (3) That the provision as to commutation tickets should not become part of the new lease.

Reference is made to that communication for a detailed statement of the grounds on which the application was based.

The situation which now confronts the Commissioners of the Sinking Fund, summed up in a few words, would seem to be as follows : The ferry franchises about to be sold and constituting what should be valuable property rights of the City of New York, have suffered depreciation in value, owing to the building of the New York and Brooklyn Bridge. It is claimed that under present conditions, and at the rates of fare allowed to be charged by the last lease, the business of conducting these ferries is not sufficiently profitable to permit of the payment in the future of 12 3/4 per cent. of the gross receipts, at which rate, even, the City is now receiving less than could be obtained if the wharf property subject to the lease were rented in the open market. If the upset price fixed in the former lease be retained in the new one, it is possible that no bids will be made at the sale, and the City will then be confronted with that condition in the lease which provides for the purchase of the company's property at \$3,229,401.

If the upset price be reduced say five per cent., the franchise will probably be sold, but the City will suffer an additional loss of about \$42,000 per annum, representing (at 3 per cent.), a capitalized depreciation in the value of the franchises of about \$1,400,000.

The Union Ferry Company continues to pay to the city 12 3/4 per cent. of their gross receipts as formerly, in pursuance of the agreement ratified by the Commissioners of the Sinking Fund April 28, 1891 ; but they have now given notice that they will discontinue these payments, and intend to terminate said agreement. It therefore becomes necessary to provide for a re-sale of these

ferry leases, and this highly important matter is respectfully submitted to the Commissioners of the Sinking Fund for such action as, in their judgment, may seem wise.

Whereas, The Board of Estimate and Apportionment adopted resolutions on July 18, 1893, authorizing the issue of additional School-house Bonds, to be known as Consolidated Stock of the City of New York, pursuant to the provisions of chapter 264 of the Laws of 1891, for the purchase of school sites and other school purposes, amounting in all to the sum of one hundred and seventy-one thousand four hundred and seven dollars and seventy-two cents, and requested the Commissioners of the Sinking Fund to exempt said bonds from city and county taxation; therefore

Resolved, That the said stocks or bonds, amounting to one hundred and seventy-one thousand four hundred and seven dollars and seventy-two cents, so authorized to be issued by the Board of Estimate and Apportionment, be and hereby are exempted from taxation by the City and County of New York, in pursuance of the provisions of section 137 of the New York City Consolidation Act of 1882, and an ordinance of the Common Council, approved by the Mayor October 2, 1880.

Which was unanimously adopted.

The Comptroller presented the following statement and resolution to pay Frank E. Towle, Surveyor, for professional services in the matter of "Improving and Constructing Riverside Avenue":

The unpaid balance of claim of Frank E. Towle, City Surveyor, for services rendered in surveying and preparing an assessment list for "Improving and Constructing Riverside Avenue," is submitted herewith.

The total amount of claim was.....	\$2,694 03
Less amount paid on account (B Voucher No. 4371 of 1892).....	1,627 00

Balance unpaid.....\$1,067 03

The claim, as presented to the Finance Department, through the Department of Public Parks, bears date November 12, 1890. The authority for the Department of Public Parks to employ a Surveyor for this service outside its own Engineer Corps was questioned, and the claim was referred to the Corporation Counsel. Before the claim was ready for adjustment the assessment was before the Board of Revision and Correction of Assessment for confirmation.

There was in the City Treasury to credit of the fund only \$1,627. To pay the claim in full would necessitate the issue of Assessment Bonds. The Corporation Counsel arranged with Mr. Towle's counsel to receive on account this \$1,627 and wait for the balance until it could be paid from assessments collected. The assessment was confirmed November 29, 1892, and the collections thereon are deposited in the Sinking Fund for the Redemption of the City Debt. The amount of Mr. Towle's claim is included in the assessment.

TO OWNERS OF LANDS ORIGINALLY ACQUIRED BY WATER GRANTS.

ATTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1889), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty containing covenants requiring the grantees and their successors to pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repavement, the Common Council may, by ordinance, require the same to be paved, repaved or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property (who shall also be the owners of a majority of the property in frontage) on the line of the proposed improvement.

The act further provides that the owner of any such lot may notify the Commissioner of Public Works, in writing, specifying the ward number and street number of the lot that he desires, for himself, his heirs and assigns, to be released from the obligation of such covenants, and elects and agrees that said lot shall be thereafter liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns shall thenceforth be relieved from any obligation to pave, repair, uphold or maintain said street, and the lot in respect of which such notice was given shall be liable to assessment accordingly.

The Commissioner of Public Works desires to give the following explanation of the operation of this act:

When notice, as above described, is given to the Commissioner of Public Works, the owner of the lot or lots therein described, and his heirs and assigns, are forever released from all obligation under the grant in respect to paving, repaving or repairing the street in front of or adjacent to said lot or lots, except one assessment for such paving, repaving or repairs, as the Common Council may, by ordinance, direct to be made thereafter.

No street or avenue within the limits of such grants can be paved, repaved or repaired until said work is authorized by ordinance of the Common Council, and when the owners of such lots desire their streets to be paved, repaved or repaired, they should state their desire and make their application to the Board of Aldermen and not to the Commissioner of Public Works, who has no authority in the matter until directed by ordinance of the Common Council to proceed with the pavement, repavement or repairs.
