



APPROVED PAPERS.

Ordinances and Resolutions passed by the Common Council during the week ending June 13, 1885

Resolved, That the Commissioner of Public Works be and he is hereby directed to cause the sidewalk in front of Nos. 3, 5, 7, 9 and 11 Bridge street, Nos. 22 and 24 Whitehall street, No. 157 Cedar street, and on the west side of Church street, between Fulton and Vesey streets, Nos. 83 and 85 Greenwich street, to be repaired, and the flagging laid or relaid on the established grade, as provided in sections 99, 103 and 104 of article VII. of chapter 6 of the Revised Ordinances of 1880.

Adopted by the Board of Aldermen, May 25, 1885.

Received from his Honor the Mayor, June 8, 1885, without his approval or objections thereto; therefore, as provided in section 75, chapter 410, Laws of 1882, the same became adopted.

Whereas, The water supplied to the inhabitants of the city north of the Harlem river, in the Twenty-third and Twenty-fourth Wards, is so offensive as to render its use a source of great annoyance and dangerous to the health of the people of the said wards; be it therefore

Resolved, That the Commissioner of Public Works be and he is hereby authorized and directed to take such measures as he may deem necessary to remedy the evils of impure water referred to, and that he invoke the aid of the Board of Health to assist him in his effort to serve the people in the upper part of the city good and wholesome water.

Adopted by the Board of Aldermen, May 25, 1885.

Received from his Honor the Mayor, June 8, 1885, without his approval or objections thereto; therefore, as provided in section 75, chapter 410, Laws of 1882, the same became adopted.

Resolved, That permission be and the same is hereby given to Michael Caldron to place and keep a watering-trough on the sidewalk, near the curb, in front of his place of business in Cherry street, northeast corner of Gouverneur street, the work to be done and water supplied at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

Adopted by the Board of Aldermen, May 28, 1885.

Received from his Honor the Mayor, June 8, 1885, without his approval or objections thereto; therefore, as provided in section 75, chapter 410, Laws of 1882, the same became adopted.

Resolved, That One Hundred and Forty-ninth street, from Seventh to Eighth avenue, be regulated, graded, curbed and flagged a space four feet wide through the centre thereof, under the direction of the Commissioner of Public Works; and that the accompanying ordinance therefor be adopted.

that the work be done and gas supplied at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

Resolved, That gas-mains be laid, lamp-posts erected and street-lamps placed thereon and lighted in One Hundred and Forty-eighth street, from Third to Brook avenue, under the direction of the Commissioner of Public Works.

Resolved, That Claremont avenue, from One Hundred and Sixteenth to One Hundred and Twenty-second street, be regulated and graded, curb-stones set and sidewalks flagged four feet wide, where not already done, under the direction of the Commissioner of Public Works; and that the accompanying ordinance therefor be adopted.

Whereas, The proceedings of the various meetings of the Board of Education are frequently interrupted by the noise resulting from the passage of heavy vehicles over the pavement in Elm street; and

Resolved, That the Commissioner of Public Works be and he is hereby authorized to pave with wooden or asphalt pavement that portion of the roadway of Elm street beginning at the crosswalk at the northerly side of Grand and extending northerly therefrom for a distance of one hundred and fifty feet (150), without public advertising and letting, to be paid from the appropriation of "Repairs and Renewal of Pavements," as provided by section 64 of the New York City Consolidation Act of 1882.

In adopting the foregoing resolution (of retirement), the Board of Police cheerfully embrace the opportunity to give expression to their high appreciation of the many years of valuable service rendered to the public by an honest, worthy and capable officer.

Appointed a Patrolman December 22, 1847, he was promoted through the grades of Captain and Inspector to that of Superintendent for specially marked ability, untiring devotion to duty, and rare fidelity to trust. In every position, and in every grade so ably filled by him, the slightest word or whisper of suspicion has never been heard against his integrity; and in being retired from the Police service, he carries with him the best wishes of the members of this Board, and the hope that he may live many years to enjoy the rest and recreation to which his long and creditable service so justly entitles him. DEPARTMENT OF DOCKS.

At a special meeting of the Board of Docks, held May 29, 1885.

Present, the full Board.

The communication from Theodore Schumacher, requesting permission to repair the sea-wall, between East Fifty-seventh and East Fifty-eighth streets, East river, and the report from the Engineer-in-Chief on Secretary's Order, No. 4248, in relation thereto, were taken from the table and ordered to be placed on file, and the following preamble and resolution, offered by Commissioner Stark, was unanimously adopted:

Whereas, Application has been made by Theodore Schumacher for permission to repair the sea-wall at the foot of the bluff between East Fifty-seventh and East Fifty-eighth streets, East river, and Whereas, the said wall is located outside of the line of original high-water mark on premises the title to which is vested in and properly belongs to the Corporation of the City of New York, and in view of the fact that the said Theodore Schumacher does not assert any claim to the possession of the said premises, therefore

Resolved, That permission be and hereby is granted to the said Theodore Schumacher to make such necessary repairs within the existing lines as may be required to put the said wall in good and serviceable condition, all the work hereby authorized be done under the supervision and direction of the Engineer-in-Chief of this Department; it being expressly understood that the permission hereby granted is not to be construed as in any way or manner acknowledging that the said Theodore Schumacher has any right, title or interest in or to the premises lying outside of the line of original high water.

The communication from James Gillies, requesting permission to drive two rows of piles, extending from the inner end of platform at the southerly side of West Fiftieth street to the northerly side of the said street, and also requesting permission to fill in behind the same with rip-rap and earth filling, was, together with the report from the Engineer-in-Chief on Secretary's Order No. 4309, in relation thereto, taken from the table, and ordered to be placed on file, and the following resolution, offered by Commissioner Koch, was unanimously adopted:

Resolved, That permission be and hereby is granted to James Gillies to drive a double close row of piles to extend from the northerly side of the platform heretofore erected south of West Fiftieth street, North river, to the northerly line of the said street, as extended, the said piles to be driven on a line parallel to and not less than fifty feet easterly of the established bulkhead line; permission being also granted to fill in behind the said piles with rip-rap and earth-filling up to the established grade of the street; the said structure extending across the foot of West Fiftieth street to be kept open for use by the public, and wharfage to be paid to the City for all vessels using the same; all the work hereby authorized, to be done under the supervision and direction of the Engineer-in-Chief.

The communication from the Department of Public Works requesting the assignment of berths for the public baths during the season of 1885, was taken from the table, and with the report from the Engineer-in-Chief on Secretary's Order No. 4409, in relation thereto, which was received and read, was ordered to be placed on file, and the following locations were assigned for the berthing of the public baths:

On North river.

Foot of Duane street.
Foot of Horatio street.
Foot of West Fifty-first street.
Pier at West Twenty-seventh street.

On East river.

Pier 51.
Pier at Fifth street.
Pier at East Thirty-seventh street, and
At the Battery.

On Harlem river.

Bulkhead at East One Hundred and Twelfth street, and at foot of Lincoln avenue.

In pursuance of the provisions of section 725, chapter 410, Laws of 1882, the foot of East Seventeenth street, East river, is also assigned as the location for a public bath.

The Secretary was directed to advise the Department of Public Works that the berth at present assigned for bath, at the foot of Duane street, North river, is the only available location in the Fifth Ward, between Reade and Canal streets, that is the property of the City, and which is at present unleased; and as the Commissioners are of the opinion that, for sanitary and other reasons, the location of the bath at the place named would not be safe or suitable, the Board have requested the opinion of the Counsel to the Corporation as to its powers and duties in the premises—whether the provisions of section 727 of the "Consolidation Act" are mandatory or not, and if the Board have discretionary power to place and locate the bath at any other place not within the Fifth Ward. Also, to further advise, that the other designations made for locations of the Public Baths are at the most available places that the Board can select, and to request that the locations assigned for the baths, respectively, be accepted by the Department of Public Works. The Engineer-in-Chief to be directed to make the necessary and proper provision for the placing of the baths at the places designated.

Commissioner Koch, to whom was referred the communications from John Dorschell, requesting permission to locate bath at foot of Eighty-first street, North river, and also requesting a renewal of permit to locate bath at foot of Eightieth street, North river, reported thereon in favor of granting the permission asked for, provided that the said Dorschell pay therefor, monthly in advance, the sum of \$40, for the months of June, July, August and September, and also provided that he pay \$50 in advance, for the privilege of laying up the said baths from October 1, 1885, to June 1, 1886.

On motion, the report was received, the communications from John Dorschell ordered to be placed on file, and the Secretary directed to notify the Dock Master to berth the baths at the locations named, provided they do not interfere with the commercial use of the premises.

Commissioner Matthews, to whom was referred the communications from the East River Bathing Company, requesting permission to locate a bath at Pier 55, foot of Grand street, East river, and from M. C. Dexter requesting permission to locate baths at the lower side of the Piers at foot of West Twenty-first and Thirty-fourth streets, North river, reported thereon in favor of granting the permission asked for, provided the East River Bathing Company pay as rent therefor, for the use of berth at Pier 55, East river, \$5 per day, and also provided that M. C. Dexter pay \$6 per day for the use of the berth at West Twenty-first street, and \$5 per day for the use of the berth at West Thirty-fourth street, North river.

On motion, the report was received, the communication from the East River Bathing Co. and from M. C. Dexter ordered to be placed on file, and the Secretary directed to notify the Dock Master to berth the baths at the locations named, provided they do not interfere with the commercial use of the premises, and also to collect for the use thereof, \$5 per day from the East River Bathing Co., and \$6 per day from M. C. Dexter, for use of West Twenty-first street, and \$5 per day for the use of West Thirty-fourth street, North river.

On motion, the Secretary was directed to request the Counsel to the Corporation to give the Board his opinion as to its rights, power and duties to sell at public auction, wharf property required for ferry purposes by the lessee of the franchise for the ferry to Fort Lee, at the bulkhead between One Hundred and Thirtieth and One Hundred and Thirty-first streets, North river, or whether the same should be sold by the Commissioners of the Sinking Fund in accordance with the provisions of section 180 of the Consolidation Act.

On motion, the Secretary was directed to notify the Dock Master to report if the location of a dumping-board at Delancey street, in addition to the one at present located at Rivington street, East river, would interfere with the use of the premises for commercial purposes.

The communication from the Department of Public Works, in reference to the dumping-board located at One Hundred and Tenth street, Harlem river, was taken from the table and placed on file, and the Secretary directed to advise that the said premises are in the use and occupation of the Department of Street Cleaning for a dump, and it appears to be necessary and requisite for that Department to have a dump in that vicinity, and this Board has no authority to prevent the use of same or to remove the Department of Street therefrom.

The application of Frank Pidgeon, to continue in the use of the dumping-board located at Rivington street, East river, was referred to Commissioner Matthews with power.

The Auditing Committee presented an audit of eight bills or claims amounting in the aggregate to the sum of \$888.81, which was accepted and adopted, and the Secretary directed to enter the same in full on the minutes, as follows:

Whether liable or not, such notices must be answered (in person, if possible, and at this office only) under severe penalties. If exempt, the party must bring proof of exemption; if liable, he must also answer in person, giving full and correct name, residence, etc., etc. No attention paid to letters.

Persons "enrolled" as liable must serve when called or pay their fines. No mere excuse will be allowed or interference permitted. The fines if unpaid will be entered as judgments upon the property of the delinquents.

All good citizens will aid the course of justice, and secure reliable and respectable juries, and equalize their duty by serving promptly when summoned, allowing their clerks or subordinates to serve, reporting to me any attempt at bribery or evasion, and suggesting names for enrollment. Persons between sixty and seventy years of age, summer absentees, persons temporarily ill, and United States and District Court jurors are not exempt.

Every man must attend to his own notice. It is a misdemeanor to give any jury paper to another to answer. It is also punishable by fine or imprisonment to give or receive any present or bribe, directly or indirectly, in relation to a jury service, or to withhold any paper or make any false statement, and every case will be fully prosecuted.
