BOROUGH OF THE BRONX.

Minutes of the Local Board of Morrisania, Twenty-fourth District, Borough of The Bronx.

Pursuant to call by President Haffen, the members of the Local Board of Morrisania, Twenty-fourth District, met on Thursday, September 3, 1903, at the office of the President of the Borough of The Bronx, Municipal Building, Crotona Park, One Hundred and Seventy-seventh street and Third avenue.

Present—President Haffen in the chair and Alderman Peck.

Minutes of the previous meeting were read and adopted.

Hearings Pursuant to Advertisement.

No. 411.

Paving with asphalt block pavement on a concrete foundation Crotona avenue, from Crotona Park North to Pelham avenue.

Petition of James Kilkenny and others was read and laid over.

No. 418.

Regulating and paving with sheet asphalt on a concrete foundation where the grade is less than 3 per cent., and with asphalt blocks on concrete where the grade is over 3 per cent., Crotona avenue, from Crotona Park North to the Southern Boulevard, and setting curb where necessary.

Petition of John McNulty, No. 1805 Crotona avenue, was read.

The Engineer of Highways' report, as approved September 1, 1903, by the Chief Engineer of the Borough of The Bronx, gave the estimated cost of this improvement at \$93,000, and the assessed value of the real estate included within the probable area of assessment at \$1,038,052.

On motion, the following preambles and resolution were adopted, as no one appeared in opposition:

For regulating and paving with sheet asphalt on concrete where the grade is less than 3 per cent., and with asphalt blocks on concrete where the grade is over 3 per cent., Crotona avenue from Crotona Park North to the Southern Boulevard, and setting new curb where necessary and rejoining and resetting old curb, in the Borough of The Bronx, City of New York; and it is hereby

Resolved, That a copy of this resolution be transmitted forthwith to the Board of Estimate and Apportionment for its approval.

Receiving basin, etc., in Hughes avenue, at the northwest corner of East One Hundred and Eighty-first street, and at the northwest corner of Oak Tree place.

No. 428.

Paving with sheet asphalt on concrete East One Hundred and Sixty-seventh street, from Southern Boulevard to West Farms road, and setting curb where necessary.

Petition of Violetta A. Jackson and another was read, and no one appearing in opposition the matter was laid over for report of the Chief Engineer of the Borough for his report as to the estimated cost of the proposed work or improvement, and a statement of the assessed value of the real estate included within the probable area of assessment.

No. 429.

Regulating, grading, etc., Walton avenue, from East One Hundred and Sixty-seventh street to the Fordham road.

Petition of Randall Salisbury, per H. S., and Messrs. Reeves, Todd & Swain, attorneys for a number of property owners, was read.

Mr. Joseph A. Flannery, representing the Astor estate, appeared in opposition. Mr. Swain appeared in favor. After discussion the petitioners requested that they be allowed to amend their petition so that the limits of the improvement would extend from "One Hundred and Seventy-second street to Fordham road only."

Paving with block asphalt on concrete foundation Daly avenue, from One Hundred and Seventy-sixth (or Woodruff) street to Bronx Park, and setting curb where necessary.

Petition of Chas. M. Breidenbach and others was read. No one appeared in opposition.

On motion, the matter was laid over for the Chief Engineer's report as to the estimate of the cost of the proposed work or improvement, and a statement of the assessed value of the real estate included within the probable area of assessment.

Paving Lorillard place, from Third avenue to Pelham avenue.

Petition of Annie Rehill and others was read. No one appeared in opposition.

Laid over for report of the Chief Engineer as to the estimate of the cost of the proposed work or improvement, and a statement of the assessed value of the real estate included within the probable area of assessment.

Regulating and grading, etc., Arthur avenue, from East One Hundred and Seventy-fifth street to East One Hundred and Seventy-seventh street.

The City of New York, Office of the President of the Borough of The Bronx, One Hundred and Seventy-seventh Street and Third Avenue, August 21, 1903.

In the matter of the proposed opening of Becker avenue, from White Plains road to the centre of the Bronx river, Borough of The Bronx.

The petition for the opening of Becker avenue, from White Plains road to the centre of the Bronx river, was approved by the Local Board of Chester, and was before the Board of Estimate and Apportionment on the 22d day of July, 1903, but was referred back to the Local Board for further consideration.

The opening of Becker avenue was petitioned for by W. W. Penfield and William H. Fields, probably for the purpose of obtaining a connecting street with the existing street west of the Bronx river, which was constructed by the City of Yonkers so far as the Bronx river.

I have been informed that opposition to the opening of Becker avenue was caused by a rumor that a viaduct would be built across the New York and Harlem Railroad and the New York, New Haven and Hartford Railroad, the construction of which would bring a heavy burden upon the adjoining property owners.

The grades on section 29 of the final maps show Becker avenue is to be carried under the tracks of the two railroads, as it is the case at the present time, and that the street will be lowered in order to get sufficient head room.

The question whether the opening of a 100-foot street is a public necessity at the present time seems to have been answered affirmatively by the Local Board, but I would recommend that since the matter was referred back to the Local Board, that another hearing be given.

On motion of President Haffen the said resolution was amended so as to read as follows, and was adopted as thus amended:

Whereas, The absence of a bridge for vehicular and passenger traffic over the Bronx river, between Two Hundred and Thirty-third street and West Mount Vernon, is working untold inconvenience and hardship to the residents of the upper section of The Bronx; and


