



**Local Law 53 Annual Report Calendar Year 2019**

This report details the number of noise inspections, with a focus on the number of noise complaints received by the Department of Environmental Protection (DEP) related to afterhours noise complaints and response time to those complaints as well the number of summonses issued.

The answers below describe the status of the DEP’s implementation of the law and respond to the specific questions posed in the legislation.

1. *What is the number of inspectors employed by the department?*

There were 66 Air and Noise Inspectors.

2. *What is the number of complaints regarding noise received by the department, disaggregated by the type of noise?*
