### DEPARTMENT OF PUBLIC PARKS.

Abstract of Proceedings for the Week ending December 20, 1884.

Wednesday, December 17, 1884.—Regular Meeting-10 A. M.

Present —Commissioners Crimmins (President), Viele, Wales, and Olliffe.

Mr. W. M. Walker appeared before the Board and presented a petition for the establishing of a grade for Jerome (Central) avenue, from the Harlem river to Croton avenue.

Mr. Walker also presented a petition signed by B. W. Bradford, A. H. Gerding, and others, property-owners, asking that One Hundred and Seventy-sixth street be opened and widened, from Anthony avenue to Morris avenue, and that Morris street, from Anthony avenue to Morris avenue, be closed. be closed

A petition was received from Isaac M. Dyckman and T. & W. Thorn & Co., asking that the matter of establishing grades of Riverdale avenue at Kingsbridge be laid over for the present in order to give adjacent property-owners more time to consider the matter.

Messrs. J. H. Godwin and Waldo Hutchins appeared before the Board and were heard in relation to the same.

The further consideration of the subject was laid over.

The following communications were received:

From the Clerk of the Board of Aldermen, transmitting a copy of an ordinance to regulate, grade, etc., Trinity avenue, from Clifton street to One Hundred and Sixty-fifth street, adopted by said Board and approved by the Mayor.

From the Secretary of the Department of Public Charities and Correction, transmitting a copy of a resolution relative to the telephone system of this Department.

From Henry Lett, requesting permission to obtain from the Topographical Engineer the block distances and angles for streets and avenues shown on a diagram submitted by him.

From the Counsel to the Corporation, as to the powers and duties of the Department in the matter of the application of the Harlem Bridge, Morrisania and Fordham Railroad Company, for a permit to proceed with the work of laying its tracks along One Hundred and Thirty-eighth street.

From the Clerk of the Board of Estimate and Apportionment, transmitting copies of the following resolutions adopted by said Board:

1st. Auditing the charges for counsel fees, "In the matter of the application of John Noble Steams, Joshua C. Sanders, Horace Winans, Edward A. Morrisson and George H. Beyer for the examination of Salem H. Wales, William M. Olliffe, John D. Crimmins and Egbert L. Viele, Commissioners of Parks of the City of New York," at the sum of ten thousand dollars (\$10,000), to be paid to Messrs, John E. Parsons, Theron G. Strong and Henry R. Beekman, in the amounts of their bills, respectively, from an appropriation therefor to be included in the Final Estimate for the year 1885.

2d. Authorizing the Computabler to issue Assessment Fund bonds to the amount of \$100.000 at

2d. Authorizing the Comptroller to issue Assessment Fund bonds to the amount of \$100,000, at a rate of interest not to exceed 3½ per cent. per annum, to provide for the payment of awards and expenses for opening streets, avenues, parks and public places which may become a liability

incurred before January 1, 1885.

3d. Authorizing the Comptroller to issue Assessment bonds to the amount of \$950,000, at a rate of interest not to exceed 3½ per cent. per annum, to provide for the completion of existing contracts and liabilities for street improvements.

From Hiram Barney, asking permission to improve the sidewalk of the Spuyten Duyvil Parkway opposite his property, on the westerly side, from Riverdale avenue to the Westchester road, to be used as a temporary road until the said parkway shall be regulated and graded; the same to be

done at his expense.

From the New York Wood Turning Company, asking the rate charged for permits to connect with sewers be reduced in the case of the lumber storage building, corner Alexander avenue and One Hundred and Thirty-fourth street.

From Peck & Snyder, applying for the privilege of hiring skates at the Central Park lake during the coming skating seaso

From J. Clarence Dick, applying for a renewal of his license for boat service at the Central Park lake.

From Theodore Weston, inclosing a bill amounting to \$8,322.75, for professional services as architect in preparing plans, etc., for the enlargement of the Metropolitan Museum of Art.

From N. P. Bailey, in relation to the laying out of the roads and avenues on the east of Kings-

bridge.
From Henry W. Vogel, Assistant Engineer, asking to be allowed leave of absence for one week,

with pay, in consequence of sickness.

From the Superintendent Twenty-third and Twenty-fourth Wards, submitting the following estimates for placing sheet piling around the outlet of the Third avenue sewer in the Harlem river:

Frank Pidgeon, \$969.

B. C. Murray, \$755. From J. C. Friedmann, Henry Lipps, and M. Langenbeck, asking for the construction of a wer in One Hundred and Thirty-eighth street, from the summit between St. Ann's avenue and Southern Boulevard to Brook avenue.

Commissioner Wales, to whom was referred the subject of the monument proposed to be erected in Central Park by the New England Society, commemorative of the landing of the Pilgrim Fathers at Plymouth Rock, presented communications from the Presidents of the Metropolitan Museum of Art, the National Academy of Design, and the New York Chapter of the American Institute of Architects, reporting favorably upon the proposed monument, and moved that said monument be accepted and that it be erected on the site designated by the action of the Board of November 21,

Commissioner Wales, to whom was referred the application of James Thompson and Josiah A. Osgood, for a license to place and operate "swan velocipede boats" on the Central Park lake, made a verbal report and recommended that the application be denied.

Adopted. Commissioner Wales, to whom was referred the subject of preparing and submitting rules and regulations for the hiring of skates and chairs at the Central Park lake, and the government of the Skate-house, presented a series of rules, which were adopted.

A license was ordered granted to August Braun for the hiring of skates and chairs at the Central Park lake, during the company skating season, upon the same terms and conditions as heretofore and

Park lake, during the coming skating season, upon the same terms and conditions as heretofore, and conforming to the above rules and regulations.

The license of J. Clarence Dick, for the boat service at Central Park lake, was renewed for one

year upon the same terms and conditions as before.

The license with William H. Radtord, dated December 30, 1882, for the occupancy of certain buildings on the Central Park and the sale of refreshments therein, was canceled, and a new license was granted him for a period of five years, covering all of the privileges as heretofore enjoyed by him under his license, and containing, in addition to all of the covenants and agreements as heretofore in force and effect, the additional agreement that the said Radford will make all of the recessive years. force and effect, the additional agreement that the said Radford will make all of the necessary renovations, repairs and renewals that are now required, or that may be from time to time required, to the inside of the Casino building on the Central Park, and all of the fixtures and appurtenances as

now contained or may be hereafter contained inside of said building during the term for which this

The Comptroller of the city was requested to present to the Commissioners of the Sinking Fund a statement that the Department of Public Parks request a continuation of the lease of the premises at No. 36 Union Square, now occupied by them, for the term of one year from the first day of January, 1885.

of January, 1885.

Permission was given Hiram Barney to improve the sidewalk of the Spuyten Duyvil Parkway opposite his property, on the westerly side, from Riverdale avenue to Westchester road, to be used as a temporary road until the said parkway shall be regulated and graded; the same to be done at his expense, and under the direction of the Engineer of Construction.

The President stated that, in consideration of the exhausted condition of the appropriations, he had, since the last meeting of the Board, been compelled to order reductions in the working and mechanical forces of the Department, as well as a temporary suspension until January I, next, of such employees as could be best spared, including the midnight watch and one bridge-tender from each watch on the Harlem river bridges, whereupon the action of the President was approved.
