Executive Order No. 58

THE MAYOR'S DOMESTIC VIOLENCE COORDINATING COUNCIL (Executive Order No. 57, dated 10/21/93, Repealed)

WHEREAS, it is estimated that domestic violence affects as many as 279, 300 households in New York City every year; and

WHEREAS, domestic violence is a devastating phenomena that respects no boundaries of race, ethnicity, age, gender, sexual orientation, or economic status; and

WHEREAS, the policies and programs of this Administration have been dedicated to assisting children and families in need; and

WHEREAS, during the past four years the City has more than doubled the number of emergency shelter beds for victims of domestic violence and their children, and has for the first time ever designed non-residential services for this population; and

WHEREAS, the City has incorporated domestic violence prevention into the New York City Police Department's community policing program, thereby expanding the "Safe Streets, Safe City" program, into a "Safe Streets, Safe Homes" program; and

WHEREAS, the development of an integrated approach to the problem of domestic violence and the coordination of existing systems and services are critical to the success of the City's efforts in this area;

NOW THEREFORE, by the power vested in me as Mayor of the City of New York, it is hereby ordered;

Section 1. <u>Prior Order Repealed</u>, Executive Order No. 57 of 1993, dated October 21, 1993, is hereby repealed.

Section 2. <u>Establishment of a Coordinating Council</u>. There is hereby established a Mayor's Domestic Violence Coordinating Council (the "Coordinating Council"). The Director of the Mayor's Office for Children and Families or his or her designee shall serve as chairperson of the Coordinating Council and shall coordinate and supervise its activities. The Coordinating Council shall report to the Deputy Mayor for Health and Human Services, the Deputy Mayor for Planning and Development, and the Deputy Mayor for Public Safety.

Section 3. Membership.

a. In addition to the Mayor's Office for Children and Families, the following City agencies, commissions and divisions of the Office of the Mayor shall be members of the Coordinating Council:

- 1. Department of Health
- 2. Human Resources Administration (Child Welfare Administration, Adult Services Administrator, Family Support Administration)
- 3. Police Department
- 4. Department for the Aging
- 5. Department of Housing Preservation and Development
- 6. Department of Youth Services
- 7. Department of Probation
- 8. Department of Mental Health, Retardation and Alcoholism Services
- 9. Law Department
- 10. Department of Homeless Services
- 11. Department of Juvenile Justice
- 12. Community Development Agency
- 13. Department of Corrections
- 14. Commission on the Status of Women

- 15. Office of Management and Budget
- 16. Mayor's Office of Immigrant Affairs
- 17. Mayor's Office of Operations
- 18. Mayor's Office of Lesbian and Gay Community Affairs

b. The Health and Hospitals Corporation and the New York City Housing Authority shall also be invited to be members of the Coordinating Council.

c. The head of each participating entity shall designate a senior level administrator to attend Coordinating Council meetings and be responsible for carrying out the terms of this Executive Orders.

d. The Coordinating Council shall meet at least once each quarter and as otherwise requested by the chairperson.

Section 3. <u>Purpose</u>. The Coordinating Council shall:

a. Formulate policies and programs relating to all aspects of services and protocols for victims of domestic violence;

b. Develop methods to improve the coordination of systems and services for victims of domestic violence;

c. Create mechanism to ensure that each affected city agency responds appropriately to domestic violence situations and that there is coordination among the agencies involved; and

d. Launch public education campaign to heighten awareness of domestic violence and its devastating effects on society.

Section 4. Effective Date. This Order shall take effect immediately.
