D., Sanitary Superintendent and Register: SIR-There were 814 deaths reported to have occurred in this city during the week ending Saturday, January 15, 1887, which is an increase of 5, as compared with the number reported the preceding week, and 162 more than were reported during the corresponding week of the year 1886. The actual mortality for the week ending January 8, 1887, was 836, which is 172.4 above the average for the corresponding week for the past five years, and represents an annual death-rate of 29.74 per 1,000 persons hving, the population estimated at 1,461,466.
