

New York City Department of Correction
Monthly Report on Court Production
November 2025

Pursuant to Local Law 149 of 2023, the Department is required to report on a monthly basis an aggregate report on production of individuals in custody to scheduled court appearances. Court appearances are scheduled by the Office of Court Administration (OCA). Per Department policy, court refusals are treated as an anticipated use of force; individuals who refuse to go to their scheduled court appearance may be compelled to board the transportation vehicles to their designated court facility with force if necessary. The below data represents scheduled court appearances in the month of November 2025.
