HPD New Penn Development (210109 HAK)

An application submitted by the Department of Housing Preservation and Development (HPD), pursuant to Article 16 of the General Municipal Law of New York State, to designate three scattered sites, 306 Pennsylvania Avenue, 392 Wyona Street, and 467 Vermont Street/426 Wyona Street, as an Urban Development Action Area and an Urban Action Development Area Project (UDAAP), and the disposition of these properties to a developer selected by HPD. These actions are requested to facilitate three new buildings with a total of 46 affordable rental units in Brooklyn Community District 5 (CD 5). Eight of the apartments would be designated as Affordable Independent Residences for Seniors (AIRS).

Suydam Street Rezoning (200344 ZMK, 200343 ZRK, 200326 ZSK)

Applications submitted by Suydam Inc. and 3120 Willoughby LLC pursuant to Sections 197-c and 201 of the New York City Charter, for land use actions affecting 10 lots on a block, bounded by Suydam Street and Irving, Willoughby, and Wyckoff avenues. These include a zoning text amendment, to establish a new Special Mixed-Use (MX) R7D/M1-5 district consisting of seven lots; a zoning map amendment to map such

district, along with M1-5 and R6 districts within portions of the rezoning area, a zoning text amendment to designate a Mandatory Inclusionary Housing (MIH) area coterminous with the R7D/M1-5 district, and a special permit, to waive a requirement of 35 accessory parking spaces. Such actions are requested, to facilitate a 95-unit affordable residential building at 1250 Willoughby Avenue and enlarge an existing industrial building, at 349 Suydam Street in Brooklyn Community District 4 (CD 4).

300 Huntington Street (210049 ZMK, 210051 ZAK, N210056 LDK)

An application submitted by 300 Huntington Street LLC, pursuant to sections 197-c and 201 of the New York City Charter for a set of actions involving a block of the Gowanus Canal bounded by Huntington, Ninth, and Smith Streets. The applicant seeks a zoning map amendment to change the zoning district from M2-1 to M2-3, a Chairperson's Certification for Waterfront Public Access and Visual Corridors, and authorizations, to modify Waterfront Public Access Area (WPAA) requirements for grade changes, plantings, screening buffers, fences, and tree pits. Such actions would facilitate the construction of a 99,667 square foot manufacturing and commercial building at 300 Huntington Street, and a public esplanade along the adjacent portion of the Gowanus Canal in Brooklyn Community District 6 (CD 6).

Acme Fish (210138 ZMK, 210139 ZSK)

An application submitted by RP Inlet, LLC, pursuant to Sections 197-c and 201 of the New York City Charter for a zoning map amendment to change a block, bounded by Meserole and Wythe avenues, and Banker, Gem, and North 15th streets from M3-1 to M1-5, as well as a Large-Scale Development Special Permit by the City Planning Commission (CPC), to permit such development to exceed applicable height and setback requirements. These actions are requested, to facilitate a mixed-use building with approximately 488,480 square feet of commercial space, including office and retail, and 95,300 square feet of industrial space, to accommodate the relocation of the existing Acme Smoked Fish processing facility into the first phase of the intended construction, at 30 Gem Street, in Brooklyn Community District 1 (CD 1).

135-137 Bedford Avenue Rezoning (210043 ZMK)

An application submitted by Dawn Kiernan and NRL URF LLC pursuant to sections 197-c and 201 of the New York City Charter to map a C1-4 overlay on 11 blocks zoned R6A and R6B on the eastern side of Bedford Avenue between North 9th and North 10th streets. The requested zoning map amendment would facilitate a five-story, mixed-use building with seven dwelling units and approximately 3,253 square feet of commercial space at 135-137 Bedford Avenue in CD 1.

ORDER OF THE COMMISSIONER OF HEALTH AND MENTAL HYGIENE TO REQUIRE SCHOOLS TO MEET COVID-19 HEALTH AND SAFETY REQUIREMENTS

WHEREAS, on March 7, 2020, New York State Governor Andrew Cuomo issued Executive Order No. 202, declaring a State disaster emergency for the entire State of New York to address the threat that COVID-19 poses to the health and welfare of New York residents and visitors, and such order remains in effect; and

WHEREAS, on March 12, 2020, Mayor Bill de Blasio issued Emergency Executive Order No. 98 declaring a state of emergency in the City to address the threat posed by COVID-19 to the health and welfare of City residents; and such Emergency Executive Order directed the heads of all agencies, including the Department of Health and Mental Hygiene (the "Department"), to take all appropriate and necessary steps to preserve public safety and to render all required and available assistance to protect the security, well-being and health of the residents of the City, and such order remains in effect; and

WHEREAS, on March 25, 2020, pursuant to Section 3.01 of the New York City Health Code ("Health Code"), the existence of a public health emergency within the City as a result of COVID-19, for which certain orders and actions are necessary to protect the health and safety of the City of New York and its residents, was declared; and

WHEREAS, on September 4, 2020, Governor Cuomo issued Executive Order No. 202.60, authorizing schools to be open for in-person instruction subject to adherence to New York State Department of Health guidance and directives;

WHEREAS, the State Department of Health promulgated Interim Guidance for In-person Instruction at Pre-K to Grade 12 Schools During the COVID-19 Public Health Emergency on August 26, 2020 ("State Guidance for Pre-K to Grade 12 Schools" or "State Guidance"),¹ setting forth health and safety requirements that public and private schools must adhere to in order to provide in-person instruction during the COVID-19 pandemic, and requiring all schools to develop, in consultation with local health departments, a plan for reopening and operating during the COVID-19 pandemic, including a plan for the closure of school facilities and commencement of in-person instruction, if necessitated by widespread virus transmission; and

WHEREAS, the State Guidance provides (at p. 21, part C) that Responsible Parties should identify clearly defined measures that will serve as warning signs that the level of COVID-19 transmission may be increasing in the school setting beyond an acceptable level and must have a process to respond to COVID-19 cases at the school, including closing classrooms or the school in consultation with the local health department; and

WHEREAS, the New York City Department of Education's State-approved reopening plan² includes comprehensive COVID-19 health and safety protocols developed in consultation with the Department and is applicable to all New York City Department of Education schools; and

WHEREAS, pursuant to Section 558 of the New York City Charter (the "Charter"), the Board may embrace in the Health Code all matters and subjects to which the power and authority of the Department extends, and pursuant to Section 556 of the Charter and Section 3.01 of the Health Code, the Department is authorized to supervise the control of communicable diseases and conditions hazardous to life and health and take such actions as may be necessary to assure the maintenance of the protection of public health; and

WHEREAS, pursuant to Section 556 of the Charter, the Department is also authorized to promote or provide health services for school children in the City; and

WHEREAS, on September 28, 2020, I declared the continuance of a public health emergency and ordered certain schools in neighborhoods identified by certain ZIP codes where there is evidence of rapid growth of COVID-19 cases, and in other ZIP codes identified by the Department where incidence of COVID-19 is increasing, to meet additional requirements, including meeting the Department's protocols for closing a school if a student, teacher, or staff member is confirmed with a case of COVID-19; and

WHEREAS, in certain areas of the City COVID-19 incidence is increasing, despite efforts to combat the spread of COVID-19 such as physical distancing (also known as social distancing), face covering guidance, diagnostic testing, case investigation, contact tracing, isolation, and quarantine, and the incidence of disease in these areas is now persistently at or above 3% positivity, which is indicative of widespread community transmission that may risk increased incidence citywide; and

WHEREAS, outbreaks of COVID-19 have occurred in schools in the City, and I find that such outbreaks in schools create an unnecessary and avoidable risk of illness and endanger the health of those attending and associated with such schools, which could spread beyond the schools, and is therefore a nuisance, as defined in New York City Administrative Code §17-142; and

WHEREAS, pursuant to Health Code Section 3.07, no person “shall do or assist in any act which is or may be detrimental to the public health or to the life or health of any individual. . . or . . . shall fail to do any reasonable act or take any necessary precaution to protect human life and health;” and

WHEREAS, pursuant to Health Code Section 3.09, no person shall allow a nuisance to exist or to be created in respect to any matter, thing, chattel or premises which such person owns or controls; and

WHEREAS, pursuant to Section 2.6 of the New York State Sanitary Code and Section 11.03(e) of the Health Code, the Department is required to conduct an investigation to determine the sources of outbreaks of infectious diseases such as COVID-19, and takes steps necessary to prevent further infection and spread; and

WHEREAS, pursuant to Section 3.01 of the Health Code, I am authorized to issue orders and take actions that I deem necessary for the health and safety of the City and its residents when urgent public health action is necessary to protect the public health against an existing threat and a public health emergency has been declared pursuant to such section;

NOW THEREFORE I, Dave A. Chokshi, MD, MSc, Commissioner of Health and Mental Hygiene, finding that a public health emergency within New York City continues, and that it is necessary for the health and safety of the City and its residents, do hereby exercise the power of the Board of Health to prevent, mitigate, control and abate the current emergency, and, consistent with State Guidance for Pre-K to Grade 12 Schools, hereby order that in addition to the requirements described in the State Guidance, all non-public and charter schools in New York City shall comply with the following requirements:

- All individuals on non-public and charter school premises must remain at least 6 feet apart to the greatest extent possible, except in emergencies or when doing so would create a safety hazard, or when physical barriers are put in place between individuals in accordance with the State Guidance for Pre-K to Grade 12 Schools;
- All individuals must wear a face covering on non-public and charter school premises at all times, and during all off-site non-public and charter school activities, except: when individuals cannot wear a face covering because of developmental, medical, or age reasons; during snacks or meals when eating or drinking; during scheduled face covering breaks consistent with guidance issued by the Department; and during nap times;
- All non-public and charter schools must coordinate with the Department and the Test and Trace Corps to identify, isolate, and prevent the spread of COVID 19; and
- All non-public and charter schools must report every case of COVID-19 to the Department by calling 866-692-3641 and cooperate with the Department regarding closing and opening of classrooms or schools as the Department determines necessary to prevent the spread of COVID 19.

Students, teachers, staff members, volunteers, or any other individuals providing services in the non-public and charter school having close contact with confirmed cases of COVID-19 must quarantine for 14 days from such contact, in accordance with the State Department of Health's guidance for precautionary quarantine.

This Order amends and replaces the Order I issued on September 28, 2020, regarding additional requirements for certain schools in certain ZIP codes.

This Order shall be effective immediately and remain in effect through the end of the 2020-2021 school year, including any summer school sessions during 2021, or such earlier time as I may indicate, subject to the authority of the Board of Health to continue, rescind, alter or modify this Order pursuant to Section 3.01 of the Health Code.

Failure to comply with an Order of the Commissioner is a violation of the Health Code and a misdemeanor for which you may be subject to civil and criminal penalties, including fines, forfeitures, and imprisonment.

ORDER OF THE COMMISSIONER OF HEALTH AND MENTAL HYGIENE FOR BUSINESS CLOSURES FOR NON-COMPLIANCE WITH COVID-19 HEALTH AND SAFETY REQUIREMENTS

WHEREAS, on March 7, 2020, New York State Governor Andrew Cuomo issued Executive Order No. 202, declaring a State disaster emergency for the entire State of New York to address the threat that COVID-19 poses to the health and welfare of New York residents and visitors, and such order remains in effect; and

WHEREAS, on March 12, 2020, Mayor Bill de Blasio issued Emergency Executive Order No. 98 declaring a state of emergency in the City to address the threat posed by COVID-19 to the health and welfare of City residents; and such Emergency Executive Order directed all agencies, including the Board of Health (“Board”) and the Department of Health and Mental Hygiene (“Department”), to take all appropriate and necessary steps to preserve public safety and to render all required and available assistance to protect the security, well-being and health of the residents of the City, and such order remains in effect; and

WHEREAS, on March 25, 2020, pursuant to Section 3.01 of the New York City Health Code (“Health Code”), the existence of a public health emergency within the City as a result of COVID-19, for which certain orders and actions are necessary to protect the health and safety of the City of New York and its residents, was declared; and

WHEREAS, on April 15, 2020, Governor Cuomo issued Executive Order No. 202.17 requiring all persons over 2 years of age who are medically capable, to wear a face covering when in a public place and not maintaining social distance, and subsequent Executive Orders required businesses opening and operating pursuant to the New York Forward plan to comply with the relevant guidance for their business as issued by the New York State Department of Health (“NYSDOH”), and such guidance documents require employees to wear a face covering when in direct contact with customers or members of the public and unable to maintain 6 feet of distance from another person; and

WHEREAS, on September 9, 2020, Governor Cuomo issued Executive Order No. 202.61, allowing indoor food services and dining to resume in New York City beginning September 30, 2020, and on or about September 11, 2020, NYSDOH issued guidance requiring food service establishments resuming indoor service to limit indoor capacity to no more than 25% of maximum occupancy; to restrict seating or service at the bar; to ensure that employees wear a face covering at all times; and to implement mandatory daily health screening practices of their employees, and such restrictions may be further adjusted in subsequent NYSDOH guidance or orders of the Governor; and

WHEREAS, as part of the State's phased reopening, non-essential gatherings in public places in Phase 4 regions are limited to 50 or fewer people, and pursuant to the Governor's Executive Order 202.68 issued on October 6, 2020¹, non-essential gatherings are further restricted in locations designated by the State as cluster-based zones, and such restrictions may be further adjusted in subsequent orders of the Governor; and

WHEREAS, pursuant to Governor's Executive Order No. 202.74, issued November 12, 2020, food service establishments are required to cease all on-premises service and consumption of food and beverage no later than 10:00 pm each day and non-essential gatherings in private residences are limited to 10 or fewer people, and such restrictions may be further adjusted in subsequent orders of the Governor; and

WHEREAS, pursuant to Section 558 of the New York City Charter (the “Charter”), the Board may embrace in the Health Code all matters and subjects to which the power and authority of the Department extends, and pursuant to Section 556 of the Charter and Section 3.01 of the Health Code, the Department is authorized to supervise the control of communicable diseases and conditions hazardous to life and health and take such actions as may be necessary to assure the maintenance of the protection of public health; and

WHEREAS, pursuant to Section 556(a)(5) of the Charter, the Department may arrange, with the approval of the Mayor, for the rendition of services by other City agencies; and

WHEREAS, on October 1, 2020, I arranged for various other City agencies and offices to enforce violations of State and local COVID-19 health and safety requirements as violations of Section 3.07 the Health Code, including ordering the closure of businesses when there was repeated noncompliance with such requirements ("October 1, 2020 Order"); and

WHEREAS, incidence of COVID-19 is increasing in the City, despite efforts to combat the spread of COVID-19, such as diagnostic testing, case investigation, contact tracing, isolation, and quarantine; and

WHEREAS, because of the rapid, marked, and sustained increase in COVID-19 positivity rates throughout the City, it is now necessary to allow for the immediate closure of businesses that fail to comply with State and local COVID-19 health and safety requirements; and

WHEREAS, failure to adhere to the necessary precautions to prevent the spread of COVID-19 in restaurants and other businesses, as described in the Governor's Orders and NYSDOH guidance documents, including ensuring that employees wear a face covering when in direct contact with customers or members of the public, having a process in place for employee health screening, limiting indoor dining capacity to no more than 25% maximum occupancy, and restricting food service establishments from providing seating at the bar, creates an unnecessary and avoidable risk of illness and endangers the health of City residents, and is therefore a nuisance, as defined in New York City Administrative Code §17-142; and

WHEREAS, pursuant to Health Code Section 3.07, no person "shall do or assist in any act which is or may be detrimental to the public health or to the life or health of any individual [or] shall fail to do any reasonable act or take any necessary precaution to protect human life and health;" and

WHEREAS, pursuant to Health Code Section 3.09, no person shall allow a nuisance to exist or to be created in respect to any matter, thing, chattel or premises which he or she owns or controls; and

WHEREAS, pursuant to Section 2.6 of the New York State Sanitary Code and Section 11.03(e) of the Health Code, the Department is required to conduct an investigation to determine the sources of outbreaks of infectious diseases such as COVID-19, and to take steps necessary to prevent further infection and spread; and

WHEREAS, pursuant to Section 3.01(d) of the Health Code, I am authorized to issue orders and take actions that I deem necessary for the health and safety of the City and its residents when urgent public health action is necessary to protect the public health against an existing threat and a public health emergency has been declared pursuant to such section; and

WHEREAS, pursuant to Section 3.01(c) of the Health Code, the Department is authorized to take such action as may be necessary to assure the maintenance of public health, the prevention of disease, or the safety of the City and its residents;

NOW THEREFORE I, Dave A. Chokshi, MD, MSc, Commissioner of Health and Mental Hygiene, finding that a public health emergency within New York City continues, and that it is necessary for the health and safety of the City and its residents, do hereby exercise the power of the Board of Health to prevent, mitigate, control and abate the current emergency, and, hereby order that, in accordance with Section 556(a)(5) of the Charter, the Department, the Police Department, the New York City Sheriff, the Fire Department, the Department of Buildings, the Department of Consumer and Worker Protection, the Office of the Mayor, acting through the Office of Special Enforcement, which shall be deemed for this purpose to include employees of any other agency detailed thereto, and any other City agency having jurisdiction over businesses affected by this Order, may enforce violations of State and City COVID-19 health and safety requirements as violations of Section 3.07 of the Health Code, including ordering the immediate closure of businesses where there is noncompliance with any such requirement.

FURTHER, I hereby order that any business or entity ordered to close pursuant to an Order issued by any such office or agency must remain closed pending submission to the Department of a corrective action plan specifying how the business or entity will maintain ongoing compliance with all applicable State and City directives and guidance, and receipt of written approval from the Department authorizing the business or entity to reopen. Within 3 business days after submission of the corrective action plan, the Department will either provide such written approval or indicate to the business or entity that such submitted plan does not allow for the continued compliance with the applicable State and City directive and guidance.

FURTHER, I hereby RESCIND the October 1, 2020 Order relating to enforcement of violations of State and City COVID-19 health and safety requirements, which is hereby REPLACED by this Order, so that any action, order or requirement of such October 1, 2020 Order is continued and may be enforced as if it were issued under this Order.

ORDER OF THE COMMISSIONER OF HEALTH AND MENTAL HYGIENE OF THE CITY OF NEW YORK FOR THE COVID-19 NYC TEST AND TRACE CORPS PROGRAM

TO: Individuals who have been identified as cases or suspected cases of COVID-19, and individuals who have been identified as contacts of cases or suspected cases of COVID-19

WHEREAS, the Governor, the Mayor and the Commissioner of Health and Mental Hygiene have declared emergencies in response to the threat posed by COVID-19, and such emergencies continue; and

WHEREAS, on October 31, 2020, the Governor issued Executive Order No. 205.2 requiring all travelers entering New York from anywhere other than Connecticut, Massachusetts, New Jersey, Pennsylvania or Vermont to quarantine for a period up to 14 days, in order to protect New York from community transmission of COVID-19; and

WHEREAS, the COVID-19 NYC Test and Trace Corps Program identifies individuals who are cases, suspected cases, and contacts of cases or suspected cases, as defined in section 11.01 of the New York City Health Code (the "Health Code"), and advises them of the need to quarantine or isolate themselves to prevent further spread of COVID-19, and offers them medical and supportive services (the "Test and Trace Program"); and

WHEREAS, section 556 of the New York City Charter (the "Charter") and section 3.01 of the Health Code authorize the Department of Health and Mental Hygiene (the "Department") to supervise the control of communicable diseases and conditions hazardous to life and health and take such actions as may be necessary to assure the maintenance of the protection of public health; and

WHEREAS, section 11.23 of the Health Code authorizes the Department to take appropriate steps when a case, contact, or carrier of a contagious disease, or a suspected case, contact or carrier of a contagious disease may, in the opinion of the Commissioner of Health and Mental Hygiene, pose an imminent threat to the public health resulting in severe morbidity or high mortality;

NOW, THEREFORE, I hereby order that:

1. The Test and Trace Program shall continue to contact individuals who have been identified as cases or suspected cases of COVID-19, or as contacts of cases or suspected cases of COVID-19, or as having traveled from a location that requires they quarantine in New York City ("Contacted Individuals") to provide them with information about the need to quarantine or isolate in accordance with guidance from the Department and the State Department of Health.
2. Contacted Individuals who are required to quarantine or isolate should remain in quarantine or isolation for the time specified by the Test and Trace Program.
3. During Contacted Individuals' period of isolation or quarantine they shall communicate with the Test and Trace Program to determine whether they are remaining in quarantine or isolation or are in need of any services.

Contacted Individuals may at any time apply to request release from this Order. Please email the Office of the General Counsel, New York City Department of Health and Mental Hygiene, 42-09 28th Street, Long Island City, NY 11101-4132; OGC@health.nyc.gov. Requests made outside of business hours will be considered as soon as possible.
