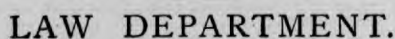

DEPARTMENT OF DOCKS.

At a meeting of the Board of Docks of the City of New York, held at the office of the Board, Pier "A," Battery place, Thursday, October 19, 1893, at 11 o'clock A. M.

Present—President Cram.
" Commissioner Phelan.

The minutes of the meeting held on the 12th instant were read and approved.

Henry R. Beekman, attorney, appeared, and requested the Board to take action respecting the purchase of the premises between Ninety-sixth and Ninety-seventh streets, North river.

On motion, the Counsel to the Corporation was requested to advise the Board whether it has the power to purchase water-front property where no new plan has been adopted by the Department.

On motion, the matter of the purchase of a steam derrick, for use on Pier, old 42, North river, was tabled for one week.

The communication from the Engineer-in-Chief respecting the improvement of the water-front between Eighth and Seventeenth streets, East river, was tabled for two weeks.

The following communications were referred to the Engineer-in-Chief to examine and report:
From James P. Carson—Requesting an extension of forty days to complete the work of dredging at Piers, new 40 and 59, North river, under Contract No. 460.

From Michael Mitchell, lessee—Requesting dredging at the Pier foot of West Thirty-fifth street.

The following permit was granted, the work to be done under the supervision of the Engineer-in-Chief, and to be kept within existing lines:

New York, New Haven and Hartford Railroad Company—To cut gangways and drive fender piles at Pier 49, East river.

From the Finance Department—Inclosing copy of a communication from the Counsel to the Corporation approving the title to the pier and wharf property purchased from the West Shore and Ontario Terminal Company, September 17, 1891, and requesting a requisition for the amount. The Chief Clerk directed to prepare the necessary requisition.

From the Department of Street Cleaning—Requesting dredging at the dump foot of West Twelfth street.

From the Department of Public Works—Stating that repairs will be made to the pavement north of the seventy foot line at Pier, old 24, East river.

From the Fort Lee Park and Steamboat Company—Reporting the removal of the shed from the Pier at West Thirteenth street.

From Matthew J. Stripp, Jr.—Requesting a lease of the bulkhead between Piers, new 21 and 22, North river. Application denied.

From the New York Central and Hudson River Railroad Company—Requesting that the taxes and Croton water rents on the property foot of Harrison street, North river, be remitted from the date this Department entered into possession of said property. Notify the Comptroller that the Department entered into possession October 10, 1891.

From Gilbert M. Speir, Jr., attorney—Declining, on behalf of his client, Casimir de R. Moore, the offer of September 25, 1893, to purchase his riparian and wharfage rights in the premises between Twenty-second and Twenty-third streets, North river.

On motion, the following preambles and resolution were adopted:

Whereas, This Department, on the 25th day of September, 1893, adopted preambles and resolutions offering to purchase in the name and for the benefit of the corporation of the City of New York, all riparian and wharfage rights and interests in or annexed to or appurtenant to the premises between Twenty-second and Twenty-third streets, North river, on the Thirteenth avenue; and

Whereas, Said offer was, on the 27th day of September, 1893, served upon Gilbert M. Speir, Jr., attorney for Casimir de R. Moore, who is the agent and representative of William T. Moore and the heirs of Mary C. Ogden, owners in fee simple of said property; and

Whereas, Said offer has not been accepted, although more than ten days have elapsed since the expiration of the time to do so; and

Whereas, It is deemed that no price can be agreed upon between the owners of said property and this Department for the purchase thereof;

Therefore, be it Resolved, That the Counsel to the Corporation of the City of New York be and is hereby requested to institute legal proceedings for the immediate acquisition of said property rights, terms, easements and privileges for the Mayor, Aldermen and Commonalty of the City of New York as required by law in such cases made and provided.

From Dock Master Martin:

1st. Reporting the sinking of a canal boat, at the Pier foot of West One Hundred and Fifty-eighth street on the 19th instant. Owners and consignees notified to remove.

2d. Reporting that repairs are required to the Pier at One Hundred and Fifty-second street, North river, and that the Bulkhead foot of West Ninety-sixth street requires cleaning. The Engineer-in-Chief directed to do the work.

From Dock Master Abeel—Reporting repairs required to the pavement on the bulkhead at Pier, new 34, North river. The Engineer-in-Chief directed to repair.

The Treasurer, to whom was referred, September 25, 1893, the communication from the Engineer-in-Chief, respecting the reduction for overtime to be charged Sheridan & Byrne for the non-completion of Contract No. 437 within the time specified in said contract, submitted a report, recommending that the time be extended until September 14, 1893, and that no further contracts of a similar nature with this Department be awarded said contractors.

On motion, the report was approved, and the following resolution adopted:

Resolved, That the time for the completion of the work of building an iron awning shed on the Pier foot of West Thirty-fourth street, Sheridan and Byrne contractors, be and hereby is extended to September 14, 1893.

The Treasurer, Commissioner Phelan, submitted his report of receipts for the week ending October 18, 1893, amounting to \$22,101.64, which was received and ordered to be spread in full on the minutes as follows:

TO OWNERS OF LANDS ORIGINALLY ACQUIRED BY WATER GRANTS.

ATTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1889), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty containing covenants requiring the grantees and their successors to pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repavement, the Common Council may, by ordinance, require the same to be paved, repaved or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property (who shall also be the owners of a majority of the property in frontage) on the line of the proposed improvement.

The act further provides that the owner of any such lot may notify the Commissioner of Public Works, in writing, specifying the ward number and street number of the lot that he desires, for himself, his heirs and assigns, to be released from the obligation of such covenants, and elects and agrees that said lot shall be thereafter liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns shall thenceforth be relieved from any obligation to pave, repair, uphold or maintain said street, and the lot in respect of which such notice was given shall be liable to assessment accordingly.

The Commissioner of Public Works desires to give the following explanation of the operation of this act: When notice, as above described, is given to the Commissioner of Public Works, the owner of the lot or lots therein described, and his heirs and assigns, are forever released from all obligation under the grant in respect to paving, repaving or repairing the street in front of or adjacent to said lot or lots, except one assessment for such paving, repaving or repairs, as the Common Council may, by ordinance, direct to be made thereafter.

No street or avenue within the limits of such grants can be paved, repaved or repaired until said work is authorized by ordinance of the Common Council, and when the owners of such lots desire their streets to be paved, repaved or repaired, they should state their desire and make their application to the Board of Aldermen and not to the Commissioner of Public Works, who has no authority in the matter until directed by ordinance of the Common Council to proceed with the pavement, repavement or repairs.
