The 792 deaths represent a death-rate of 21.88 against 21.28 for the previous week, and 24.67 for the corresponding week of 1892.

The increase of 22 deaths was mainly due to an increase of 10 in the deaths from diphtheria, of 26 from phthisis, of 18 from diseases of the digestive organs, and of 7 from violence, partially offset by a decrease of 15 in the deaths from heart disease, and of 27 in the deaths from pneumonia.

The deaths from diphtheria were most numerous in the Twelfth Ward, from measles in the Twenty-first Ward, and from scarlet fever in the Seventh Ward.

The Mayor then offered the following resolution :

Resolved, That Canal street, from the Bowery to East Broadway, be lighted by about seven (7) electric lamps ; Gold street, from John street to Spruce street, by about three (3) electric lamps ; Pearl street, from Old Slip to Fulton street, by about nine (9) electric lamps ; State street, from Pearl street to Bowling Green, by about three (3) electric lamps ; Morton street, from Greenwich street to Washington street, be lighted by two (2) electric lamps ; Wooster street, from Broome street to Spring street, by about three (3) electric lamps ; Duane street, from Broadway to Church street, by one (1) electric lamp ; White street, from Broadway to West Broadway, by about two (2)

electric lamps; and Reade street, from Hudson street to Church street, by about two (2) electric lamps, at the rate of forty cents (40c.) per night for each lamp, and the Commissioner of Public Works is hereby requested to cause this resolution to be carried into effect.

Which was adopted by the following vote:

Affirmative—The Mayor, the Comptroller and the Commissioner of Public Works.

NEW YORK, June 1, 1893.

DEAR SIR—I have the honor to inform you of the adoption of the following resolution at a meeting of the Board of Parks, held on the 31st ultimo:

Resolved, That the Gas Commission be respectfully requested to cause one electric lamp to be placed and lighted in each of the following-named small parks: Abingdon Square, Jackson Square and Christopher Street Park.

The Secretary stated that petitions had been received for the lighting of Franklin avenue and One Hundred and Forty-fifth street (Springhurst) in Twenty-third Ward by electric lamps, which papers were laid over the last meeting.

The Mayor then offered the following resolution:

Resolved, That Franklin avenue, from Third avenue to Crotona Park, be lighted by about twelve electric lamps, and One Hundred and Forty-fifth street, from the Southern Boulevard to Tiffany street, by about four electric lamps, at the rate of forty-five cents per night for each lamp, and the Commissioner of Public Works is hereby requested to cause this resolution to be carried into effect.

Which was adopted by the following vote:

Affirmative—The Mayor, the Comptroller and the Commissioner of Public Works.

The Secretary reported that Church street, from Chambers street to Canal street, has not yet been lighted by electric lamps by the Thomson-Houston Electric Company, as required by their contracts.

The following communication was received:

NEW YORK, June 29, 1893.

To the Gas Commission:

GENTLEMEN—The Thomson-Houston Electric Company of New York, of the additional lights in their contract have lighted Avenue A, First avenue, Fourth avenue, Fourteenth to Forty-second streets, Irving place and Bryant Park. There remain but three lights on Fourth avenue and seven on Church street; on the latter street we have a subway for which we are now paying rent, but cannot get to it from our other subways at present. Within a few days we hope to obtain permission to connect through another company's duct, when we can light these few remaining lights.

ATTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1889), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty containing covenants requiring the grantees and their successors to pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repavement, the Common Council may, by ordinance, require the same to be paved, repaved or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property (who shall also be the owners of a majority of the property in frontage), on the line of the proposed improvement.

The act further provides that the owner of any such lot may notify the Commissioner of Public Works, in writing, specifying the ward number and street number of the lot that he desires, for himself, his heirs and assigns, to be released from the obligation of such covenants, and elects and agrees that said lot shall be thereafter liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns shall thenceforth be relieved from any obligation to pave, repair, uphold or maintain said street, and the lot in respect of which such notice was given shall be liable to assessment accordingly.

The Commissioner of Public Works desires to give the following explanation of the operation of this act: When notice, as above described, is given to the Commissioner of Public Works, the owner of the lot or lots therein described, and his heirs and assigns, are forever released from all obligation under the grant in respect to paving, repaving or repairing the street in front of or adjacent to said lot or lots, except one assessment for such paving, repaving or repairs, as the Common Council may, by ordinance, direct to be made thereafter.

No street or avenue within the limits of such grants can be paved, repaved or repaired until said work is authorized by ordinance of the Common Council, and when the owners of such lots desire their streets to be paved, repaved or repaired, they should state their desire and make their application to the Board of Aldermen and not to the Commissioner of Public Works, who has no authority in the matter until directed by ordinance of the Common Council to proceed with the pavement, repavement or repairs.
