J. A. BENSEL, Esq., Commissioner of Docks:

Sir—I have the honor to submit the following report of work done under my charge and supervision for the quarter ending June 30, 1906:

Battery Wall, North River.

The existing platforms at this locality and the steamboat landing have been maintained during the quarter, and some repairs have been made to the steamboat landing.

Boat Landing, Pier "A," North River.

The boat landing has been maintained during the quarter and the float inside the landing has been repaired from time to time when needed.

Rector Street Section, North River.

The work at this section is being done under authorization of the Commissioner of Docks of December 16, 1903, and is at the cost and expense of the owners of the property to be improved. During the quarter cobble and riprap have been inspected and deposited in rear of the bulkhead wall. Pier (old) 7 is being removed and a temporary approach is being built to Pier (new) 7.

Cedar Street Section, North River.

By action of the Commissioner of Docks of December 10, 1902, a section of the bulkhead wall was authorized in the vicinity of Cedar street, extending from the middle of the block between Carlisle and Albany streets northerly to a point about 40 feet southerly of the northerly line of Cedar street. This work includes the removal of the old structures and Piers (old) 13 and 14, together with the sheds thereon. The building of the wall proper was practically completed during the prior quarter, and during the present quarter joints in the granite have been pointed.

A pier to be known as Pier 11 had been finished by the Department force as far as it was intended at the time, and a ferry rack was constructed at the outer end of the pier preparatory to the work to be done by the Central Railroad Company of New Jersey on its new ferry. During the quarter just past the Department force has done some further work in the construction of this pier made possible by the removal of the old ferry rack at this locality.

Piers (New) 20 and 21, North River.

These piers are being extended out to the pierhead line by the force of the Department for the Erie Railroad Company, and the work has been in progress during the quarter.

Pier (New) 40, North River.

The New England Navigation Company has, during the quarter, extended the freight shed at this pier and erected a shed on the bulkhead under a permit from this Department.

Chelsea Section, North River.

On the 28th of December, 1900, the Board of Docks authorized the construction of a section of the bulkhead wall between Bloomfield and West Twenty-third streets. Large property interests in this vicinity have in the past been acquired and extensive work done towards the construction of the wall, until at the present time the wall proper has been practically completed for the entire length of the section. The actual wharfage room made during the quarter is 2,025 linear feet. Fire walls have been built across the platforms between Fifteenth and Sixteenth and between Seventeenth and Eighteenth streets. The old ferry house at Twenty-third street is being removed and preparations made for the sewer between Twenty-second and Twenty-third streets. A contract, No. 1,006, has been awarded for paving between Twenty-second and Twenty-third streets and for a portion of Twenty-second street, between Eleventh and Thirteenth avenues.

Pier (New) 54, North River.

The construction of a new pier, to be known as Pier 54, at the foot of Thirteenth street has been in progress during the quarter, under Contract No. 949, and a contract has been awarded for asphaltating the deck of the pier.

Pier (New) 56, North River.

The construction of a new pier, to be known as Pier 56, near the foot of Fourteenth street has been in progress during the quarter, under Contract No. 941, and a contract has been awarded for asphaltating the deck of the pier.

Pier (New) 57, North River.

During the present quarter the concrete deck of this pier has been covered with asphalt, under a contract, No. 936, awarded therefor.

Pier (New) 58, North River.

During the present quarter the concrete deck of this pier has been covered with asphalt under Contract No. 936.

Pier 59, North River.

A contract, No. 996, has been awarded for paving with asphalt the deck of this pier.

Rebuilding the Terminals of the Delaware, Lackawanna and Western Railroad Company and the Central Railroad Company of New Jersey.

On the 20th of December, 1905, a disastrous fire occurred in these premises, starting at the upper end of the ferryhouse of the Delaware, Lackawanna and Western Railroad Company, and in a short time destroying both the terminals of that company and the Central Railroad Company of New Jersey, adjoining the same on the south. The companies affected by this fire immediately started to rebuild the destroyed structures, and during the quarter the work has been in progress. The charred timbers have been removed and the pier at Twenty-second street has been repaired. A temporary approach to the ferry has been built and a fire wall has been built across the pier at Twenty-second street.

West Thirty-second Street, North River.

An extension to the pier has been built by the Pennsylvania, New York and Long Island Railroad Company, under a permit from this Department under Bureau Orders 4013 and 4024.

West Forty-second Street Section, North River.

By an order from the Engineer-in-Chief, dated November 14, 1905, sections originally known as West Forty-second Street Section, West Forty-second Street Section Extended and West Forty-third Street Section were consolidated. The wall was practically completed, with the exception of the coping for all the portion except that extending across the foot of West Forty-second street during a prior order. During the present quarter earth filling has been deposited in rear of the bulkhead wall, between Forty-second and Forty-third streets. During the present quarter a temporary approach has been built to Pier 83 near the foot of West Forty-third street.

Pier (New) 83, North River.

The work of constructing a new pier, to be known as Pier 83, near the foot of West Forty-third street, under Contract No. 919, has been completed during the quarter.

Between West Fifty-sixth and West Fifty-seventh Streets, North River.

In this locality the Department is preparing for and constructing a large storehouse, with offices, etc., for the use of the Department. Work is being done under Contract No. 987.

Clarendon Section.

The work at this section is being done under resolution of the Board of Docks, passed November 16, 1900. During the past quarter work on the wall proper has been in progress, a number of concrete blocks being set in the wall. Filling is being placed in rear of that portion of wall built. A temporary approach is being arranged at West One Hundred and Thirty-first street.

Pier West One Hundred and Thirty-third Street, North River.

The work of constructing an extension to this pier is in progress by the force of the Department.

Between Spuyten Duyvil and Mount Saint Vincent.

The New York Central and Hudson River Railroad Company is widening the present railroad embankment between these two points, and riprap is being deposited along the line of the widening under permit from the Commissioner of Docks.

Marginal Street, North River.

A contract awarded during the prior quarter with the Sicilian Asphalt Paving Company has been in progress. Under this contract the work of laying the concrete foundation and asphalt pavement on the marginal street along the North river has been done. Repairs have also been made where necessary to the asphalt pavement already laid by the Uvalde Asphalt Paving Company under its various bonds to maintain the pavement in good condition. A contract has also been awarded for repairing the asphalt pavement on the North and East rivers, to be known as Contract No. 993, and work has been begun thereunder.

Whitehall Terminal, East River.

The work of constructing a new ferry terminal at this point for a municipal ferry to Staten Island is in progress. The work of removing the old ferryhouse is being done and two of the slips have been completed. A contract has been prepared and let for the construction of the temporary waiting-room to be used prior to the entire tearing down of the old ferryhouse. Work on this temporary waiting-room has been completed during the quarter.

Broad Street Section, East River.

Work at this section, which is being done under resolution of the Board of Docks of December 22, 1899, was completed a few years ago as far as could be done until possession of inner end of Pier 7 was obtained. During the past quarter work has been resumed at this portion of the section, and a foundation for the wall is being built across the inner end of Pier 7. A temporary approach was built to the pier and a portion of the inner end of the pier removed to make way for the construction of the bulkhead wall.

Old Slip Section, East River.

The Commissioner of Docks, on December 7, 1904, issued the necessary authorization for the construction of the bulkhead wall from the northerly side of Pier (new) 7, where it joins the Broad Street Section, to the westerly side of Burling slip, East river. This stretch of wall is divided into two sections, the Old Slip Section and the Maiden Lane Section. The Old Slip Section extends from the northerly or upper end of the Broad Street Section, and runs along the established bulkhead line to a point opposite the southerly line of Wall street. This section contemplates the erection of four new piers to be known as Piers 8, 9, 10 and 11. During the quarter the work of construction of bulkhead wall proper has been in progress. Temporary approaches have been built to the piers and earth filling is being deposited in rear of the wall.

Pier 8, East River.

The work of constructing this pier, under Contract No. 923, has been completed during the quarter, and about 1,197 linear feet of new wharfage room made by the work done.

Pier 9, East River.

The work of constructing this pier, under Contract No. 968, was begun on February 28, 1906, and is in progress.

Pier 10, East River.

This pier was completed during a prior quarter.

Pier 11, East River.

This pier was completed during a prior quarter.

Storage of Concrete Material on Pier 8, East River, and Making Concrete Blocks.

It having been thought advisable to provide a place in the lower part of the city where concrete material could be stored, the outer end of this pier was fitted up during a prior quarter with a derrick for handling material, and broken stone, sand and cement have been stored at this locality.

Maiden Lane Section, East River.

By authorization of the Commissioner of Docks, dated December 7, 1904, the construction of the bulkhead wall along this stretch of waterfront has been ordered. The work extends from the southerly line of Wall street, where it joins the Old Slip Section, to about the southerly line of Burling slip. Work on the bulkhead wall proper has been in progress during the quarter, and about 335 linear feet of new wharfage room has been made by the work done. Earth filling is being placed in rear of that portion of the wall built. Temporary approaches have been built to the piers in this section, and the section embraces Piers 12, 13, 14 and 15. Pier (new) 12 was built in 1901; Piers (new) 14 and 15 were built in 1905, and Pier (new) 13 was built during the first quarter of 1906.

Fulton Section, East River.

This section of the bulkhead wall was authorized by the Board of Docks on April 26, 1901. This resolution was amended by action of the Commissioner of Docks on December 7, 1904. During the past quarter no work has been done on the bulkhead wall proper. Filling, however, has been placed in rear of that portion of the wall built. This section embraces Piers (new) 16, 17 and 18. Pier (new) 16 was built in 1901; Pier (new) 17 was built in 1905, and Pier (new) 18 was built during the previous quarter.

Peck Slip Section, East River.

No work has been done on the bulkhead wall proper at this section during the quarter, but the temporary approach was removed to make way for pavement at Pier 20, and second-hand paving blocks were laid at this locality.

Market Street Section, East River.

The authorization for this section is the resolution of the Board of Docks passed February 28, 1900. During the quarter work has been in progress on the bulkhead wall proper and no new wharfage room has been made along this section. Earth filling has been deposited in rear of the wall.

Pier Eighteenth Street, East River.

The pier at the foot of this street has been reconstructed in accordance with new plan line by the force of the Department, the work having been completed on the 12th of May, 1906.

Between Sixty-fourth and Sixty-fifth Streets, East River.

A temporary platform has been constructed along the established bulkhead line by the force of the Department.

Between Sixty-ninth and Seventieth Streets, East River.

A temporary platform is being constructed in this locality along the established bulkhead line by the force of the Department and is practically completed, 252 linear feet of new wharfage room being made by the work done.

Blackwell Section, East River.

By action of the Commissioner, October 10, 1904, Bureau Order 2756, the work of improving the waterfront, which was being done under resolution for the East Seventy-fourth, East Seventy-fifth and East Seventy-seventh street sections consolidated in a new section established as Blackwell Section, beginning at the southerly line of East Seventy-fourth street and extending to the northerly line of East Eighty-first street, a distance of 1,958.03 feet. A portion of the section in the neighborhood of East Seventy-fourth street was practically completed for quite a strip of wall during a previous quarter, and the work at this particular point has been suspended until the wall in the other section makes a joint with it. During the present quarter work on other portions of the section has been in progress between Seventy-fifth and Seventy-eighth streets, and about 95 linear feet of new wharfage room has been made by that portion of the work done.

East One Hundred and Second Street Section.

The work at this section has been done under resolution of the Board of Docks, passed July 17, 1890. This section was completed a number of years ago, but during the past quarter holes were drilled in the coping and seventeen mooring posts were placed.

Between Two Hundred and Thirteenth and Two Hundred and Fourteenth Streets, Harlem River, Manhattan Side.

A small pier and machine shop have been built at this locality by Messrs Stittman & Pitt, under a permit from the Commissioner of Docks.

North of One Hundred and Fifty-ninth Street, Harlem River, Manhattan Side.

A bulkhead platform has been built and other improvements are being made at this locality by the Interborough Rapid Transit Company, under a permit from the Commissioner of Docks. This work was begun September 1, 1905, and is in progress.

Marble Hill, Spuyten Duyvil, Harlem River, Manhattan Side.

The New York Central and Hudson River Railroad Company is constructing a new roadbed in connection with the Marble Hill cut-off at this locality, under a permit from the Commissioner of Docks. This work was begun July 20, 1904, and is in progress.

One Hundred and Thirty-eighth Street, Mott Haven Canal.

Foundations for a coal pocket are being rebuilt by Olin J. Stephens under a permit from the Commissioner of Docks. This work was commenced June 4, 1906, and is in progress.

One Hundred and Forty-ninth Street, Harlem River.

The Pioneer Real Estate Company is building ferry slip, crib bulkhead, transfer bridge, freight house and freight terminal south of One Hundred and Forty-ninth street, in accordance with permit from the Commissioner of Docks. Work was commenced February 27, 1906, and is in progress.

One Hundred and Forty-ninth Street, Port Morris.

The New York Central and Hudson River Railroad Company is building a power station, pier slip and concrete bulkhead at this locality under permit from the Commissioner of Docks. Work was begun June 1, 1904, and is in progress.

One Hundred and Fiftieth Street, East River, Oak Point.

The Rock Plaster Company of New York and New Jersey is building a crib bulkhead at this locality and filling in behind same under permit from the Commissioner of Docks.

Putnam Avenue Railroad Bridge to High Bridge.

A pile and timber trestle is being built, same to be filled with riprap, by the New York Central and Hudson River Railroad Company, under permit from the Commissioner of Docks. Work was commenced July 25, 1904, and is in progress.

Between Fourth and Fifth Streets, Westchester Creek.

A bulkhead platform is being restored and rebuilt at this locality by M. J. Leahy, under permit from the Commissioner of Docks.

Between Cabot and Tiffany Streets, East River.

The Oak Point Land and Dock Company is building four piers at this locality in accordance with permit from the Commissioner of Docks. Work was commenced on the 17th of May, 1906, and is in progress.

Between Dupont and Tiffany Streets, East River.

The Oak Point Land and Dock Company is erecting bulkheads and filling in at this locality in accordance with permit from the Commissioner of Docks. This work was begun May 3, 1906, and is in progress.

BOROUGH OF BROOKLYN.

West of Greenpoint Avenue, Newtown Creek.

Storage sheds and tank have been erected at this locality by the Rockland-Rockport Lime Company, under permit from the Commissioner of Docks. This work was begun August 10, 1905, and completed May 15, 1906.

Foot of Huron Street.

The Estate of Henry Steers is erecting a pier and a shed thereon at this locality, in accordance with permit from the Commissioner of Docks. The work was commenced May 15, 1906, and is in progress.

Foot of India Street.

A pier is being constructed at this location by the Estate of Henry Steers, under permit from the Commissioner of Docks. Work was commenced February 8, 1906, and is in progress.

Division Avenue, Wallabout Canal.

The Transit Development Company is building an ash pocket and coal handling tower at this locality, in accordance with a permit from the Commissioner of Docks. This work was begun on May 1, 1906, and is in progress.

Foot of Gold Street.

The Kings County Electric Light and Power Company is rebuilding the bulkhead wall and building foundations, screening wells, etc., at this locality under permit from the Commissioner of Docks. Work was commenced April 6, 1905, and is in progress.

Bridge Street, Brooklyn.

The Jay Street Terminal Company is removing Pier (old) 3 and constructing Pier (new) 2 with bulkhead at this location under permit from the Commissioner of Docks. Work was commenced March 12, 1906, and is in progress.

Montague Street, Brooklyn.

The New York Dock Company is constructing Piers 10, 11, 12 and 13 at this locality under permit from the Commissioner of Docks. Work was commenced May 8, 1905, and is in progress. The same company is building pier sheds on the above piers under permit from the Commissioner of Docks. This work was commenced October 9, 1905, and is in progress.

Hamilton Avenue, Gowanus Canal.

F. W. Devoe and C. T. Reynolds Company is building a bulkhead wall platform north of Hamilton avenue, in accordance with permit from the Commissioner of Docks. This work was begun on June 1, 1906, and is in progress.

Between Fifth and Seventh Streets, Gowanus Canal.

The Bracken-McAveney Company is building storage sheds adjoining the Seventh street basin under a permit from the Commissioner of Docks.

Between Forty-third and Fifty-first Streets, Brooklyn.

Five new piers are being erected at this location by the Bush Company, Incorporated, under Secretary's Order 21424. Work was commenced April 1, 1902, and is in progress.

Between Sixty-third and Sixty-fourth Streets, Brooklyn.

A pier bulkhead and transfer bridge are being built at this locality by the Long Island Railroad Company under a permit from the Commissioner of Docks. This work was begun on June 11, 1906, and is in progress.

Sixty-sixth Street and Wakeman Place.

An extension to the breakwater at this locality is being built by the Edison Illuminating Company under permit from the Commissioner of Docks. This work was begun June 28, 1906, and is in progress.

Between Bay Thirty-first and Bay Thirty-second Streets, Gravesend Bay.

A crib bulkhead with return on both sides is being built at this locality by Frederick Sempken under a permit from the Commissioner of Docks. Work was begun June 1, 1906, and is in progress.

Sheepshead Bay, Manhattan Beach, Brooklyn.

The Manhattan Beach Hotel and Land Company is dredging, filling and bulkheading at this locality under permit from the Commissioner of Docks. Work was commenced January 30, 1905, and is in progress.

Beach, Fifth Street, Sea Gate.

A sheet pile bulkhead is being built easterly from near the foot of East Fifth street, Sea Gate, by William B. Rae, under permit from the Commissioner of Docks. This work was begun on May 18, 1906, and is in progress.

BOROUGH OF QUEENS.

Between Third and Fifth streets, at College Point, the American Hard Rubber Company is constructing a crib bulkhead. The Long Island Railroad Company is constructing a single track trestle along Flushing creek. At Lawrence Point the Astoria Heat and Power Company is constructing two crib piers and building bulkheads and slips and erecting a coal-handling tower. Edward Shuttleworth is constructing the crib bulkhead at Ravenswood and foundations for tunneling crane are being placed on the bulkhead between Pierce and Graham streets. Between Noble and Worth streets, Ravenswood, Wm. Bradley & Son are building a crib bulkhead with a shed and runway for traveling crane. The Estate of Wm. Nelson is constructing three bulkheads between Webster and Washington avenues at Ravenswood. A coal pocket, tower and coal-handling plant are being erected at Eleventh street, Long Island City. The Degnon Contracting Company is constructing a crib bulkhead between Hunter's Point avenue and Anabel avenue, Long Island City, and between Hunter's Point avenue and Nott avenue. In Newtown creek, between Clifton and Washington avenues, the Nichols Copper Company is building a pump house, water-cooling tower and sampling shed; and east of Dutch Kills the Long Island Railroad Company is constructing a crib bulkhead with piers.

BOROUGH OF RICHMOND.

A number of pieces of work have been done by private parties and supervised by the Department of Docks and Ferries in this Borough. A pier is being constructed at Mariner's Harbor by Du Bois Sons Company, and a crib and close-pile bulkhead are being built near Van Name street, Mariner's Harbor, by the New Jersey Dock and Bridge Building Company. An extension of 100 feet has been built to the platform of Millikin Brothers, near Holland avenue, Mariner's Harbor, and piles are being driven near the foot of Andros avenue by the Burlee Dry Dock Company. At St. George about 200 feet of crib bulkhead and about 300 feet of sheet pile bulkhead are being built on property owned by the Staten Island Rapid Transit Railway Company. This work was commenced on August 18, 1904, and is in progress; also a new pier is being erected for a car dumper at St. George by the same company. At Port Richmond a dry-stone retaining wall is being constructed offshore of the railroad trestle by the Baltimore and Ohio Railroad Company. At Tottenville a crib or pile bulkhead is being constructed and filling is placed behind same and a pier built at the foot of Henry street by Henry Cosey. The pier is being constructed out into the Arthur Kills by the same party. At New Brighton a crib bulkhead is being erected by J. B. King & Co. This work was commenced in 1901 and is in progress from time to time. The American Dock and Trust Company is extending its pier near the foot of Arrietta street, Tompkinsville, and extending the shed on the pier. At Stapleton a crib bulkhead is being built by Bernard Brady and a sheet pile and bulkhead platform are being built by Thomas Williams. A marine railway is being built just north of the Amboy road at Tottenville.

Pavement on Marginal Streets, North and East Rivers.

The asphalt pavement has been repaired at various places along the North and East rivers where necessary to repair pavement already laid, and the work under Contract No. 879, for the repairing of the wearing surface and binder and concrete foundations for the asphalt pavement along the North and East rivers, has been in progress.

Pavement on East River.

Pavement has been repaired along the East river water front as required.

Timber Basin.

At the Timber basin, timber has been received under Department orders and contracts, cared for and issued as required. The Timber basin has been maintained and cared for.

Pile Basin, Sherman's Creek, Harlem River.

The Pile basin at Sherman's creek on the Harlem river has been maintained and cared for.

Basin for Storage of Old Material, Brooklyn.

At this basin old material has been rafted and cared for.

Department Yards at West Fifty-seventh and East Twenty-fourth Streets.

At the Department yards the force of the Department has been engaged in the construction of concrete blocks, the handling and cutting of granite, the care of materials and the issue of supplies for various pieces of work. The yards have been maintained in good order and condition. The contract has been awarded for constructing Department storehouse and offices in the yard and work has been begun under the contract.

Floating Property.

All of the floating property of the Department has been cared for during the quarter and repaired where necessary. Work has been in progress under Class I. of Contract No. 907 for building piledrivers. The work under Class 4 of the above contract for building derrick has been commenced and is in progress.

Dredging.

All the dredging has been supervised, whether done by the Department or private parties.

Surveying Party.

All the necessary lines, grades, soundings, surveys and examinations have been made and given. Work done by private parties has been supervised; automatic tide gauges have been attended to, and the daily and weekly reports have been made. The records of the anemometer and weather vane, etc., have been compiled. An extensive survey of the waterfronts of Brooklyn, Queens and Richmond is in progress.

Repairs.

Repairs other than dredging have been made at various times under orders or permits from the Commissioner of Docks. Repairs, alterations and other pieces of work by private parties under order or permit from the Commissioner of Docks have been supervised during the quarter.

Recreation Structures.

The recreation structures have been maintained and cared for during the quarter.

Baths.

Berths have been prepared for the public baths and the baths have been maintained during the quarter.

New Staten Island Ferry.

The operation of this ferry was begun on October 25, 1905, and since that time the ferry has been maintained and operated. Contracts have been awarded for the construction of the necessary ferry terminals at the foot of Whitehall street, East river, and at St. George, Staten Island, and the work has been in progress during the quarter. A contract has also been awarded and the work done for the construction of a temporary waiting-room and boiler-house in front of the Whitehall terminal preparatory to the construction of the new ferryhouse.

Draughtsmen.

In the office of the Engineer-in-Chief the Draughtsmen have been engaged on plans and studies for contract work, plans for the improvement of the waterfront, plans and specifications for new piers and repairs, change of lines, examination of plans submitted by private parties, solar printing and general routine work.

The total new wharfage room made by the Department of Docks and Ferries for the quarter amounts to 6,545 linear feet; wharfage room destroyed by the City in making way for the new improvements 3,001 linear feet. The area of the City's piers has been increased by 167,414 square feet. The total increase in wharfage room made by private parties under permit from the Department of Docks and Ferries is 3,221 linear feet.

Each bid or estimate shall contain the name and place of residence of the person making the same, and names of all persons interested in him, and, if no other person be so interested, it shall distinctly state that fact; also, that it is made without any connection with any other person making an estimate for the same purpose, and is in all respects fair and without collusion or fraud, and that no member of the Board of Aldermen, head of a department, chief of a bureau, deputy thereof, or clerk therein, or other officer of The City of New York is, shall be or become interested, directly or indirectly, as contracting party, partner, stockholder, surety or otherwise in or in the performance of the contract, or in the supplies, work or business to which it relates, or in any portion of the profits thereof. The bid or estimate must be verified by the oath, in writing, of the party or parties making the estimate that the several matters stated herein are in all respects true.

Each bid or estimate shall be accompanied by the consent, in writing, of two householders or freeholders in The City of New York, or of a guaranty or surety company duly authorized by law to act as surety, and shall contain the matters set forth in the blank forms mentioned below.
