



### PROCLAMATION.

MAYOR'S OFFICE, NEW YORK, June 14, 1879.

In pursuance of the ordinance approved April 30, 1877, as amended June 1, 1877, notice is hereby given that said ordinance will be enforced on and after the 23d day of June, 1879.

The Dog Pound at the foot of Sixteenth street, East river, is hereby designated as the place where dogs captured pursuant to said ordinance are to be delivered. The Pound will be open from 8 A. M. to 5 P. M., Sundays excepted.

The ordinance to prevent the danger of hydrophobia to any of the inhabitants of the City of New York, as amended and passed by the Board of Aldermen, May 29, 1877, is as follows:

AN ORDINANCE to prevent the Danger of Hydrophobia to any of the Inhabitants of the City of New York.

The Mayor, Aldermen, and Commonalty of the City of New York do ordain as follows:

Section 1. Hereafter it shall not be lawful to permit any dog to go abroad loose or at large in any of the public streets, lanes, alleys, highways, parks or places within the corporate limits of the City of New York, under a penalty of three dollars for each offense, to be recovered against the owner, possessor, or person who knowingly harbored such dog within three days previous to the time of such dog being so found going abroad loose or at large; and the Commissioners of Police are hereby authorized and directed to cause complaint to be made to the Corporation Attorney against the owner or possessor of every dog permitted to go loose or at large within the corporate limits, as aforesaid, for the recovery of the penalties prescribed in this ordinance; such penalties and all license fees, when collected, to be accounted for semi-monthly, and paid to the Comptroller of said city, and upon the requisition of the Mayor, to be applied towards the payment of enforcing the provisions of this ordinance. Nothing in this ordinance shall prevent any dog from going into any such street, lane, alley, highway, park or public place, provided such dog shall be held, by such owner or other person, securely by a cord or chain, to be not more than four feet long, fastened to a collar around the neck of the animal.

Sec. 2. Every owner, possessor, or person who harbors any dog shall take out a permit for each dog, at the Permit Bureau, paying the sum of two dollars (\$2) for the same. All permits, and renewals of the same, shall be dated from the first day of May in each and every year, and shall be for one year from date, and all renewals shall be one dollar (\$1). Said permit shall have the name of the owner and the number of the permit or license on it. Any dog so licensed must have a collar around his neck, with a metal tag attached, having the number of the license on it. And any dog so licensed must, when in the street, be held by such owner, or other person, secured by a cord, rope, or chain, not more than four feet in length; but the owner, at his option, may use, instead of the above, a muzzle, constructed so as to prevent the dog from biting. Any dog that is not so secured, although he is licensed, shall be captured the same as if no license was granted. No dog having a collar and tag, with the number of his license on it around his neck, that may be in a wagon or other vehicle belonging to his owner, shall be captured. Any person appointed by his Honor the Mayor to capture dogs who shall permit any person to take one or more dogs from him for nothing, or for pay, shall be arrested, and taken before a police justice, and upon the facts being proven, the judge shall impose a fine of not less than \$10, or more than \$50 for each offense. Any person may make a complaint of persons having dogs unlicensed at the police stations, and the officer in command shall entertain the same; and all policemen on patrol duty must report all violations of this ordinance the same as any other violation of a Corporation ordinance. All such reports shall be transmitted to the Corporation Attorney, the same as for other violations of city ordinances, and in addition to the \$3 fine, shall be added all costs of suits for the recovery of the same as for any other violation of the city ordinances. The provisions of this section, except those relating to leading and muzzling dogs, shall not apply to dogs owned by non-residents, in remaining temporarily or in passing through this city, or to dogs brought into this city and entered for exhibition at any dog show or annual exhibition of dogs.

Sec. 3. The Mayor of the City of New York is hereby authorized and empowered to take such measures as he may deem most efficient to carry into effect the provisions of section 1 of this ordinance. All dogs found loose or at large, as aforesaid, shall be seized, captured and delivered by such persons as the Mayor shall designate, at a place to be provided and indicated by him, where such animals, if not within forty-eight hours thereafter claimed and redeemed by the owner or some other person, shall be killed and destroyed in such manner and by such persons as the Mayor shall designate.

Sec. 4. Any owner or other person who may claim such dog shall, before being placed in possession thereof, pay therefor the sum of three dollars. The provisions of this ordinance shall apply only to dogs owned or claimed by residents of this city; and any person who shall knowingly present any such dog, and claim payment for the capture thereof, which shall not be owned or captured within the corporate limits of this city, shall thereby incur a penalty of ten dollars.

Sec. 5. No person shall hinder or molest any person or persons so appointed by the Mayor while engaged in seizing or capturing and delivering any such dog as aforesaid, or any other person engaged in the performance of any duty enjoined by the provisions of this ordinance, under a penalty of not less than twenty-five nor more than one hundred dollars for every offense, to be sued for and recovered in the manner now provided by law or ordinance for the recovery of penalties for violations of the ordinances of the Common Council, on the complaint of the person so hindered or molested; the penalty, when recovered, to be accounted for, paid, and appropriated, as provided in section one of this ordinance. The Commissioners of Police are hereby authorized and required to cause the persons so engaged in the performance of any of the duties prescribed by this ordinance, to be protected from hindrance or molestation.

Sec. 6. Chapter XLIV. of the Revised Ordinances of 1866, and all other ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance, are hereby repealed.

Sec. 7. This ordinance shall take effect immediately.

### DEPARTMENT OF DOCKS.

At a meeting of the Board of Docks, held June 4, 1879,

Present—Commissioners Dimock and Vanderpoel.

On motion, Commissioner Dimock took the chair.

The minutes of the meetings held May 24, 26, and 28, 1879, were read and approved.

The following communications were received, read, and,

On motion, laid on the table to await action, as stated, to wit:

From J. H. Vanderbilt and others—Protesting against the erection of a dumping board at Bethune street, North river.

From James W. Smith—As to his ownership of the south side of Pier 62, East river. Secretary directed to examine as to his title of said premises, and report to the Board.

From Harlem, New York Navigation Company—To have lease of pier at East Fifty-third street executed direct to them. Applicants requested to be present at the next meeting of the Board.

From B. F. Tyler—In reference to damage done to schooner O. F. Hawley by tug Manhattan on June 2, while off Pier, old 40, North river. Engineer-in-Chief to report as to the facts of said collision.

From Police Department—As to dredging required at pier at Forty-sixth street, East river. Engineer-in-Chief directed to examine and report as to the extent of dredging required at said premises to accommodate the boats of the Bureau of Street Cleaning.

From J. M. Goetchius—To drive piles and erect a platform for ferry purposes between One Hundred and Thirtieth and One Hundred and Thirty-first streets, North river.

From Police Department—To have dredging done at the dumping board at Lighthouse street, North river. Engineer-in-Chief directed to examine and report amount of dredging required at said premises to accommodate the boats of the Police Department.

From George H. Fletcher, Attorney for Eldridge & Warren—Claiming that the Department is bound to give to them the lease of the pier at Fifty-third street, East river, under the assignment made by the Harlem & New York Navigation Company, purchasers of said lease, filed in this office on 26th February last. Applicants being heard, further consideration of the subject deferred for one week.

From O. F. Kerker, lessee of the right to moor floats at the foot of the steps at Harlem Bridge and Third avenue for the letting of small boats—Stating that the Superintendent of Public Parks had placed the house of the Bridge Keeper in front of the steps of the Westchester side of the bridge, thereby obstructing the approach to his floats, and requesting that this Department take action to have said house removed. Secretary directed to address a communication to the Commissioners of Public Parks, advising that said Kerker had purchased, on March 14, 1878, at the public sale ordered by this Department, the right, for three years, to moor floats at steps at each end of Third Avenue Bridge, at a yearly rent of \$1,200 per annum, and that the privilege of mooring floats at said premises has been a source of revenue to the city for several years past, and requesting that said Department cause the removal of the obstruction complained of, as the interests of the city require that the lessee aforesaid should have the enjoyment of the right purchased by him.

From Engineer-in-Chief—Stating that there remain at the Department yard, at Seventeenth street, East river, one hundred and eighteen pieces of granite headers and stretchers, and sixty-six pieces of granite coping, delivered under the contract of John Hogan, and rejected as not being in accordance with the provisions of the contract, and that said contractor had been directed in writing to remove said rejected stone, but had failed to do so; and that, as the Department requires the space occupied by them, their removal is necessary. Secretary directed to have printed a proper form of notice, and posted on said stones and in the vicinity of said yard, to the effect that said stone must be removed on or before the 18th instant, and if not so removed by that date that then this Department will remove said stones and place them in storage, subject to the charges incurred in said removal.

The following communications were received, read, and,

On motion, placed on file, action being taken where necessary, as stated, to wit:

From Fulton Market Fish Mongers' Association—Lessees of slip between Piers 22 and 23, East river, etc., requesting that the necessary dredging thereat be performed with as little delay as possible. Applicants informed that the work of dredging said premises has been contracted for and will be done very soon.

From N. Y. & Manhattan Beach Railway Co.—In reference to price to be charged to the Harlem boats for making landings daily at the end of pier at Twenty-third street, East river. Secretary directed to advise in reply that this Department will charge \$5 per day to said boats for the privilege of making landings at said pier, and as the season is short, the Commissioners believe the price fixed to be fair and reasonable.

From Superintendent McConkey—As to shed erected on Pier 1, East river.

From C. H. Loomis—Accepting to contract for dredging at various piers, under award made May 28, 1879.

From Henry Miller, Jr.—As to repairs needed at Pier, old 54, North river. Applicant notified and directed to make the necessary repairs to said pier, in accordance with the terms and conditions of sale held March 14, 1878, under which the lease of said premises was purchased by him.

From Department of Public Works—Stating that the free public baths are now located at the places designated by this Department, and requesting that such floats and rafts as may be necessary for their full protection be placed thereat. Engineer-in-Chief directed to do the work in accordance with the request of said Department.

From Police Department—Requesting that about six piles be driven at the dumping board at Jackson street, East river. Engineer-in-Chief directed to drive said piles as requested by said Department.

From Charles G. Francklyn, Agent Cunard Steamship Company, stating that he is informed by the Department of Public Works that the sewer at the foot of Clarkson street, North river, will remain as it is until September next, and requesting that a temporary covering be placed over the same to prevent the foul odors arising therefrom. Engineer-in-Chief directed to cover said sewer with old material now on hand, and with earth, at a cost of about \$400.

From Engineer-in-Chief—

1st. Report as to work performed during week ending May 31, 1879.

2d. Report stating that the crib at the end of the pier at One Hundred and Sixth street, Harlem river, has settled and carried the whole pier out, so as to pull off the face of the bulkhead, making it necessary to rebuild the bulkhead, and repair the pier, at a cost of about \$750. Engineer-in-Chief directed to repair said bulkhead and pier in accordance with his report.

On motion, the application of F. E. Bean to erect a platform on north side of pier at Sixteenth street, North river, etc., was taken from the table and placed on file, and the applicant notified that this Department has no objection to his driving five piles and erecting thereon a platform about eighty feet long, on the north side of pier at Sixteenth street, North river, also to place a scale and weigh-office on the northeast corner of said pier; the consent of the lessee of said premises, and also of the Harbor Master of the district having been filed in this office, but this Department reserves the right to cause their removal at any time it may so elect.

On motion, the application of Warwick & Gordon, for permission to erect a hoisting engine on premises occupied by them between Forty-sixth and Forty-seventh streets, North river, for the purpose of discharging coal, was taken from the table and placed on file, and the applicants informed that, while this Department is doubtful if it has jurisdiction to grant the permission asked for, it sees no objection to their placing said engine on the premises referred to, but the Department reserves the right to cause its removal at any time it may so elect.

A report was received from the Engineer-in-Chief, stating that the repairs ordered to be made to the inner end of the westerly side of Pier 23, East river, for account of the lessees thereof, were completed on May 13, at a cost of \$562.19, and, being read,

On motion, it was

Resolved, That the Treasurer be and is hereby authorized and directed to prepare a statement of claim in the sum of \$562.19, and present the same to the Fulton Market Fish Mongers' Association for payment, being for expenses incurred for repairs made by this Department to the inner end of the westerly side of Pier 23, East river, in conformity with the provisions of the lease of said premises.

The Auditing Committee presented an audit of nine bills or claims, amounting in the aggregate to the sum of \$1,698.08, and, being read, was

On motion, accepted and adopted, and the Secretary directed to forward the said bills, together with proper requisitions for the amount, to the Finance Department for payment.

A communication was received from the Engineer-in-Chief, suggesting certain changes in the plans for sewers and outlets about to be contracted for by the Department of Public Works, on West

street, between Spring and West Eleventh streets, as shown on the maps received from said Department, and being read,

On motion, the Secretary was directed to address a communication to the Commissioner of Public Works, advising him of the suggestions of the Engineer-in-Chief, in regard to said sewers outlets, etc., with the request that if they shall prove acceptable to him, he will have the alterations made upon the maps prepared by his Department, and forwarded to this Department at his earliest convenience.

An application was presented by F. W. Jackson, General Superintendent Pennsylvania Railroad Co., for permission to erect platform, repair and extend Pier 16, North river, etc., occupied by said Company, and being heard at length in reference to the contemplated improvements, said application was

On motion, laid on table, to enable the applicant to prepare a modified plan of the work.

The Secretary stating that the insurance against fire on the sheds on Piers, new 43 and 46, North river, to the amount of \$65,000, would expire on the 25th instant,

On motion, the Treasurer was authorized and directed to effect an equal amount of fire insurance, either by renewal of existing policies or otherwise, for one year from said date.

On motion, John Hogan, and Patrick Kane, Night Watchmen, were discharged.

On motion, the Board adjourned.

## BOARD OF REVISION AND CORRECTION OF ASSESSMENTS.

A meeting of the Board of Revision and Correction of Assessments was held at the Comptroller's Office, in the New Court-house, on Thursday, June 5, 1879, at 12.10 o'clock P. M.

Present—Hon. John Kelly, Comptroller; Hon. William C. Whitney, Counsel to the Corporation; Hon. John K. Hackett, Recorder.

The minutes of the meeting held May 29, 1879, were read and approved.

The assessment list for paving, with Belgian pavement, Lexington avenue, between Eighty-fifth and Eighty-sixth streets, with objections of Elizabeth H. Theall and others, laid over at the meeting of April 18, 1879, for a further examination in respect to the condition of the work was, on motion, taken up for action.

In connection therewith the Comptroller presented to the Board a report of J. B. Bacon, examiner, of a further examination made by him as to the execution of said work.

Mr. John M. Seaman, of No. 1264 Lexington avenue, was sworn and examined by the representative of Mr. N. Gano Dunn, attorney for the objectors, and by the Board relative to the character of the grade of Lexington avenue, between Eighty-fifth and Eighty-sixth streets.

On motion, the said assessment list was again laid over.

The assessment list for regulating, grading, curbing, flagging, and superstructure of One Hundred and Fifty-fifth street, from Ninth avenue to Hudson river, and record of awards for damages to buildings by reason of change of grade on the line; also the petitions for damages, objections, correspondence, affidavits, and testimony taken by the Board of Assessors in said matter, were presented to the Board by the Comptroller, the same having been received from the Board of Assessors with a communication dated May 19, 1879.

Mr. Charles E. Miller, attorney for the Vestry, etc., of Trinity Church, submitted an act of the Legislature relating to cemeteries, passed May 17, 1879, whereupon

It was ordered that the said assessment list be returned to the Board of Assessors for revision in accordance with the provisions of said act.

Mr. William B. Crosby, an objector to the assessment, submitted affidavits of Mr. H. M. Gilliland and himself relative to the present condition of the work. Which were filed.

The assessment list for regulating, grading, etc., in Concord avenue, from Home street to Westchester (road) avenue, in the Twenty-third Ward, and objections of George F. Bristow, Cornelia Pastor, and others, were presented to the Board by the Comptroller, the same having been received from the Commissioners of Estimate and Assessment, with report in said matter, on May 20, 1879.

After hearing Mr. Ernest Hall, attorney for Mr. Geo. F. Bristow and others, in opposition to the confirmation of the assessment, and Mr. Michael Kuntz, one of the Commissioners of Estimate and Assessment in said matter, on motion, the said assessment list was laid over.

The assessment list for regulating and grading, setting and resetting curb, flagging and reflagging, and paving with Telford Macadam pavement, Eastern Boulevard, One Hundred and Twenty-fourth street, from Avenue A to Sixth avenue, with objections of Messrs. Isaac Lockwood, William H. Colwell, Frederick Kopper, and others, was presented to the Board by the Comptroller, the same having been received from the Board of Assessors with a communication dated March 31, 1879.

After hearing Mr. John C. Shaw, attorney for Isaac Lockwood and others objectors, in opposition to the confirmation of the assessment, on motion, the said assessment list was laid over for further consideration.

The Counsel to the Corporation here withdrew from the meeting.

The Comptroller presented to the Board the assessment list for building sewers in First avenue, between Ninety-second and One Hundred and Tenth streets, and Second avenue, between Ninety-fifth and One Hundred and Ninth streets, with branches in Ninety-third, Ninety-sixth, Ninety-seventh, Ninety-ninth, One Hundredth, One Hundred and First, One Hundred and Second, One Hundred and Third, One Hundred and Fourth, One Hundred and Fifth, One Hundred and Seventh, and One Hundred and Eighth streets, accompanied with objections of the Second Avenue Railroad Company, Albert Crane, Thomas Kitts, and others, and a communication from the Commissioner of Public Works relative thereto, the same having been received from the Board of Assessors with a communication dated May 20, 1879.

After hearing Mr. Charles E. Miller, attorney for the Second Avenue Railroad Company, and Albert Crane, in opposition to the confirmation of the assessment, on motion, the objections in said matter were overruled and the assessment list was confirmed, all the members of the Board present voting in the affirmative.

The assessment list for regulating and grading that portion of Fourth avenue, between One Hundred and Sixteenth and One Hundred and Twenty-fourth streets, on each side of the improvement of said avenue for railroad purposes, and record of awards for damages to buildings by reason of change of grade on the line; also the petitions for damages, objections of Huldah Eisenprice, Nelson Haradon, and Henry Bullenkamp and others, and opinion of the Counsel to the Corporation in said matter, were presented to the Board by the Comptroller, the same having been received from the Board of Assessors, with a communication dated June 3, 1879.

After hearing Mr. William Boehlk, one of the objectors in opposition to the confirmation of the assessment, on motion, the objections in said matter were overruled, and the assessment list was confirmed, all the members of the Board present voting in the affirmative.

At 12.50 o'clock P. M., on motion, the Board adjourned.

## COMMISSIONERS OF THE SINKING FUND.

*Abstract of the Proceedings of the Commissioners of the Sinking Fund at the meeting held June 16, 1879.*

Present—Hon. Edward Cooper, Mayor (Chairman); Hon. John Kelly, Comptroller; J. Nelson Tappan, Esq., Chamberlain; and Nicholas Haughton, Esq., Chairman Finance Committee Board of Aldermen.

The minutes of the last meeting were read and approved.

The Mayor presented the following communication:

FULTON MARKET, NEW YORK, June 16, 1879.

Hon. EDWARD COOPER, Mayor:

SIR—As invited by the Sinking Fund Commissioners, we submit for their consideration certain suggestions as to the conditions or stipulations upon which a lease of the Fulton Market should be given, so that a new building might be erected this fall, to be used for market purposes.

The standholders are substantially united in urging upon the favorable consideration of the Commissioners the application made on their behalf, and in supporting this application there is not a single standholder who desires to secure any advantage to himself which is not secured to all standholders alike. The movement on the part of the standholders is an honest endeavor on their part to secure the erection of a new market.

In these circumstances we are particularly anxious that the action now taken by the Commissioners will not have the effect of continuing the present exceedingly unsatisfactory state of matters. The present buildings are in a wretched condition. Condemned by the Building Department as unsafe, by the Department of Health to be a public nuisance, there ought to be no delay in removing this dangerous nuisance.

We are aware that the power of the Commissioners over this Fulton Market property is limited to either selling or leasing the same, for the highest marketable price or rental, at public auction or by sealed bids after public advertisement and appraisal, "under a condition that the purchaser or lessee thereof shall maintain said market property as and for the purposes of a public market for at least ten years from and after such sale or lease, and under due ordinance of the Common Council, or of the Department of Health, or under stipulation in the deed of sale or lease."

Under this grant of power the question to be determined by the Commissioners is whether they will sell or lease the property, so that a new market may be erected? The Commissioners have no power to build a new market. Will they therefore sell or lease, that a new market may be built by the purchaser or lessee?

If the Commissioners resolve to exercise the power they possess, it is for them to then determine the stipulations or conditions to be inserted in the deed of sale or lease. The standholders have submitted certain suggestions on this subject, but if these do not meet with the approval of the Commissioners, we ask them to agree upon conditions which will be satisfactory. The Commissioners are sole judges in the matter, and are subject only to the imperative proviso contained in the law, from whence they derive their power, viz.: "That the property shall be maintained for the purposes of a public market for at least ten years from and after the lease."

As it is evident that a failure to exercise the power which the Commissioners possess in the matter would be equivalent to a determination on their part that the present dangerous nuisance must continue, we trust that the Commissioners may see their way to the adoption of such action as will secure to the city, this fall, a very much needed improvement.

After a general discussion of the subject under consideration by the members of the Board in attendance and the representatives of the market standholders, the Comptroller submitted the following resolution:

Resolved, That all the papers relating to the application for a lease of the Fulton Market property be referred to the Counsel to the Corporation; and that he be requested to advise the Commissioners at as early a date as possible, as to what are the powers possessed by the Commissioners in the matter, and particularly, whether it would be in the power of the Commissioners to insert as a condition in the lease, permission to erect on a portion of the market property, along Fulton street, stores for the retail of general merchandise; and whether such a use of the property would be using the property for the purpose of a public market.

On motion, the resolution was adopted.

## RAPID TRANSIT COMMISSION.

MAYOR'S OFFICE,  
NEW YORK, April 2, 1879.

*Appointment of Commissioners.*

It appearing by the application, made to me on the 4th day of March, 1879, by fifty reputable householders and taxpayers of the City and County of New York, in the State of New York, verified upon oath before a Justice of the Supreme Court, that there is need in said city and county of a street railway or railways for the transportation of passengers, mails and freight; and thirty days not having expired since said application, now, in pursuance of the provisions of the act entitled, "An Act further to provide for the construction and operation of a steam railway or railways in counties of the State," passed June 18, 1875, three-fifths being present, I, Edward Cooper, Mayor of the City of New York, do hereby appoint the following five persons, residents of said city and county, to be commissioners under and in pursuance of the provisions of said act, namely: Henry F. Spaulding, Benjamin G. Arnold, Henry G. Stebbins, Lewis G. Morris, Samuel R. Filley.

In witness whereof, I have hereunto signed my name, the 2d day of April, 1879.
