OUTREACH AND EDUCATION REPORT

MAY 30, 2025



Purpose of the Report

This annual Local Law 97 (LL97) Outreach and Education Report has been prepared pursuant to §28-320.5.1 of the New York City Administrative Code for compliance with the June 1, 2025 deadline.

§28-320.5.1. Reporting on outreach and education.

By June 1, 2021, and by June 1 in every year thereafter, the office of building energy and emissions performance shall submit a report to the mayor and the speaker of the council, detailing the outreach and education efforts made pursuant to section 28-320.5, including, but not limited to information provided about incentive programs and other sources of funding. Such report shall also include the number of staff members working at the office of building energy and emissions performance.

The Bureau of Sustainability

The Department of Building's (DOB)Bureau of Sustainability consists of five units: the Office of the Deputy Commissioner, the Office of Building Energy & Emissions Performance (OBEEP), Sustainability Policy & Legal Affairs, Sustainability Outreach & Assistance, and Energy Code Compliance.


The Bureau of Sustainability comprises 112 staff, approximately 69 of whom support implementation of LL97. DOB, the Mayor's Office of Climate and Environmental Justice (MOCEJ), the New York City Department of Housing Preservation and Development (HPD), and other city and state government partners work to carry out the tasks necessary for the successful implementation of New York City's sustainability laws, including LL97.

The Sustainability Outreach & Assistance unit was created to support citywide efforts to provide building owners and the industry with the information needed to comply with LL97 and other sustainability laws. Supported by all staff in the Bureau, this unit works hand in hand with NYC Accelerator (NYCA), MOCEJ, and the CUNY Building Performance Laboratory's Sustainability Help Center (SHC) to perform outreach and educate building owners and service providers, with the goal of advance energy efficiency and decarbonization efforts in New York City.

NYC Accelerator

NYC Accelerator is a program established by the City and overseen by the MOCEJ to assist building owners with local law compliance requirements, boost building energy efficiency performance, increase energy savings, and reduce carbon emissions across New York City buildings. NYC Accelerator:

- Provides education and free technical guidance to help buildings in the NYC market transform their construction and operations
- Identifies building upgrade projects to help meet emissions limits established under LL97 and other local building sustainability laws
- · Offers no-cost trainings and supports green workforce development
- Connects building decision-makers directly with service providers to implement decarbonization and energy efficiency projects
- Helps buildings identify applicable financial incentives and financing, such as NYC Accelerator PACE loans

To date, NYC Accelerator has:

- Engaged 30,783 buildings (26,071 of which are on the LL97 CBL), including 19,912 affordable housing buildings (16,881 of which are on the LL97 CBL)
- Conducted 1,060 solar feasibility assessments (672 for buildings on the LL97 CBL)
- Trained over 2,084 participants.

NYC Accelerator hosts and participates in events to educate audiences on LL97 and other decarbonization topics. Over the past year, the program has participated in 72 events and hosted an additional 17 events.

DOB NYC Accelerator Climate Action Meetings

DOB partners with NYC Accelerator on a series of events that offer building owners and managers the opportunity to meet with a dedicated NYC Accelerator Account Manager. NYC Accelerator Account Managers then provide attendees with free one-on-one expert guidance to help buildings improve energy efficiency and identify pathways for LL97 compliance. Through this initiative, the NYC Accelerator team also provides support for: buildings transitioning off #4 oil, affordable housing, market-rate buildings, commercial and industrial buildings, and houses of worship. To date, the series has engaged 161 participants (73 from May 1, 2024 through April 30, 2025).

Direct Contact with Building Owners via Telephone

Working closely with NYC Accelerator and where contact information was available, DOB made telephone calls to certain building owners in jeopardy of receiving significant penalties during the 2024-2029 compliance period, to inform and educate them about the law and connect them with a dedicated NYC Accelerator account manager.

Dedicated Email Address for Questions

DOB responded to approximately 1901 of 2091 emails received between May 2024 and April 2025 through a dedicated email box for LL97 questions: ghgemissions@buildings.nyc.gov. DOB continues to respond to those emails received and correspondents are notified that we are working on their requests for information. A significant number of additional questions were answered during presentations and webinars. In 2025, with the roll-out of the LL97 reporting portal (BEAM), a substantial number of inquiries are also being directed to the BEAM site. As of April 30th, DOB has received 864 emails in BEAM, has responded to 799 of these, and continues to respond to all inquiries.

Department of Finance (DOF) Statement of Accounts

Building owners are notified of LL97 compliance requirements by DOF on their quarterly Statement of Accounts (SOA).

Typical language is reflected here:

Compliance Notification

Greenhouse Gas Emission Reductions: This property may be subject to Local Law 97 of 2019, as amended, which sets carbon emission limits or prescriptive requirements for buildings, with the first reports due in 2025. All buildings required to comply with Local Law 97 and Local Law 88 of 2009, as amended, must submit their reports by May 1, 2025, with a 60-day grace period through June 30, 2025. Buildings also have until June 30, 2025, to apply for an extension of the reporting deadline to August 29. For more information, visit www.nyc.gov/LL97.

Publication of Rules

DOB published a third major Rule package during the year to advance the implementation of LL97. This Rule package:

- Established a coefficient for calculating the emissions resulting from the use of certain biofuels,
- Established an alternative coefficient for certain co-generation systems,
- Established the type of GHG offsets that may be used as a deduction from annual building emissions to achieve compliance,
- Established the filing requirements for applications for an adjustment to annual building emission limits in accordance with section 28-320.7 of the Administrative Code for buildings facing an "external constraint," due to being subject to a provision of law or affected by a physical condition, and for buildings facing a financial constraint,
- Amended the of schedule of fees to include fees associated with filing of emissions reports, and
- Amended the penalty provisions relating to failure to file energy efficiency reports for consistency in enforcement across programs.

These rules were published in the <u>City Record</u> on October 4, 2024 and became effective on January 19, 2025. As part of the City Administrative Procedure Act (CAPA), the public was given the opportunity to comment on proposed rules during the statutorily required comment period. The DOB's <u>Rules</u> webpage includes all rules pertaining to the work of the department.

Sustainability Help Center

DOB also works with the <u>CUNY Building Performance Laboratory's Sustainability Help Center (SHC)</u>, which functions as an additional resource for buildings and the industry to advance compliance with sustainability laws. SHC receives thousands of phone and email inquiries each year regarding clarification on compliance guidelines and reporting requirements. In addition to live support, SHC offers virtual classes and trainings pertaining to building sustainability in NYC.

The Carbon Reduction Workshop Series includes a Crash Course on NYC Building Energy Laws, Local Law 97 Workshop – Your Emissions and Plan, and Local Law 97 Workshop – Your Project Team and Financing.







Through the coordinated efforts of the MOCEJ, DOB, NYC Accelerator, and SHC, building owners and the industry are provided with resources, education and personalized assistance to help them comply with LL97.
