### BOARD OF CITY RECORD.

The Board of City Record met in the Mayor's Office, Thursday, August 13, 1874.

Present—The Mayor, Counsel to the Corporation, and Commissioner of Public Works.

On motion, the reading of the minutes of last meeting was dispensed with.

The Commissioner of Public Works offered for adoption the following resolution:

Resolved, That the resolution adopted July 14, 1873, and re-adopted August 28, 1873, and corrected by resolution adopted June 3, 1874, as follows:

Resolved, "By a concurrent vote of the Board, that pursuant to the provisions of sec. 19 of chap. 757, Laws of 1873, the Commissioner of Public Works be authorized and directed, until the further order of this Board, to procure such printing and stationery as may be required by the several Departments, upon their requisition, in such manner and on such terms and conditions as he may deem for the best interests of the city, to be paid for out of the appropriations made for such printing and stationery, upon the certificate and requisition of the Commissioner of Public Works," was intended to declare, by the concurrent vote of the Mayor, Counsel to the Corporation, and Commissioner of Public Works, that it was therein decided that the term Departments therein referred to, should include the City Courts and all other officers of the City Government; and

Resolved, That the record of said resolution be and the same is hereby corrected in that particular, and it is hereby declared that the printing and stationery done and furnished by persons whose accounts have been approved and certified by the Commissioner of Public Works in pursuance of said resolution, be and the same are hereby approved and ratified as done and furnished under the decision of said three officers, that the same should be so done and furnished for the City Courts and all other officers, and we authorize and request the payment thereof.

The Chairman put the question whether the Board would agree with such resolution, which was decided in the affirmative by the following vote:

Affirmative—The Mayor, Counsel to the Corporation, and Commissioner of Public Works.

The Commissioner of Public Works offered for adoption the following resolution:

Resolved, That the Commissioner of Public Works be and he is hereby authorized to have printed 1,000 copies of the third general report of the Department of Parks, with not exceeding five illustrations, to be paid for out of the appropriation for printing and Stationery.

The Chairman put the question whether the Board would agree with such resolution, which was decided in the affirmative by the following vote:

Affirmative—The Mayor, Counsel to the Corporation and Commissioner of Public Works.

MAY 15, 1874.

The Commissioners of the New County Court-house met in the Comptroller's office, at 12 M., Friday, May 15, 1874.

The roll was called, the following Commissioners being present, viz.:

Wyllis Blackstone, John P. Cumming, and Smith E. Shaw.

The minutes of the meetings held May 9 and May 13, 1874, were read and adopted.

The Chairman presented sundry correspondence with the Janitor of the New County Court-house, under resolutions adopted by the Commission.

Which was ordered on file.

Commissioner Cumming presented a copy of the pay-roll of the employees in the New County Court-house, which had been obtained from the Comptroller's office.

On motion, it was ordered on file.

The Secretary *pro tem.* presented Volume IV, of Senate Documents for the year 1872, containing reports by Hon. Andrew H. Green, Comptroller, relative to the moneys expended for the erection of the New County Court-house.

Which was also ordered on file.

Commissioner Shaw offered the following preamble and resolution:

Whereas, It is absolutely necessary for the proper performance of our duties as Commissioners of the New County Court-house, to have possession of said building and its apartments; and

Whereas, The Honorable the late Board of Supervisors, who have had said Court-house in their charge, have made no delivery thereof to the Commissioners of the New County Court-house; therefore be it

Resolved, That the Secretary of this Commission be instructed to demand from the Chairman of the Board of Supervisors, or from the person or persons claiming to have charge of said building, possession of the same, and also to demand all keys belonging to said building.

The Chairman put the question upon the adoption of the resolution.

Which was adopted by the following vote:

Affirmative—Commissioners Cumming and Shaw.

Negative—Commissioner Blackstone.

Commissioner Shaw offered the following resolution:

Resolved, That the Chairman be requested to require from Wesley C. Miller, late Secretary of the New County Court-house Commission, the delivery of all the books, papers, documents, and records of said Commission, which have been in his custody as such Secretary.

MAY 20, 1874.

The Commissioners of the New County Court-house met, pursuant to adjournment, at 1 P. M., on Wednesday, May 20, 1874, in the Chamber of the Court of Common Pleas.

The following Commissioners were present:  
Wyllis Blackstone, John P. Cumming, and Smith E. Shaw.

The Secretary *pro tem.* read the minutes of the meeting held May 15, 1874, which were, on motion, adopted.

Commissioner Cumming moved that the Secretary *pro tem.* be authorized to employ a locksmith, and take possession of the rooms in the New County Court-house, occupied by the Board of Supervisors.

After a full debate, said resolution was unanimously laid on the table.

Commissioner Shaw moved that the Chairman of this Commission be authorized to demand from the Chairman of the Committee on County Offices of the Board of Supervisors immediate possession, for the purposes of this Commission, of the room in the New County Court-house used as a committee room by the Board of Supervisors, which motion was adopted.

Rogers, Richard Coote, Michael Toohy, and Samuel H. Graves, Cleaners, employed in the New County Court-house, be and they are hereby discharged, and that the Secretary *pro tem.* be directed to notify them accordingly.

The Chairman put the question whether the Commissioners would agree with said preamble and resolution.

Which was decided in the affirmative by the following vote:

Affirmative—Commissioners Blackstone, Cumming, and Shaw.

On motion, the Commission adjourned to meet again at 12 M., Tuesday, May 26, 1874.
