# **Executive Summary**

The Civilian Complaint Review Board ("CCRB") is an independent municipal Agency that investigates complaints of NYPD misconduct. Every month, the CCRB prepares an Executive Director report for its public meeting. Data for May 2024 included the following highlights:

- 1) Of the cases in the CCRB active investigations docket, 45% have been open for 4 months or fewer, and 61% have been open for 7 months or fewer (page 10). In May, the CCRB opened 519 new cases (page 4), and currently has a total open docket of 3,550 cases (page 11).
- 2) The CCRB substantiated allegations in 26% of its fully investigated cases in May (page 17).
- 3) The CCRB fully investigated 57% of the cases it closed in May (page 14).
- 4) For May, investigations using video evidence resulted in substantiated allegations in 27% of cases compared to 18% of cases in which video was not available (page 24).
- 5) The Monthly Report includes a breakdown of complaints and substantiations by NYPD precinct and borough of occurrence (pages 5-6, 26-33).
- 6) In May the Police Commissioner finalized 43 decision(s) against police officers in Administrative Prosecution Unit (APU) cases (page 38). The CCRB's APU prosecutes the most serious allegations of misconduct. The APU conducted 25 trials against members of the NYPD year-to-date; 10 trials were conducted against respondent officers in May.

The CCRB is committed to producing monthly reports that are valuable to the public, and welcomes feedback on how to make its data more accessible.

# Glossary

In this glossary we have included a list of terms that regularly appear in our reports.

**Allegation**: An allegation is a specific act of misconduct. The same "complaint" can have multiple allegations – excessive force and discourteous language, for example. Each allegation is reviewed separately during an investigation.

**APU**: The Administrative Prosecution Unit is the division of the CCRB that has prosecuted "charges" cases since April 2013, after the signing of a 2012 Memorandum of Understanding between the CCRB and NYPD.

**Board Panel**: The "Board" of the CCRB has 15 members. Following a completed investigation by the CCRB staff, three Board members, sitting as a Board Panel, will make a finding on whether misconduct occurred and will make a recommendation on what level of penalty should follow.

**Case/Complaint**: For the purposes of CCRB data, a "case" or "complaint" is defined as any incident within the Agency's jurisdiction, brought to resolution by the CCRB.

**Disposition**: The Board's finding as to the outcome of a case (i.e. if misconduct occurred).

**FADO**: Under the City Charter, the CCRB has jurisdiction to investigate the following categories of police misconduct: Force, Abuse of Authority, Discourtesy and Offensive Language, collectively known as "FADO".

**FADO&U**: A ballot measure revising the New York City Charter, which passed on November 5, 2019, authorized the CCRB to investigate the truthfulness of an official statement made by a subject officer during a CCRB investigation into a FADO allegation. This expanded jurisdiction—Force, Abuse of Authority, Discourtesy, Offensive Language, and Untruthful Statements (FADO&U)—went into effect on March 31, 2020.

**Intake**: CCRB's intake team initially handles complaints from the public. Intake takes complaints that come via live phone calls, voicemails, an online complaint form, or in-person.

**Investigation**: CCRB investigators gather evidence and interview witnesses to prepare reports on misconduct allegations. An investigation ends when a closing report is prepared detailing the evidence and legal analysis, and the case is given to the Board for disposition.

**Mediation**: A complainant may mediate his or her case with the subject officer, in lieu of an investigation, with the CCRB providing a neutral, third-party mediator.

**Unable to Investigate**: A catch-all term, used for reporting purposes only, that refers to cases where the CCRB was unable to conduct an investigation, typically because no statement could be obtained from the complainant/alleged victim. "Unable to Investigate" incorporates the following CCRB dispositions: "Complainant/Alleged Victim Uncooperative", "Complainant/Alleged Victim Unavailable", "Witness Uncooperative", "Witness Unavailable", "Victim Unidentified", and "OMB PEG Directive Closure."

**Withdrawn**: When the complainant/alleged victim asks that their complaint be withdrawn, the case is closed as "Withdrawn."

**Closed Pending Litigation:** When a complainant is involved in criminal or civil litigation, and declines to cooperate with an investigation on the advice of their attorney, the complaint disposition is "Closed Pending Litigation."

# **Complaints Received**





Figure 1: Total Intake by Month (January 2023 - May 2024)







Figure 3: New CCRB Complaints by Year (YTD 2010 - YTD 2024)

The CCRB's Intake team processes misconduct complaints from the public and referrals from the NYPD. Under the New York City Charter, the CCRB's jurisdiction is limited to allegations of misconduct related to Force, Abuse of Authority, Discourtesy and Offensive Language. All other complaints are referred to the appropriate agency. Figure 1 refers to all complaints that the CCRB receives and Figures 2 and 3 refer to new cases that remain with the Agency. In May 2024, the CCRB initiated 519 new complaints.

Figure 4: CCRB Complaints Received By Borough of Occurrence (May 2024)




Figure 5: CCRB Complaints Received By Borough of Occurrence (YTD 2024)




Figure 6: CCRB Complaints Received By Precinct of Occurrence (May 2024)

As described in the previous section, the CCRB has jurisdiction over four categories of NYPD misconduct. The charts below show what types of allegations are contained in the CCRB complaints received.




Figure 7: CCRB Complaints Received By Type of Allegation (May 2023 vs. May 2024)




Figure 9: CCRB Complaints Received By Type of Allegation (YTD 2023 vs. YTD 2024)

Figure 15: Number of Active Investigations (January 2023 - May 2024)




Figure 16: Open Docket Analysis




Figure 17: Open Docket Analysis with % Change

# **Body Worn Camera Footage Requests**

Since the widespread roll out of body worn cameras in 2018, the collection of footage from these cameras has become an integral part of CCRB investigations.

The timeliness of the response to BWC footage requests has a direct impact on the length of time it takes to complete an investigation. The longer it takes to fulfill BWC requests, the longer CCRB investigations remain on the open docket.

Figure 20: Percentage of Open Investigations Docket with Pending BWC Requests (January 2023 - May 2024)





Figure 21: Fulfilled BWC Requests (January 2023 - May 2024)

## **Dispositions**

Cases fully investigated by the CCRB generally receive one of five outcomes:

- If the alleged misconduct is found to have occurred, based on the preponderance of the evidence, the allegation is closed as **substantiated**.
- If there is not enough evidence to determine whether or not the alleged misconduct occurred, the allegation is closed as **unable to determine**.\*
- If the preponderance of the evidence suggests that the event or alleged act did not occur, the allegation is closed as **unfounded**.
- If the event did occur, but was not improper by a preponderance of evidence, the allegation is closed as within NYPD guidelines.\*\*
- If the CCRB was unable to identify any of the officers accused of misconduct, the case is closed as **officer unidentified**.

#### **Case Abstracts**

The following case abstracts are taken from complaints closed this month and serve as examples of what the different CCRB dispositions mean in practice:

#### 1. Substantiated

An individual was pulled over while driving his vehicle. The individual had a sword in his vehicle, and the subject officer searched the glove box of the individual's vehicle. When the subject officer was interviewed by the CCRB about the search, he stated that he didn't search anywhere in the vehicle other than where the sword was located. The incident was captured on BWC. It showed the subject officer entering the vehicle and examining the sword which was a replica. The subject officer then searched the center console and glove box of the vehicle. At his interview, the subject officer stated that he did not search the glove box; he was shown the BWC of the glove box being opened and he maintained that the glove box opened without any action on his part. The investigation determined that the subject officer searched the glove box, an area not covered by the grounds for the vehicle stop of the individual's vehicle and that the subject officer made a false statement to the CCRB regarding the search of the glove box. The Board substantiated the Abuse of Authority and Untruthful Statement allegations.

#### 2. Unable to Determine

An individual stated that he went to a precinct to file a complaint against his roommates for putting blood in his drink. The individual stated that the two subject officers, including other officers surrounded him. The two subject officers told the individual that he would have to go to the ambulance parked in front of the precinct. He asked if he had to go and was told that he had to. The individual voluntarily complied and entered the ambulance and was taken to the hospital. The incident was partially captured on BWC. The first subject officer is seen escorting the individual outside. The second subject officer follows behind them. The first subject officer is heard telling the individual that because of statements he made, he would need to be evaluated by EMS. The subject officers stated that while the individual had been inside the precinct, he stated that his tarot cards told him that his roommates had poisoned him by putting blood in his drink. The individual became more agitated and stated that he would go and kill his roommates if he did not get an order of protection. Both subject officers conferred and agreed that because of the individual's behavior and statements, EMS should evaluate him. Without any independent witnesses or additional audio or video footage, the investigation could not determine the nature of the individual's initial encounter with the subject officers. The Board closed the Abuse of Authority allegations as Unable to Determine.

#### 3. Unfounded

An individual stated that she and two relatives went to a precinct to file a complaint. They spoke with the subject officer who told the individual that she did not need to file a complaint because the individual already had an active order of protection against the subject of the complaint. The individual asked for the subject officer's shield number, but he turned his body away and did not provide the individual with his shield number. One of the individual's relatives stated that the subject officer verbally provided his name and shield number when asked and that she even wrote it down. The subject officer stated that he interacted with multiple civilians that day and could not specifically recall speaking with the individual and her relatives and that if asked he would have provided his name and shield number. The investigation found that since the individual's relative obtained the subject officer's name and shield number, he complied with the individual's request for the information. The Board closed the Abuse of Authority allegation as Unfounded.

#### 4. Within NYPD Guidelines

An individual was in his residence's kitchen when his landlord entered the kitchen. The individual stated that his landlord followed him and started recording him in his personal living area. A few moments later, the two subject officers knocked on his door and asked him to step out of his bedroom. The incident was captured on BWC. The subject officers approached the landlord who explained that she was responsible for maintenance in the shared room complex. She unlocked the door and let the officers in. The subject officers reached the kitchen when the individual exited his bedroom and entered the kitchen. The landlord had stated that she came to clean and saw the individual in the kitchen and asked him to leave and he refused to do so. She left the kitchen and called 911 and showed the subject officers the video she took of the interaction. The investigation found that the landlord opened the front door with a key to grant the subject officers access to the common area of the home, demonstrating that she had common authority over the home and its common areas and was thus authorized to grant the subject officers' entry into the common area of the kitchen. The Board closed the Abuse of Authority allegations as being Within NYPD Guidelines.

#### 5. Officer Unidentified

An individual who was on probation was living with his father. The terms of the probation included scheduled home visits. On the incident date, there was a knock at the door and when they opened it, four officers were at the door. They announced that they were from the probation board and two of the officers proceeded to enter the home and search it. The individual recognized one of the officers who remained outside the home from a previous incident. The investigation identified that officer who stated that he and his partner routinely accompany probation officers on home visits and never enter the home unless requested by the probation officers. The investigation could not identify the probation officers who entered the home as the Department of Probation did not have a record of a home visit for the incident date. Without additional pertinent information, the investigation could not identify the subject officers. The Board closed the Abuse of Authority allegations as Officer Unidentified.

Figure 23: Disposition Counts of Full Investigations (May 2024)





Figure 24: Disposition Counts of Full Investigations (YTD 2024)

## **Dispositions - Untruthful Statement Allegations**

Following the 2019 passage of Ballot Question #2 and the subsequent City Charter Revision, CCRB's jurisdiction was expanded to include untruthful material statements made by police officers. As a result, CCRB added a new "Untruthful Statement" category of allegations.

There are four specific allegations in the new "Untruthful Statement" category: 1) False official statement, 2) Misleading official statement, 3) Inaccurate official statement and 4) Impeding an investigation.

# **Dispositions - Bias-Based Policing Allegations**

The Racial Profiling and Bias Based Policing ("RPBP") Unit is a unit at the CCRB focused on investigating civilian complaints of profiling/biased policing by uniformed (not civilian) members of the NYPD based on 10 different protected categories: race, national origin/ethnicity, color, religion, age, immigration or citizenship status, gender/gender identity, sexual orientation, disability, and housing status.

Figure 33: Percentage of Cases Substantiated (January 2023 - May 2024)





Figure 34: Disposition of Substantiated Complaints\* (2024)

Figure 35: Substantiation Rates for Full Investigations without Video (Jan 2023 - May 2024) (% substantiated shown)





Figure 36: Substantiation Rates for Full Investigations with Video (Jan 2023 - May 2024) (% substantiated shown)



## **Board Discipline Recommendations for Substantiated Officers**

After a CCRB investigative team has completed its investigation, a panel of Board members determines whether to substantiate the allegation(s) and make a disciplinary recommendation against the officer(s).

- "Charges and Specifications" are the most severe form of discipline. A decision to assign
  Charges commences a process that may result in an administrative trial in the NYPD Trial
  Room. An officer may lose vacation days, be suspended, or be terminated if the officer is
  found guilty.
- "Command Discipline B" and "Command Discipline A" are recommended for misconduct that is moderately serious. An officer can lose up to ten vacation days as a result of Command Discipline B and up to five vacation days as a result of Command Discipline A.
- "Formalized Training" are the least severe discipline, often recommended for officers who misunderstand a policy. This determination results in training at the Police Academy or NYPD Legal Bureau (Formalized Training).
- When the Board has recommended Formalized Training or Command Discipline, the case is sent to the NYPD Commissioner to impose training and/or other penalties. Cases where the Board recommends charges are prosecuted by the CCRB's Administrative Prosecution Unit.

The APU is also able to offer pleas to officers who admit guilt rather than going to trial. Following a plea agreement or the conclusion of a disciplinary trial, cases are sent to the Police Commissioner for final penalties.
